Note A – Description of the Plan

The following description of the Lionrock Behavioral Health, Inc. 401(k) Plan (“the Plan”) provides only general information. Interested persons should refer to the Plan agreement or the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2018. The Plan is a participant-directed defined contribution plan established by Lionrock Behavioral Health, Inc. (“the Company”) under the provision of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company who have completed one month of service, as defined, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan has been amended since inception to comply with tax law changes and make other changes to the Plan’s design.

Plan Administration

The Company has delegated certain responsibilities for the operation and administration of the Plan to Reliance Trust Company, as the Plan custodian and trustee. In addition, certain administrative and recordkeeping services were provided by ADP Retirement Services.

Participation

Employees, other than excluded employees, may participate in the Plan on the first day of the month following the first month after their date of hire.

Employee Deferrals and Company Matching Contributions

Eligible participants may elect to contribute up to 90%, but not to exceed statutory limits, of their compensation to the plan through payroll deductions. The Plan permits participants to make certain tax-free transfers (rollovers) of lump sum distributions received from other tax-qualified plans subject to code regulations. Eligible employee contributions are fully vested when contributed.

The Company may make discretionary matching and profit sharing contributions as determined by the Board of Directors on a year-to-year basis. The Company made no discretionary profit sharing contributions for the plan years ending December 2022 and 2021. The Company made matching contributions totaling \$126,518 and \$110,707 for the years ending December 31, 2022 and 2021, respectively. The employer match represents 50% of eligible participants’ contributions, up to a maximum of 4% of eligible compensation. The Plan defines eligible compensation as all compensation paid to employees reported on Form W-2. A participant’s nonforfeitable percentage of his matching contributions account equals the percentage in the following vesting schedule:

Participants direct the allocation of their contributions entirely or in percentages to any of the funds. Employee salary deferrals and the Company matching contribution are deposited directly into the appropriate fund by the Company in accordance with the participants' directives and the terms of the Plan.

The employee deferral and Company matching contributions to the Plan are intended to qualify under Section 401 and related provisions of the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, Plan earnings or losses, and rollovers from other qualified plans. Plan earnings and losses are allocated based upon each participant's account balance. Certain fees are charged to the fund investments and are offset against Plan investment income and loss as presented on the statement of changes in net assets available for benefits. Participants should refer to the prospectuses of these funds for details on the various types and amounts of investment fees charged to the Plan and their individual accounts.

Payment of Benefits

Upon a participant's termination of employment, death, or disability, the participant (or the participant's beneficiary in the event of death) may elect to receive a lump sum distribution equal to the value of his or her account, equal installment payments over a specified period of time, or direct trustee to trustee rollovers. If the participant's account balance is less than \$5,000, a lump sum distribution will be made without regard to the consent of the participant or the participant's spouse. All distributions elected by terminated participants during the Plan year have been paid by the Plan at December 31, 2022.

Hardship Withdrawals

Participants may withdraw their vested contributions in the event of hardship as defined in the plan agreement.

Notes Receivable from Participants

Participants may borrow against their vested balances for any reason. The loan provisions are structured to allow access to vested balances without incurring distribution penalties. The loan amount, length of loan repayment terms and interest rates are limited by statutory restrictions incorporated in the Internal Revenue Code and related regulations.

Notes Receivable from Participants (continued)

The Plan allows participants to borrow not less than \$500 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested balance. Such loans bear interest at the available market financing rates and must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence in which case the maximum repayment period will not be longer than the repayment period currently in effect for a home loan. The specific terms and conditions of such loans are established by the Plan administrator. Outstanding loans at December 31, 2022, carry interest rates of 5.25% – 9.00%.

Forfeitures

At December 31, 2022 and 2021, forfeited non-vested accounts totaled \$2,822 and \$1,591, respectively. These accounts are used to reduce employer contributions and pay administrative expenses of the Plan. During the year ended December 31, 2022 employer contributions were reduced by \$8,949 from forfeited non-vested accounts.

Note B – Summary of Significant Accounting Policies

Basis of Accounting and Accounting Period

The accounting records of the Plan are maintained on the accrual basis. The Plan has adopted a calendar year.

Investment Valuation and Income Recognition

The Plan's registered investment companies (mutual funds) and common/collective trust account investments are stated at fair value. The shares of mutual funds are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end. Common/collective trust accounts are valued at fair value using the market valuation approach.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains on investments bought or sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Fair Value Measurements

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*. Refer to Note D for the fair value measurement disclosures associated with the Plan’s investments.

Note C – Information Certified by the Plan’s Custodian

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by the custodian, except for comparing such information certified by the custodian to information included in the Plan’s financial statements and supplemental schedule of assets held for investment purposes.

Note D – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Certification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Common stocks, corporate bonds and U.S. government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the net asset value ("NAV") of shares held by the plan at year end. It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares held.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note E – Income Tax Status

The Plan uses a prototype plan document sponsored by ADP, LLC. ADP, LLC obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service (“IRS”) stated that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from IRS. However, the Plan’s management believes that the Plan is currently designed and being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

Note F – Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments in mutual funds are managed by Reliance Trust Company, the custodian and third party administrator of the Plan. Any purchases and sales of these funds are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Substantially all of the legal, accounting and administrative expenses of the Plan are paid by the Company.

Note G – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and participant accounts will be distributed in accordance with the Plan document and ERISA.

Note H – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note I – Subsequent Events

The Plan has evaluated subsequent events through September 22, 2023, which is the date the financial statements were available to be issued.
