INDEPENDENT AUDITOR'S REPORT

To the Board Trustees of the
UE Staff Employees' Pension Plan

Opinion

We have audited the financial statements of UE Staff Employees' Pension Plan ("Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2022, and the related statements of changes in net assets available for benefits for the year then ended, and the related notes to financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, information regarding the plan's net assets available for benefits as of December 31, 2022 and the changes in its net assets available for benefits for the year then ended, in accordance with U.S. generally accepted accounting principles ("GAAP").

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Plan Termination

As discussed in Note 5, the PBGC and the trustees of the executed an agreement whereby the Plan was terminated effective September 1, 2019 and naming the PBGC trustee of the Plan. During 2022, all remaining Plan assets were transferred to the PBGC. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022 AND 2021

NOTE 1. DESCRIPTION OF PLAN

The following description of the United Electrical, Radio & Machine Workers of America ("Union") UE Staff Employees' Pension Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was a defined benefit pension plan providing retirement, disability, and death benefits covering substantially all employees of the Union, as defined. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by the Trustees of the Plan which is a committee of Union and local board members and members at large. The Trustees had overall responsibility for the operation and administration of the Plan. The Trustees determined the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Union's Board of Directors.

On June 28, 2019, the plan sponsor adopted an amendment to freeze the Plan effective September 1, 2019. As a result, all benefit accruals earned by Participants under the Plan were ceased as of this date and no current or future employee of the Union who is not a participant on September 1, 2019 will be eligible to begin participating in the Plan.

As discussed in Note 5, the PBGC and the trustees of the executed an agreement whereby the Plan was terminated effective September 1, 2019 and naming the PBGC trustee of the Plan. The Plan paid benefits thru November 2022 and transferred all remaining assets to the PBGC by year end.

Pension Benefits - All employees on the payroll as of August 31, 2019 have had their benefit levels and years of service credited and "locked in" upon accruing five (5) years of service with the Union. Such employees with five (5) or more years of service were entitled to annual pension benefits, beginning at the normal retirement age of sixty (60), equal to 50% of annual salary as defined, preceding the Plan frozen date, reduced by an amount for each half- year that the credited service is less than twenty-five (25) years. The Plan permits early retirement at age fifty-five (55). Employees could elect to receive their pension benefits in the form of a joint and survivor annuity, a whole life annuity, or a ten-year certain and life annuity if they are sixty (60) years of age or older with ten years of service.

NOTE 1. DESCRIPTION OF PLAN (continued)

Death and Disability Benefits - Upon the death of an active vested employee, his or her spouse was eligible to receive a surviving spouse benefit. The unreduced benefit value was determined as if the deceased employee had retired on the date of his/her death. The actual monthly benefit: (a) depended upon when the surviving spouse elected to have the benefit begin and is subject to all provisions of the Plan in effect at the time of the vested employee's death, (b) was payable to the surviving spouse for the rest of his/her life, (c) was not transferable to another beneficiary and ended with the death of the surviving spouse.

Basis of Presentation - The financial statements of the Plan are prepared on the accrual basis of accounting and are prepared in conformity with U.S. generally accepted accounting principles ("GAAP") as promulgated by the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC").

NOTE 2. SUMMARY OF ACCOUNTING POLICIES

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reported period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and trustees of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits - Benefit payments are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Union. Expenses that are paid by the Union are excluded from these financial statements.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The availability of observable inputs can vary from security to security and is affected by a wide variety of factors, including, for example, the type of security, the liquidity of markets, and other characteristics particular to the security. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised in determining fair value is greatest for instruments categorized in Level 3.

The inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy within which the fair value measurement falls in its entirety is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

NOTE 3. FAIR VALUE MEASUREMENTS (continued)

Management is responsible for the Plan's fair value valuation policies, processes, and procedures. These control processes are designed to assure that the values used for financial reporting are based on observable inputs wherever possible. In the event that observable inputs are not available, the control processes are designed to assure that the valuation approach utilized is appropriate and consistently applied and that the assumptions are reasonable.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded.

Exchange Traded Funds: Investments in exchange traded funds are valued using a market approach based on the quoted market prices, where available, or broker-dealer quotes of identical or comparable instruments.

Common Stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments were managed by PNC Institutional Asset Management, the custodian of the Plan, and therefore, these transactions qualify as party-in-interest transactions.

NOTE 5. PLAN TERMINATION

In June 2022, the PBGC and the trustees of the Plan have entered into an agreement to terminate the Plan and appoint the PBGC as the trustee of the Plan. As trustee of the Plan, the PBGC will have all of the rights and powers of a trustee specified in ERISA or otherwise granted by law.

In August 2023, the PBGC and the trustees of the Plan executed a final settlement agreement that terminated the Plan retroactively to September 1, 2019. Pursuant to the agreement, the Union (Plan Sponsor) will pay \$1,450,000 to the PBGC over a ten year period. Upon completion of all payments, the UE will be released from any and all Plan liabilities.

Accordingly, the Plan provided the PBGC all personnel records, retiree files, plan documents, actuarial reports and all other relevant data files for pension validation. The PBGC notified all Plan participants of the trusteeship.

The Plan paid benefits thru November 2022 and transferred all remaining assets to the PBGC by year end. During 2022, the Plan transferred a total of \$12,108,180 in cash and securities to the PBGC.

NOTE 6. ADMINISTRATIVE EXPENSES

Plan administrative expenses consisted of service and asset charges of approximately \$47,415 and \$67,000 in 2022 and 2021, respectively. Remaining operating and administrative expenses were paid by the Union.

NOTE 7. TAX STATUS

The Internal Revenue Service has determined and informed the Union by a letter dated November 29, 2000 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable sections of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

NOTE 8. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.

In August 2023, the Plan and the PBGC entered into a settlement agreement terminating the Plan effective September 1, 2019 (see Note 5).


