Opinion

We have audited the accompanying financial statements of Freeborn & Peters Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA) which comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31 2022 and 2021, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

A. DESCRIPTION OF PLAN

The following description of the Freeborn & Peters Retirement Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering eligible employees of Freeborn & Peters, LLP (the Firm). Employees are eligible to participate in before-tax contributions or after-tax (Roth) contributions after completing an hour of service and attaining age 21. After attaining age 21 and completing 1,000 hours of service, only those employees with job classifications of "equity partner" or those other than "licensed attorney" are eligible to participate in discretionary profit-sharing contributions made by the Firm. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of eligible earnings to the Plan through regular payroll deductions, as defined in the Plan. Participant contributions are limited to an amount determined by the federal government each year; for 2022, the limit is \$19,500. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, up to \$6,500 for 2022. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover).

The Firm may make discretionary profit-sharing contributions. The Firm's contribution is allocated to participants as a percentage of each participant's eligible earnings, based on employment classification, as defined in the plan document. The Firm accrued discretionary profit-sharing contributions of \$1,298,466 and \$1,534,655 for the years ended December 31, 2022 and 2021, respectively.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Firm's discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants must direct their salary deferral contributions and Firm contributions, if applicable, into a variety of selected investment options as made available and determined by the Plan Trustees. Participants may change their investment options at any time during the year.

After the vested portion of a participant's account has reached \$25,000, the participant may elect to invest the funds in a self-directed brokerage account in permissible investments. The amount of the initial self-directed investment is limited to 50% of the participant's vested balance on the date that the self-directed brokerage account is opened. This limitation is waived if the vested portion of the participant's account invested in investment options designated by the Trustees equals or exceeds \$100,000.

Notes Receivable from Participants

Participants may borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at the prime rate plus 1% and ranged from 4.25% to 6.50%. Principal and interest are paid ratably through biweekly payroll deductions. As of December 31, 2022 and 2021, the balance of notes receivable from participants was \$463,552 and \$439,552, respectively. Related interest income totaled \$22,838 for the year ended December 31, 2022.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Firm's profit-sharing contributions becomes 20% vested after two years of service and continues to vest at the rate of 20% for each successive year until 100% vested after six years of service.

Upon death, disability, or attaining age 65 while employed by the Firm, participants will be 100% vested in the Firm's profit-sharing contributions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Hardship distributions, as well as in-service distributions for participants who have attained age 59-1/2, are also available as described in the Plan.

Forfeited Accounts

As of December 31, 2022 and 2021, unallocated plan assets resulting from forfeited nonvested accounts totaled \$4,486 and \$7,890, respectively. These accounts will be used to reduce future discretionary Firm contributions. In 2021, \$7,890 of forfeitures were used to reduce the discretionary Firm contributions.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold or redeemed, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments. Administrative expenses of self-directed accounts are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued. No such matters were identified.

C. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022 and 2021.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed brokerage accounts: Accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices. Life insurance contracts are valued at estimated cash surrender value, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In estimating fair value of the investments in Level 3, the Trustees may use third-party pricing sources or appraisers. In substantiating the reasonableness of the pricing data provided by third parties, the Trustees evaluate a variety of factors including review of methods and assumptions used by external sources, recently executed transactions, economic conditions, industry and market developments, and overall credit ratings.

D. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

The Plan participates in a revenue sharing agreement with Alliance Pension Consultants, LLC (Alliance), the Plan's third-party administrator. These transactions qualify as party-in-interest transactions. The Plan paid \$28,085 for Alliance's share of revenue per the agreement.

E. PLAN TERMINATION

The Firm merged with another firm during 2022. The Plan was terminated in 2023. Participants were notified of the termination and became 100% vested in their employer contributions as of the date the Plan terminated. Final completion of the Plan's termination is dependent upon the distribution of all assets of the Plan. The Plan will continue to file an annual Form 5500 until all plan assets have been distributed.

F. TAX STATUS

Effective January 1, 2022, the Plan was amended and restated. The IRS has determined and informed the Firm by a letter dated September 6, 2011, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC.). This Cycle 3 restatement of the Plan was to bring it into compliance with legislative and regulatory requirements.

The provisions of the Plan do not vary from the prototype plan. Accordingly, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believe that the Plan is qualified and the related trust is tax exempt.

G. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. CONCENTRATION OF CREDIT RISK

The Plan maintains a portion of its cash balances at a financial institution located in the United States of America. These cash balance is guaranteed by the Federal Deposit Insurance Corporation (FDIC) up to certain limits. The Plan, may, from time to time, have a balance in excess of FDIC insured deposit limits.


