Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Aspiranet Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (liquidation basis) as of December 5, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits (liquidation basis) for the period from January 1, 2022 through December 5, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Aspiranet Profit Sharing Plan as of December 5, 2022 and December 31, 2021, and the changes in its net assets available for benefits for the period from January 1, 2022 through December 5, 2022, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Aspiranet Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the Retirement Committee of Aspiranet Profit Sharing Plan approved a plan of liquidation on December 31, 2021. As a result, Aspiranet Profit Sharing Plan changed its basis of accounting to the liquidation basis of accounting used in presenting the 2022 and 2021 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Aspiranet Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Aspiranet Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

Effective December 31, 2021, the Board of Directors of Aspiranet, the Plan sponsor, approved the termination of the Plan. As a result of the termination, Plan participants immediately became 100% vested. Participant balances were distributed directly to participants, to participant IRA accounts or to the participant's current employer's plan, the Aspiranet 403(b) Plan. All balances were distributed as of December 5, 2022.

General – The Plan was a profit sharing plan covering substantially all employees of Aspiranet (the Company), and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company was the Plan's sponsor and served as plan administrator.

The Plan and a master trust (the Master Trust) were established effective January 1, 2010, to hold the investment of assets of both the Plan and Aspiranet 403(b) Plan. In context of retirement plans, a master trust is a trust that invests together some or all of the assets of the "participating plans." The assets are commingled for investment purposes only at the direction of the participants and are commingled to pay Plan benefits.

Administration – The Company had appointed the Retirement Committee (the Committee), to manage the operation and administration of the Plan and Master Trust. The Committee designated Matrix Trust Company (Matrix Trust or Trustee) to serve as the trustee. Fees charged by the Trustee were paid by the Plan and the Company paid all other costs of administering the Plan.

Eligibility – Prior to December 31, 2021, employees of the Company were eligible to participate in the Plan upon reaching age 21 and after completing one year of service in which at least 1,000 hours are worked. To receive any employer paid contribution, participants must have been employed as of the last day of the Plan year quarter to receive employer paid contributions for that period.

Contributions

Participant contributions – Prior to December 31, 2021, participants were able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer profit sharing contributions – Prior to December 31, 2021, the Company may have elected to make discretionary profit sharing contributions to the Plan set by the Board of Directors of the Company. There were no profit sharing contributions for the period ended December 5, 2022.

Contributions were subject to regulatory limitations.

Participant accounts – Each participant's account was credited with allocations of the Company's profit sharing contributions and plan earnings and forfeitures. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account. Participants directed the investment of their allocated contributions into various investment options offered by the Plan.

Aspiranet Profit Sharing Plan Notes to Financial Statements

Vesting – Prior to the termination of the Plan, vesting in the Company's contribution was based on years of continuous service. A participant was 100% vested after two years of credited service. As a result of the termination, Plan participants immediately became 100% vested.

Notes receivable from participants – Prior to December 31, 2021, participants were able borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 15 years. Under the terms of the Plan Agreement, Plan loans will bear a reasonable rate of interest determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Upon termination of the Plan active loans were rolled over to the Aspiranet 403(b) Plan if directed by the participant.

Payment of benefits – Prior to December 31, 2021, on termination of service a participant may have elected to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan processed involuntary cash-out distributions for terminated employees with balances less than \$5,000.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures were retained in the Plan, are to be used for the Plan year in which the forfeiture occurs and were used to reduce future Company contributions. As of December 5, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$269, respectively. During the period ended December 5, 2022, the \$269 forfeiture balance was used to reduce the Company's contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting. As a result of the termination, the Plan presented these financial statements using the liquidation basis of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Master Trust income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments. These amounts are presented in the statement of changes in net assets available for benefits combined under the Plan's interest in Master Trust net loss.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses had been recorded as of December 31, 2021.

Payment of benefits – Benefits were recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation in fair value of investments.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 13, 2023, which is the date the financial statements were available to be issued.

NOTE 3 – INTEREST IN MASTER TRUST

Prior to December 31, 2021, the Master Trust held investments of assets of the Plan and the Aspiranet 403(b) Plan. Each participating benefit plan had a divided interest in the Master Trust. The assets of the Master Trust are held by Matrix. Net earnings or losses of the individual investment funds were allocated among the participants in the proportion that each participant's account balance bears to the aggregate balances of all participants' accounts invested in each investment fund.

NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Notes to Financial Statements

Following is a description of the valuation techniques used for assets measured at fair value. There had been no changes in the techniques used at December 5, 2022 and December 31, 2021.

Mutual funds – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.


