Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the financial statements of Catapult Systems, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements (2022 Financial Statements).

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Catapult Systems, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. Effective February 18, 2022, the Plan was amended and restated to incorporate legislative regulatory changes and adopt a new non-standardized pre-approved plan document. There were no changes to Plan provisions as a result of this amendment and restatement.

General

The Plan is a defined contribution plan originally established January 1, 1996 for all employees of Catapult Systems, LLC (the “Company”). Employees are eligible to participate in the Plan beginning the first of the month coinciding with or next following the completion of one day of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger

Quisitive Ltd. acquired Catapult Systems, LLC in 2021. Effective December 31, 2022, Quisitive, LLC 401(k) Plan merged with and into the Plan. Quisitive, LLC is an affiliate of Quisitive Ltd. The Quisitive, LLC 401(k) Plan net assets were transferred effective December 31, 2022, but were not received into the accounts of the Plan until February 2023; therefore, total net assets transferred in the amount of \$11,582,116 are included as a receivable in the statements of net assets available for benefits at December 31, 2022.

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan of up to 100% of their eligible compensation, subject to certain limitations prescribed by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from qualified retirement plans, including Roth amounts.

The Company will make a nondiscretionary matching contribution equal to 25% of the first 3% of eligible compensation deferred by the participant on a quarterly basis.

The Company may also make a discretionary matching contribution for the plan year. Eligible participants must be an active participant on the last day of the plan year. The Company did not make a discretionary matching contribution for the year ended December 31, 2022.

The Plan is participant directed and participants may change their contribution rates on a monthly basis and investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest 20% after two years of service, 40% after three years of service, 70% after four years of service, and are 100% vested after five years of service. An employee that has at least 1,000 hours of service in a plan year is credited with one year of service. Vesting in Plan contributions from merged plans are subject to service requirements detailed in the Plan document. A participant shall be immediately vested upon death, retirement, or termination of employment due to total and permanent disability.

Payment of Benefits

Normal retirement age under the Plan is 65. Upon a participant's termination, retirement, death, or disability, the vested funds in the participant's account are available to be distributed in a lump-sum payment. Participants who terminate with an account balance of \$5,000 or less will be cashed out of the Plan as soon as administratively feasible. The Plan also allows in-service withdrawals at age 59½ and hardship withdrawals, subject to certain Plan provisions.

Forfeitures

Forfeitures of nonvested employer contributions are used to pay administrative expenses of the Plan or reduce employer contributions. The forfeitures balance at December 31, 2022 and 2021 was \$13,139 and \$12,296, respectively. During the year ended December 31, 2022, forfeitures totaling \$25,937 were used to reduce employer contributions. No forfeitures were used to pay administrative expenses of the Plan in 2022.

Notes Receivable from Participants

Plan participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan. Loans are repaid in level installments through payroll deductions for periods ranging up to five years, or longer if for the purchase of a primary residence. The loans bear interest at reasonable rates as determined at the date of the loan and are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest. Participants may only have one loan outstanding at any time.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested and entitled to benefits based on their account balance accumulated to the date of termination of the Plan.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to withdrawals, notes receivable from participants, plan administration, and investment advisory are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net depreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Investments measured using the NAV as a practical expedient are described below:

Pooled Separate Accounts: Valued using NAV as a practical expedient to determine fair value as reported by Principal Life Insurance Company (Principal) based on the value of the underlying investments, which primarily consist of domestic stocks, bonds or fixed income securities, and mutual funds. The Plan has no unfunded commitments or contractual obligations to further invest in these accounts and there are no restrictions on redemption of these accounts.

Collective Investment Trust Fund: Valued using NAV as a practical expedient to determine fair value based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is determined by Principal Global Investors Trust Company (PGITC). The Plan has no unfunded commitments or contractual obligations to further invest in these funds and there are no restrictions on redemption of these funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, an insurance company, Principal Trust Company, trustee, and Principal on behalf of PGITC, trustee of the collective investment trust fund, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2022 and 2021, and the schedule H, line 4i - schedule of assets (held at end of year), excluding participant loans, as of December 31, 2022, and the related investment loss reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2022.

NOTE 5 - TAX STATUS

The Plan has adopted a non-standardized pre-approved plan, which obtained its latest opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Plan investments are in pooled separate accounts and a collective investment trust fund managed by Principal and PGITC, respectively, which qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

Effective January 1, 2023, the Plan name changed to Quisitive, LLC 401(k) Plan and the plan sponsor changed to Quisitive, LLC.

Management has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.
