## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Encompass Supply Chain Solutions, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 30, 2022 (Date of Merger) and 2021, and the related statement of changes in net assets available for benefits for the period ended December 30, 2022 (Date of Merger), and the related notes to the financial statements.

Management has obtained certifications from qualified institutions as of December 30, 2022 (Date of Merger) and December 31, 2021, and for the period ended December 30, 2022 (Date of Merger), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

## **Basis for Opinion**

As a result, all of the Plan's assets were transferred out on December 30, 2022 (Date of Merger). Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Encompass Supply Chain Solutions, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## Encompass Supply Chain Solutions, Inc. 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF PLAN**

The following is a description of the Encompass Supply Chain Solutions, Inc. 401(k) Plan (the Plan) prior to the Plan merger and provides only general information. Refer to Plan Document for a more complete description of the Plan provisions.

#### ***General***

The Plan is a single employer defined contribution retirement plan established effective January 1, 2009, for Encompass Supply Chain Solutions, Inc. (the Employer, the Company, the Plan Administrator and the Plan Sponsor). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Reliance Trust Company, Inc., the trustee and the qualified institution for the Plan, which invests contributions and Plan earnings, and makes investment transactions as directed by management. ADP Retirement Services acts as the third-party administrator for the Plan, which performs certain recordkeeping services, certain plan administration services, and annual ERISA compliance testing. Prior to February 1, 2022, Plan assets were held and managed by Matrix Trust Company, Inc., and EPlan Services, Inc. acted as the recordkeeper.

The Plan's initial effective date was January 1, 2009, and restated in November 2014. The Plan adopted the Paychex EPlan Defined Contribution Volume Submitter Plan and Trust as its Plan Document, and engaged Paychex as its third-party administrator and Matrix Trust Company as its trustee. Effective February 1, 2022, the Plan was amended and adopted the Automatic Data Processing (ADP) Defined Contribution Prototype Non-Standardized 401(k) Profit Sharing Plan as its plan document, and engaged ADP as its third-party administrator and Reliance Trust Company as its trustee.

During 2022, the Plan Sponsor was acquired by Parts Town. As a result of its sale, Plan assets and participant accounts totaling \$8,755,088 were transferred out of the Plan to PT Holdings, LLC 401(k) Plan on December 30, 2022 (Date of Merger).

The following is a description of the Plan prior to the Plan merger with PT Holdings, LLC 401(k) Plan:

#### ***Eligibility***

An employee is eligible once two months of entry service has been completed and attained the age of 21. Each employee is eligible to make contributions to the Plan on the first day of the month on or after they have met the eligibility requirements. Each employee is eligible to receive matching contributions when they enter the Plan.

## Encompass Supply Chain Solutions, Inc. 401(k) Plan Notes to Financial Statements

### **Note 1: DESCRIPTION OF PLAN (Continued)**

#### ***Contributions***

Participants are allowed to contribute up to 50% of their annual compensation as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Employer matches a percentage of the participant's pre-tax contributions. The Plan provides for a safe harbor matching contribution of 100% of each participant's contribution not exceeding 3% of the participant's compensation, plus 50% of each participant's contribution in excess of 3% but not to exceed 5% of the participant's compensation.

The Employer may also make a discretionary profit sharing contribution to the Plan. There were no profit sharing contributions for the period ended December 30, 2022 (Date of Merger).

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Company's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in their own contributions, qualified matching contributions, rollover contributions, plus earnings thereon. Participants become 100% vested in the Employer's profit sharing contributions and earnings when the participants reach normal retirement age. Prior to normal retirement age, the participants become vested in profit sharing contributions and earnings based on a 5 year vesting schedule. Participants are 20% vested after one year of service and vesting increases 20% for each additional year of service until fully vested after five years of service.

#### ***Notes Receivable from Participants***

A participant may borrow up to the lesser of \$50,000 or 50% of the vested portions of his/her account balance, repayable over a reasonable period of time not to exceed five years and bearing interest at 1% over the prime rate in effect at the beginning of the month in which the loan is approved. Principal and interest is paid ratably through payroll deductions.

#### ***Benefit Payments***

The participant's vested portion of his/her account balance will be available for distribution in the event of retirement, death, disability, termination of employment, or financial hardship subject to the Plan's provisions.

While employed, a participant may withdraw rollover contributions at any time. Also while employed, a participant who either reaches age 59½ or is considered totally disabled may withdraw all or part of his/her account balance.

#### ***Forfeitures***

At December 30, 2022 (Date of Merger) and 2021, forfeited nonvested accounts totaled \$0. In 2022, no forfeited balances were applied towards employer contributions.

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC), and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements, contract value, and NAV.

Management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 30, 2022 (Date of Merger) or December 31, 2021.

## Encompass Supply Chain Solutions, Inc. 401(k) Plan Notes to Financial Statements

### Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

#### *Payment of Benefits*

Distributions to participants are recorded when paid.

#### *Administrative Expenses*

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer. During the period ended December 30, 2022 (Date of Merger), expenses of \$30,947, were paid by the Plan and allocated to participant accounts.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, October 16, 2023, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### Note 3: INFORMATION CERTIFIED BY QUALIFIED INSTITUTIONS

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified as complete and accurate by the qualified institutions:

- a) Total investments included in the statements of net assets available for benefits at December 30, 2022 (Date of Merger) and 2021.
- b) Investment income and net depreciation in value of investments information included in the statement of changes in net assets available for benefits for the period ended December 30, 2022 (Date of Merger).
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) Total notes receivable from participants included in the statements of net assets available for benefits at December 30, 2022 (Date of Merger) and 2021.
- e) Interest income on notes receivable from participants' information included in the statement of changes in net assets available for benefits for the period ended December 30, 2022 (Date of Merger).

### Note 4: FAIR VALUE MEASUREMENTS

Prior to the Plan merger, fair value measurements were as follows:

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Below is a description of the valuation methodologies used for assets measured at net asset value. There have been no changes in the methodologies at December 30, 2022 (Date of Merger) and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money Market Fund:* Valued at cost plus earnings, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5: TAX STATUS**

The IRS has determined by an opinion letter dated October 6, 2020, that the volume submitter plan is designed in accordance with applicable sections of the IRC. Although the volume submitter plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain expenses of the Plan, including legal and accounting fees, are paid by the Employer. In addition, certain services to the Plan, by the Employer, were performed at no charge.

### **Note 7: PLAN TERMINATION**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On December 30, 2022 (Date of Merger), the Plan was merged into the PT Holdings, LLC 401(k) Plan and all plan assets and participant accounts were transferred out.

### **Note 8: PLAN COMPLIANCE**

In prior years, the Company determined that certain participant contributions had not been remitted to the Plan in a timely manner, according to Department of Labor regulations. Although these remittances were made, they fell outside the normal processing time the Company allows. Lost earnings on these delinquent deposits are in the process of being calculated and remitted into the Plan.
