Opinion

We have audited the accompanying financial statements of Hostmark Health Care Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

A. DESCRIPTION OF PLAN:

The following description of the Hostmark Health Care Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

1. *General.* The Plan was established to provide placement of medical, prescription drug, dental, life, and non-occupational disability insurance coverage for the participating employees of the participating entities, which include the hotels that are managed by Hostmark – S. Raintree Enterprises, Inc. (the Company) and the corporate office of the Company. The related trust was established on May 1, 1990.

The Plan purchases individual stop-loss protection for claims exceeding \$100,000.

The Company has been delegated the responsibility of administering the financial activities of the Plan, which is intended to be a “cafeteria plan” meeting the requirements of Section 125 of the Internal Revenue Code of 1986. The Trust is also intended to be qualified within the meaning of Section 514 of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan’s benefit coverage begins January 1 and ends December 31.

2. *Major Medical Coverage.*

The Plan provides options for participants as follows:

Bronze PPO Plan – a component plan of the wholly self-insured health plan where individual participants may receive all of their care through a network of participating providers, hospitals, specialists and prescription drugs. In addition, after deductibles, there are out-of-network benefits attached to this component plan and referrals are not required.

POS Plan – a component plan of the wholly self-insured health plan where individual participants may receive all of their care through a network of participating providers, hospitals, specialists and prescription drugs. There are no out-of-network benefits attached to this component plan and referrals are not required with the exception of prescription drugs, of which may receive some benefits.

3. *Other Insurance and Benefits.* The Plan provides vision, dental, life, disability, accidental death and dismemberment for all participants through conventional insurance policies with outside insurance carriers (VSP, Assurant and Unum).

A. DESCRIPTION OF PLAN (CONTINUED):

4. *Eligibility and Participation.* Each employee may participate in the Plan after 60 days of continuous employment with the Company. Terminated employees are entitled to similar health benefits if enrolled under the Consolidated Omnibus Budget Reconciliation Act (COBRA).
5. *Other.* The Plan's board of trustees, as the plan sponsor, has the right under the Plan to modify the benefits provided to active employees. The Plan may be terminated only by joint agreement between the employer and participants, subject to the provisions set forth in ERISA.
6. *Current Legislation.* Several acts were signed into law in 2021 and 2020 including the Families First Coronavirus Response Act, the Consolidated Appropriations Act, and the American Rescue Plan Act. None of these Acts had a material impact on the Plan and to the extent applicable, the Plan is fully compliant with the Acts.

B. SUMMARY OF ACCOUNTING POLICIES:

1. *Basis of accounting.* The financial statements of the Plan are prepared under the accrual method of accounting.
2. *Use of estimates.* The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported (IBNR), claims payable, and disclosure of contingencies. Actual results could differ from those estimates. Significant estimates include evaluating collectability of receivables and calculation of claims incurred but not reported.
3. *Cash and Cash Equivalents.* The Company considers cash in operating bank accounts with a maturity of three months or less as cash and cash equivalents.
4. *Allowance for Doubtful Accounts.* The Company considers the allowance for doubtful accounts based upon a formula applied to aged accounts, in addition to an assessment of each hotel's and corporate office's financial condition.
5. *Benefits paid.* Health claims and premiums are reported when paid. Any refunds due to overpayments, subrogation, stop loss revenue or adjustments are recorded in the period received and are shown netted with benefits paid.
6. *Concentration of cash on deposit and uninsured cash balances.* Financial instruments that potentially subject the Company to concentrations of credit risk consist principally of cash deposits. Accounts of each institution are insured by the Federal Deposit Insurance Corporation (FDIC) up to certain limit. At December 31, 2022, the Company had no amount in excess of FDIC insured limits.

B. SUMMARY OF ACCOUNTING POLICIES (CONTINUED):

7. *Benefit Obligations.* Plan obligations at December 31, 2022 and 2021 included unpaid health claims incurred by active participants both reported and not reported to Blue Cross Blue Shield at that date. Unpaid health claims incurred by active participants but not reported at that date were estimated by the Company in accordance with accepted actuarial principals, which were estimated by using a “claims development” or “lag” method. Both amounts are reported in the statements of plan benefit obligations and the statements of changes in plan benefit obligations. At December 31, 2022 and 2021, total benefit obligations amounted to \$60,780 and \$151,859, respectively.

C. FUNDING POLICY:

Each participating entity shall make all necessary contributions to meet the funding requirements, as determined by the Plan’s Board of Trustees. The Company contributes funds to the Plan to provide for benefit payments and to replenish funds held in the Plan. These funds are accumulated through employee payroll deductions, as well as from contributions made by the participating entities and certain terminated employees electing to remain in the Plan. Participant contributions for the various insurance plans are determined based upon the coverage chosen by the participant, the level and number of dependents being covered, as well as the plan in which they choose to enroll.

D. RECEIVABLE, NET:

At December 31, 2022 and 2021, the Plan had receivables, which included balances due from participating entities, totaling approximately \$1,737,000 and \$1,287,000, respectively. At December 31, 2022 and 2021, the Plan had recorded a reserve for losses against these receivables totaling \$1,073,302 and \$1,233,394, respectively.

E. TAX STATUS:

The Internal Revenue Service has determined and informed the Company that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the code. The Plan has been amended since receiving the determination letter. However, the Company believes that the Plan is currently designed and being operated in compliance within the applicable requirements of the code. Therefore, the Company believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the applicable tax authority. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

E. TAX STATUS (CONTINUED):

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

F. RISKS AND UNCERTAINTIES:

Various assumptions are used for the valuation of benefit obligations. Due to the level of risk associated with investments and the valuation of benefit obligations, it is at least reasonably possible that changes in the values of investments and the valuation of benefit obligations will occur in the near term and that such changes could materially affect the amounts reported in the statement of benefit obligations and net assets available for benefits.

The Plan's prepaid cash deposits are held in a noninterest-bearing cash account. The deposits are insured by the Federal Deposit Insurance Corporation ("FDIC") up to \$250,000.

Plan contributions are made and the actuarial present value of benefit obligations are reported based on certain assumptions including but not limited to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

G. RELATED-PARTY TRANSACTIONS:

The Company administers the financial activities of the Plan including paying general and administrative expenses of the Plan through the Company's corporate office. Salaries, employee benefits, and occupancy costs were allocated by the Company to the Plan.

I. PLAN TERMINATION:

Under certain conditions, the Plan may be terminated. Upon termination, the assets remaining shall be subject to the applicable provisions of the Plan in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.




