### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Modern Clinics Inc. 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Other Matters

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 - Description of the Plan

The following description of the Modern Clinics Inc. 401(K) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### a. *General*

The Plan is a defined contribution plan designed to provide benefits to all eligible employees of Modern Clinics, Inc. (the "Company"). Employees are eligible when they have been employed by the Company for at least two months. The Plan is subject to the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's effective date was December 1, 2021.

#### b. *Contributions*

Each year, an eligible employee may pay into the Plan as a salary reduction contribution up to 90% of eligible earnings to the maximum annual amount allowed by the Internal Revenue Code (\$20,500 for 2022 and \$19,500 for 2021). Individuals aged 50 or older are eligible to make additional annual catch-up contributions to a maximum of \$6,500 for the year ended December 31, 2022 and period from December 1 through December 31, 2021. Roth and rollover contributions are also permitted.

Employees who attain eligibility status will be automatically enrolled with a 2% contribution unless they elect otherwise.

#### c. *Administrative Costs*

All costs incurred to administer the Plan, except for some fees, are paid by the Company.

#### d. *Excess Contributions Payable*

The Plan has chosen the refund method to satisfy the compliance test for the year ended December 31, 2021. In accordance with the refund method, excess contributions are refundable to the participant. Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. For the Plan year ended December 31, 2021, \$8,235 of the excess contributions and attributable earnings were not refunded to the participant subsequent to the year end.

#### e. *Loans to Participants*

Participants are permitted to borrow from their account balances. Participants may only have one loan outstanding at any time. The total amount of any such loan, when added to the outstanding balance of all other loans to the participant from the Plan, shall not exceed the lesser of:

- (a) 50% of the total vested accrued benefits of the participant under the Plan as of the date of the loan; or
- (b) \$50,000 reduced by the excess (if any) of the highest outstanding balance of all loans to the participant from the Plan during the one-year period ending on the day before the loan was made over the outstanding balance of all loans to the participant from the Plan on the date on which the loan was made.

### Note 1 - Description of the Plan - Continued

#### *e. Loans to Participants - Continued*

Loans shall be repaid within five years or within a reasonable period of time if used to purchase a principal residence. Repayments shall be made in regular periodic installments through payroll deductions. The loan interest rate shall be determined by the Plan administrator. At December 31, 2022, interest rates on outstanding loans ranged from 4.5% to 8.50%. Loans are valued at their outstanding balances. There were no outstanding loans for the year ended December 31, 2021.

#### *f. Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of the employer contribution and investment earnings and charged with allocations of investment losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *g. Payment of Benefits*

Upon termination of service, participants with vested balances over \$5,000 may elect to leave their vested balance in the Plan or they may elect a lump sum payment. For vested balances of \$1,000 to \$5,000, if no other form of payment is elected, the vested balance may be rolled into an individual retirement account ("IRA"). For vested balances under \$1,000, if no other form of payment is elected, the vested balance is automatically paid as a lump sum.

### Note 2 - Summary of Significant Accounting Policies

#### *a. Basis of Accounting*

The Plan maintains its accounting records on the accrual basis.

#### *b. Investment Valuation and Income Recognition*

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *c. Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *d. Payment of Benefits*

Benefits are recorded when paid.

#### *e. Risks and Uncertainties*

The Plan provides for various investment fund options in any combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to high level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *f. Subsequent Events*

Subsequent events have been evaluated through October 13, 2023, the date the financial statements were approved and authorized for issue by the Plan administrator.

### Note 3 - Investments Certified by the Trustee

The following information regarding the Plan's investments was obtained from data that has been prepared and certified as complete and accurate by the Reliance Trust Company, the trustee of the Plan. As permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information.

### Note 4 - Fair Value Measurements

The Fair Value Measurements and Disclosures Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Topic are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

### Note 7 - Tax Status

The Plan obtained its latest determination letter on December 31, 2018, in which the Internal Revenue Service stated that the Plan, as then designed, followed the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and for the period December 1 through December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 8 - Prohibited Transactions**

During the year ended December 31, 2022, Modern Clinics failed to remit participant contributions amounting to \$10,081 to the Plan within the time period prescribed by Department of Labor regulations. The failure to remit participant contributions and loan repayments to the Plan in a timely basis represents a prohibited transaction under ERISA. All delinquent contributions and loan repayments have been contributed into the Plan.

The lost earnings on the 2022 late participant contributions will be calculated and remitted into the Plan in 2023 and the Company will file IRS form 5330 and pay all applicable penalties.

### **Note 9 - Subsequent Event:**

Effective January 1, 2023, the Plan changed its 401k plan provider to Human Interest.
