### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Proos Employees 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Note 1 - Plan Description

The following description of Proos Employees 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of Proos Manufacturing, LLC (the "Company"). All employees who have attained the age of 21 and have completed at least 30 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee 401(k) contributions through reductions of participants' salaries and wages. These contributions are subject to maximum tax-deferred limitations established by the Internal Revenue Code and are made out of pretax earnings, which are not subject to federal income tax until withdrawn, or after-tax earnings. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company matches 100 percent of participant contributions on the first 3 percent of compensation deferred and 50 percent of participant contributions, not to exceed 5 percent of compensation deferred. Participants who have completed 30 days of service will be eligible to receive Company matching contributions. Matching contributions amounted to \$152,669 in 2022.

The Company may make discretionary matching contributions and profit-sharing contributions. Participants who have attained the age of 21 and have completed 30 days of service will be eligible to receive discretionary matching contributions. Participants who have attained the age of 21 and have completed one year with 1,000 hours of service will be eligible to receive an allocation of the company's profit-sharing contribution. There were no discretionary matching contributions or profit-sharing contributions in 2022.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age. On termination of service due to death, the distribution of the account balance must be completed by December 31 of the calendar year containing the fifth anniversary of the participant's death. All other distributions are in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary, rollover, and employer matching contributions and any income or loss thereon. Participants are also fully vested if employed with the Company upon reaching age 65 or upon termination of service due to death or permanent disability.

**Note 1 - Plan Description (Continued)**

Employer discretionary matching contributions and discretionary profit-sharing contributions vest according to the following schedule:

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan.

***Termination***

While it has not expressed any intent to do so in 2022, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

During the year, the Company had a reduction in force. The Company is currently working with legal counsel to determine if a partial termination of the Plan has occurred. If a partial termination has occurred, the terminated participants would become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by John Hancock Life Insurance Company (U.S.A.); Empower Annuity Insurance Company of America; and Empower Trust Company or their affiliates. John Hancock Life Insurance Company (U.S.A.); Empower Annuity Insurance Company of America; and Empower Trust Company, LLC are the Custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Additionally, certain administrative expenses of the Plan are paid by the Company, which qualify as party-in-interest transactions.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value except as noted below.

The pooled separate accounts and common/collective trust funds are valued at net asset value per share (NAV) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 4 for additional information.

The Empower Investment Fixed Account is a guaranteed group annuity contract issued by Empower Annuity Insurance Company of America (EAICA). Principal and interest for participant-initiated benefit payments are fully guaranteed by the general account assets of EAICA. The Fixed Account is considered to be fully benefit responsive and is recorded at contract value. Contract value represents principal invested, plus interest earned, less any withdrawals.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 13, 2023, which is the date the financial statements were available to be issued.

Subsequent to year end, the Company is operating under receivership with the expectation that the business will be acquired and the acquiring company will continue the Plan. Should that expectation change, the Plan will terminate and participant balances will be liquidated.

**Note 3 - Certified Information**

During 2022, the Plan changed its custodian from John Hancock Life Insurance Company (U.S.A.) to Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively, the "Custodians"). During the periods under audit, the Custodians of the Plan held the Plan's investments and executed all related transactions. The investment balances and related investment results (income and losses) included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Note 4 - Fair Value Measurements (Continued)**

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
