Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Amro Fabricating Corporation 401(k) Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of the Amro Fabricating Corporation 401(k) Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a qualified defined contribution plan covering all eligible employees of Amro Fabricating Corporation (the “Plan Sponsor” and “Plan Administrator”) who have completed 6 months of service and have reached age 21. The Plan was established by the Plan Sponsor on January 1, 1998 to provide retirement benefits for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA).

Effective September 1, 2016, the Plan was amended and restated to adopt the Automatic Data Processing Prototype 401(k) and Profit Sharing Plan. The significant changes to the Plan included the change in Plan eligibility requirements, which now allows employees who have completed 3 months of service and have reached age 18 to participate, and the addition of the automatic enrollment whereby all newly eligible employees are automatically enrolled in the Plan with a default rate set at 3% of eligible compensation. Contributions are automatically invested in designated funds until changed by the participant. Participants should refer to the restated Plan agreement for a more complete description of the Plan’s provisions.

Effective September 1, 2018, the Plan was amended and restated to permit Roth elective deferrals under the Plan and to implement an automatic 1% increase to the pre-tax deferral rate of 3% for each year up to a maximum of 6% on each participant’s enrollment anniversary.

Effective April 28, 2023, the Plan merged into the Karman Space & Defense 401(k) Plan, a qualified plan sponsored by the Plan Sponsor’s parent company. As part of this merger, all plan assets were transferred from Amro Fabricating Corporation 401(k) Plan & Trust to Karman Space & Defense 401(k) Plan, and the custodian and recordkeeper changed from ADP to John Hancock. As a result, Amro Fabricating Corporation 401(k) Plan & Trust will be terminated and no longer exist.

Contributions

The Plan is a contributory plan whereby participants may contribute up to a maximum of 90% of pre-tax annual compensation not to exceed the dollar limit set by law of \$20,500 for 2022. Participants age 50 or older may elect to defer an additional \$6,500 of “catch up” contributions to the Plan. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan Sponsor may make discretionary matching contributions to the Plan. There were no such contributions for the year ended December 31, 2022.

The Plan Sponsor may also make discretionary non-elective contributions to the Plan in an amount determined by the Plan Sponsor, as defined in the Plan agreement. There were no such contributions for the year ended December 31, 2022.

Participant Accounts

Each participant's individual account is credited with participant contributions, the Plan Sponsor's contributions and Plan investment earnings. Participants may choose to have their account balance deposited in various investment programs. Allocation of Plan investment earnings is based on the participant's account balance, as defined.

Vesting

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the Plan Sponsor's matching and profit-sharing contributions is based on years of continuous service as follows:

Participant Notes Receivable

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed a maximum of 5 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator. However, the amortization period for a loan to a participant to acquire his or her principal residence may be extended to 30 years. Interest rates on participant loans were 5.25% to 9.00% as of December 31, 2022. Principal and interest is paid ratably through either payroll deductions or participant payments. As of December 31, 2022 and 2021, participant notes receivable was \$187,179 and \$117,175, respectively.

Investment Options

At December 31, 2022, participants may self-direct employee and employer contributions in to various investment options available for investment. The investment options include mixes of mutual funds from aggressive to conservative, international, and short-term money market funds.

Payments of Benefits

Upon termination of service due to death, disability, or retirement, a participant is entitled to receive, as benefits, an annuity or a lump sum amount equal to the value of his/her account, distributed in accordance with the Plan.

Forfeitures

Forfeitures may be used to pay any administrative expenses or reduce Plan Sponsor matching contributions. As of December 31, 2022, the Plan has no forfeitures.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting. The Plan's investments are stated at fair market value. Quoted market prices are used to value investments. Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Sponsor to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. The Plan Sponsor believes that the estimates utilized in preparing its financial statements are reasonable and prudent. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net depreciation in fair value of investments consists of realized gains and losses and the change in unrealized gains and losses in the Plan's investments. Realized gains and losses from the sale of investments are computed using the participant's cost basis in the investment aggregated at the Plan level. Net changes in unrealized appreciation/depreciation in investments represent the difference between the fair value of investments held at year-end and the cost of investments purchased in the current fiscal year or the fair value of investments held at the end of the preceding year.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on participant notes receivable is recorded when earned. Delinquent notes receivable from participants are recorded as a distribution based on the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when incurred.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as excess contributions owed to participants. As of December 31, 2022 and 2021, there was no excess contributions payable.

Payments of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Plan administrative expenses are paid by either the Plan Sponsor or the Plan, as provided in the Plan agreement. Amounts paid by the Plan for certain administrative fees was \$18,028 for the year ended December 31, 2022.

Subsequent Events

The Plan evaluated the impact of subsequent events through October 16, 2023, the date these financial statements were issued. Other than the matters disclosed in Notes 1 and 8, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. Fair Value Measurements

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan maximizes the use of observable inputs and minimizes the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the following fair value measurement.

- Level 1: quoted prices in active markets for identical assets or liabilities;
- Level 2: inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3: unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

3. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

- Registered investment companies: Investments in shares of registered investment companies are valued at quoted market prices, which represent the net asset values of shares held by the Plan at year-end (Level 1 inputs).
- Common/collective trusts: Investments are public investment securities valued using the NAV for that fund as a practical expedient to estimate fair value. The NAV is quoted on a private market that is not active; however, the unit price is based on the underlying investments. There are no imposed restrictions as to the redemption of these investments.

The method described above for common collective trusts may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different estimate of fair value at the reporting date.

7. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

The Plan may be adversely affected by health epidemics. Due to pandemics, the equity and bond markets, in which Plan assets are invested, could experience unusually high volatility and uncertainty. Although the Plan Sponsor is continuing to monitor and assess the effects of potential pandemics on the Plan and its investments, the ultimate impact of the outbreak or a similar health epidemic is highly uncertain and subject to change.

8. Plan Termination

As noted in Note 1, the Plan will be terminated and no longer exist as a result of the plan merger into a qualified plan sponsored by the Plan Sponsor's parent company effective April 28, 2023.

9. Prohibited Transactions

There were no prohibited party-in-interest transactions during the year ended December 31, 2022.

10. Tax Status

The Plan is a prototype non-standardized 401(k) profit sharing plan provided by ADP. The prototype plan received a favorable determination letter from the Internal Revenue Service on July 8, 2014 indicating that the specimen document was designed in accordance with applicable sections of the Internal Revenue Code (IRC). However, the determination did not constitute a determination of the qualification of an adopting plan sponsor. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The financial statement effects are recognized when the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
