INDEPENDENT AUDITOR'S REPORT

NOTE A—DESCRIPTION OF PLAN

The following description of the E & M Bindery, Inc. (“Company”) 401 (k) Profit-Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all full-time employees of the Company who have completed at least one month of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended and restated, effective June 1, 2015, to bring the Plan into compliance with the Pension Protection Act of 2006. The Plan was amended on August 5, 2020 to change the eligibility requirement from one full year of service to one month of service effective October 1, 2020. Employees eligible for nonelective contributions have no hours of service requirement.

Contributions. Participants may contribute from 1% to 90% of their annual wages as reflected on their Forms W-2. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various mutual fund options offered by the Plan. The Company is not required to make a Nonelective Contribution to the Plan but may choose to do so. The Nonelective Contribution will be allocated to all employees eligible to participate in the Plan in proportion to a participant's eligible earnings compared to the eligible earnings of the other employees. Contributions are subject to certain statutory limitations.

Participant Accounts. Each participant's account is credited with the participant's contribution. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Administrative expenses paid by the participant include investment management expenses, transactional costs and service charges as well as costs associated with obtaining a loan and receiving a distribution.

Vesting. Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in a Nonelective Contribution Account is based on years of service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The interest rate for a loan is the prime rate in effect, on the date of the loan, as published in The Wall Street Journal on the 14th day of the month immediately prior to the loan date, plus two percentage points. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 7.50%. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, or have the payment paid as a “direct rollover” to an individual retirement account or individual retirement annuity or to another employer's tax qualified plan. If the account balance is greater than \$5,000, the participant may also choose to receive installments, request a partial withdrawal, or defer receiving payments until age 70 1/2.

Forfeited Accounts. At December 31, 2021 and 2020 the forfeited nonvested account totaled \$59 and \$59, respectively. This account will be used to reduce administrative expenses paid by the Company.

NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

NOTE B—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, continued

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Loans must be fully repaid through payroll deductions within 5 years unless the loan is used for the purchase of a primary residence. A deemed distributed loan (DDL) occurs when a participant misses a loan payment and fails to make it up by a specified date, or the term for repaying a loan expires without full payment. The plan must continue to treat DDLs as outstanding; however, they are excluded from the assets reported on Schedule H of Form 5500. At December 31, 2021 and 2020, DDLs were \$1,125 and \$5,023, respectively. As of December 31, 2021 and 2020, no allowance for credit losses has been recorded.

An offset loan occurs when a participant has an outstanding loan, terminates employment, and is paid out from the plan. The loan is treated as part of the distribution.

Excess Contributions Payable

\$17,067 is recorded as accounts payable to a participant for a contribution in excess of amounts allowed by the IRS, with a corresponding reduction to 2021 contributions. The Plan distributed the 2021 excess contribution prior to March 15, 2022. There was an excess contribution of \$17,577 for the year ended December 31, 2020 which was distributed on March 9, 2021.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. These fees include trustee, recordkeeping and accounting and audit services.

Fees for the administration of notes receivable from participants and disbursements following termination and investment management expenses, transactional costs and service charges are included in administrative expenses and charged directly to the participant's account. Net expense ratios for investment options range from 0.03% to 0.84%.

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through October 7, 2022, which is the date the financial statements were available to be issued.

NOTE C—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE D—TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by letters dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letters, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE E—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G—FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.
