As a result, the Plan has changed its basis of accounting from the going concern basis used in prior years to the liquidation basis used in presenting the 2022 and 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

1. Description of Plan

The following description of The Traditional Bakery, Inc. DBA Panera Bread Company 401(k) Plan (Plan), sponsored by The Traditional Bakery, Inc. DBA Panera Bread Company (Company), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of the Company who have 1,000 hours of service in a one year period and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees are responsible for oversight of the Plan. The Fiduciary Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

On December 30, 2022, the Plan adopted a resolution to terminate plan operations and all plan assets were distributed, as reflected in the Statement of Changes in Net Assets Available for Benefits (in Liquidation). As of March 6, 2023, the plan ceased operations.

Contributions: Participants may contribute up to 100% of their annual wages, subject to certain IRS limitations, as defined in the Plan through pre-tax contributions, or after-tax ROTH contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Company may make matching contributions equal to a discretionary percentage of the participant's salary on an annual basis. The plan received \$92,695 in company contributions during the plan year ended December 31, 2022. There were no company or participant contributions received during 2023. Contributions are subject to certain IRS limitations.

Participant accounts: Each participant's account is credited with (a) the participant's contribution, (b) the Company's matching contribution (if any), and (c) Plan earnings. Net income and asset revaluation are allocated to each participant based upon the earnings of the investments selected by the participant. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their account is based on years of continuous service. A participant is 100% vested after six years of credited service. Upon plan termination, as discussed in Note 5, participants are 100% vested.

Payment of benefits: On termination of service, a participant receives a lump-sum amount, or annual payments over an elected term not to exceed the participant's life expectancy, equal to the participant's vested interest in the value of his or her account.

Forfeitures: At March 6, 2023 and December 31, 2022, there were no forfeited nonvested accounts. In the year ended December 31, 2022, employer contributions were reduced by \$4,668 from forfeited nonvested accounts.

Recognition of service: For purposes of satisfying the service requirements for vesting, eligibility, and hours of service the Plan shall recognize service with Oklahoma City Bakery, Inc. DBA Panera Bread Company.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 6.25%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions. Upon termination of the Plan, all loans were reclassified as deemed distributions and a benefit payment was recorded.

2. Summary of Accounting Policies

Basis of accounting: The Plan's financial statements are prepared on the accrual basis of accounting.

Accounting estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are stated at fair value as determined and certified by the Plan's asset custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded when received. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of March 6, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value in investments.

Payment of benefits: Benefits are recorded when paid.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and September 21, 2023, the date the financial statements were available to be issued.

3. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets and liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 6, 2023 and December 31, 2022.

Group variable annuity funds: Valued by the annuity provider using the quoted net asset value of the shares of the underlying mutual fund adjusted for any dividends or distributions received by AUL and the daily equivalent of any fee charged by AUL pursuant to the contract.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. On December 30, 2022, the governing body approved plan termination.

Effective March 6, 2023, the Plan distributed all assets of the plan and the Plan ceased operations.

6. Related-Party Transactions And Party In Interest Transactions

Substantially all of the administrative costs of the Plan are paid by the Company. Certain employees serve as the Plan's administrators. The administrators do not receive any compensation for services rendered to the Plan.

The Plan holds investments in funds managed by the Plan's asset custodian, AUL. Investments in these funds totaled \$391,480 at December 31, 2022. There were none held as of March 6, 2023.

7. Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at March 6, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the periods January 1, 2023 to March 6, 2023 and January 1, 2022 to December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the custodian).

8. Tax Status

The prototype document adopted by the Plan, obtained its determination letter on November 30, 2020, in which the Internal Revenue Service stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the favorable opinion letter. However, the Plan Administrator believes that the Plan is designed in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 6, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. A tax liability would be recognized if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
