Independent Auditor's Report

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of American Natural Operations, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of American Natural Operations, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2022 and 2021 and for the year ended December 31, 2022, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of American Natural Operations, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about American Natural Operations, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt American Natural Operations, LLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF PLAN

The following brief description of the American Natural Operations, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan available to substantially all employees of American Natural Operations, LLC (ANO) and affiliated companies in the plan documents (the Plan Sponsor). Employees become eligible to make deferrals upon hire except for the excluded employee groups as defined in the plan document.

The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may contribute a percentage of their eligible plan compensation up to a maximum allowance by the plan document and in accordance with other limiting provisions of the Internal Revenue Code (IRC) and other applicable legal limits. In any calendar year in which a participant is age 50 or older an additional "catch-up contribution" (limited to \$6,500 in 2022) may be made. The Plan also permits rollover contributions of retirement benefits received from other qualified plans and Roth elective deferrals.

The Plan allows for matching contributions for eligible employees of 100% of the first 3% of compensation contributed by employees plus 50% of the next 2% of compensation contributed by employees. Certain employee groups, as defined in the plan document are eligible for matching contributions after completion of a year of service.

The Plan Sponsor may also provide an additional discretionary profit sharing contribution determined by management of the Plan Sponsor. There was no discretionary profit sharing contribution in 2022.

Participant Accounts:

The plan administrator maintains separate participant accounts for each participant. Each participant's account is credited with the participant's contributions, employer matching contributions, an allocation of the company's discretionary profit sharing contribution, and plan earnings. Allocations are based on participants' account balances, as defined by the Plan. Participants may direct the investments of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting:

Participants are immediately vested in their contributions and actual earnings thereon. Vesting in the employer match and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants become fully vested upon completion of six years of continuous service.

Notes Receivable from Participants:

Participants may borrow from their accounts a minimum of \$500 and a maximum equal to the lesser of 50% of their vested balance or \$50,000, reduced by the participant's highest outstanding loan balance during the prior twelve months. A participant may have one loan outstanding at a time. Loan repayment terms may not exceed 60 months unless the loan is granted for the purpose of acquiring the participant's principal residence. In such instance, a longer repayment term may be permitted. Interest on loans is charged at the prime rate at the date of the loan plus 1%.

In the event of default, as described by the Plan, participants are considered to have received a distribution and are subject to income taxes on the distributed amount.

Benefit Payments:

Upon termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the vested value of the participant's account. Normal retirement is attained at age 65. During active employment, participants may withdraw their contributions for financial hardship based on circumstances defined in the plan document. Terminated employees receive a lump-sum amount if their account balance is less than \$5,000 but greater than \$1,000. If their account balance is greater than \$5,000, the participant must consent to receive a lump-sum distribution.

Hardship Withdrawals:

Participants may request that all or a portion of their account be distributed in the case of severe financial hardship, as defined in the plan document. The company must approve any such hardship withdrawals.

Forfeitures:

Nonvested accounts are forfeited upon participants' termination. Forfeited amounts can be used to reduce contributions made by the employer and to offset expenses incurred by the Plan. Employer contributions were reduced by forfeitures by \$5,244 in 2022. At December 31, 2022 and 2021, forfeited nonvested accounts were \$634 and \$0, respectively.

#### NOTE A - DESCRIPTION OF PLAN (CONTINUED)

##### Administration:

The company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, functions as both the plan administrator and plan trustee and has responsibility for the administration of the Plan. Reliance Trust Company functions as the trustee. Investment management fees are paid by the Plan in accordance with the Plan agreement.

##### Plan Termination:

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their account balance.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting:

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

##### Investment Valuation and Income Recognition:

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers the assumption that market participants would use when pricing the asset per liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021:

Mutual funds are public investment vehicles valued using the net asset value provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Investment Valuation and Income Recognition (continued):

The investment in the Invesco Stable Asset Trust (the Fund) is valued at net asset value (NAV) as supported by unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date resulting in a readily determinable fair value. As a practical expedient, the Plan measures and presents its investment in this fund at NAV as calculated by the plan administrator. The Fund allows for daily redemption and investments in the Fund and does not have a holding period. There are no unfunded commitments for investments in the Fund. The Fund seeks to preserve principal investment while earning interest income.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment gain and loss includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. Delinquent participant loans are reclassified as distributions based upon the terms of the plan documents.

Investment Management Fee and Operating Expenses:

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation in the fair value of investments.

Administrative Expenses:

Administrative expenses are paid by the Plan Sponsor or the Plan, as provided by the plan document. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Benefit Payments:

Benefits are recorded when paid.

Subsequent Events:

The plan sponsor evaluated all activity of the Plan through October 4, 2023, the date the financial statements were available to be issued, and concluded that no subsequent events have occurred that would require recognition or disclosure in the financial statements or notes.

NOTE C - CERTIFICATION OF FINANCIAL INFORMATION

Reliance Trust Company, the trustee of the Plan, has certified that all investment information and notes receivable from participants summarized in the statements of net assets available for benefits as of December 31, 2022 and 2021, and in the statement of changes in net assets available for benefits for the year ended December 31, 2022, including all investment income, is complete and accurate. As elected by the plan administrator, no auditing procedures have been performed on this information except to compare such information to the information included in the accompanying financial statements.

NOTE D - INVESTMENTS

FASB ASC 820 requires the Plan to classify its assets and liabilities based on valuation methods using three levels. Level 1 inputs are based on quoted prices in active markets for identical investments. Level 2 inputs are based on significant observable market inputs, such as quoted prices for similar investments and quoted prices in inactive markets. Level 3 inputs are based on significant unobservable inputs that reflect the Plan's determination of assumptions that market participants might reasonably use in valuing the investments. The valuation levels are not necessarily an indication of risk or liquidity associated with the underlying investments.

NOTE E - INCOME TAXES

The Plan is a non-standardized prototype plan of ADP, LLC, the third-party administrator of the Plan. ADP, LLC obtained a letter dated October 6, 2020 in which the Internal Revenue Service (IRS) stated its opinion that the form of the prototype plan of ADP, LLC is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are managed by the trustee. Therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for trustee and recordkeeping services were not significant for the year ended December 31, 2022. These transactions are not, however, considered prohibited transactions under Section 408(B) of the ERISA regulations.

Certain administrative functions are performed by officers or employees of the Plan Sponsor at no cost to the Plan.

The Plan has notes receivable from participants subject to specific guidance as defined in the plan document.

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.

The annual audit fee of the Plan is paid by the Plan Sponsor.

NOTE G - RISK AND UNCERTAINTIES
