INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Edelmann USA 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Edelmann USA 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets in liquidation available for benefits as of November 29, 2022 and the statement of net assets available for benefits as of December 31, 2021 (going concern basis), and the related statement of changes in net assets in liquidation available for benefits for the period ended November 29, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Edelmann USA 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of November 29, 2022 and December 31, 2021, and for the period ended November 29, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Edelmann USA 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Terminating Plan and Liquidation Basis of Accounting

As further discussed in Note 1 to the financial statements, the management of the Edelman USA, Inc, the plan's sponsor, voted on July 15, 2022 to terminate the plan and management determined liquidation is imminent. As a result, the Edelman USA 401(k) Plan changed its basis of accounting from the going-concern basis of accounting used in presenting the 2021 financial statements to the liquidation basis of accounting used in presenting the 2022 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Edelman USA 401(k) Plan's ability to continue as a going concern for one year after the date that the 2022 financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Edelman USA 401(k) Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Edelman USA 401(k) Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Edelman USA 401(k) Plan's internal control. 1. DESCRIPTION OF PLAN

The following description of the Edelmann USA 401(k) Plan (the “Plan”) is provided for general information purposes. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution profit sharing plan for the eligible employees of Edelmann USA, Inc. (the “Company”). The Plan has a pre-tax salary reduction provision as defined under Section 401 of the Internal Revenue Code (“IRC”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was established on January 1, 2017.

Plan Termination

On July 15, 2022, the management of the Plan sponsor elected to fully terminate the Plan. Upon termination, all participants will become 100% vested in their entire account balance. Upon satisfaction of all regulatory requirements, the Plan fully funded and liquidated all plan assets for all the participants. The Plan completed the liquidation process on November 29, 2022.

Eligibility

The Company’s employees over the age of 21 are eligible to participate in the Plan on their date of hire. The Plan allows automatic enrollment of eligible participants. Automatic enrollment provides that, in the absence of a participant election to the contrary, the participant is deemed to have elected to contribute 4% of the participant’s eligible pre-tax compensation.

Contributions

Participants may contribute a percentage of their pretax compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) from other qualified benefit plans. Participants direct the investment of all contributions to their account into various investment options offered by the Plan. The Company may also match participant contributions in an amount set by the Company which is determined and allocated at the end of the year. In addition, the Company, at its option, may contribute a portion of its current profits. For the period ended November 29, 2022, the Company elected not to contribute any matching contributions or profit-sharing contributions. Participants are eligible for employer contributions after one year of eligible service.

Participant Accounts

Participant accounts are credited with the participants’ contributions and allocations of (a) the Company’s profit-sharing contributions, (b) the Company’s matching contributions, and (c) Plan earnings. Participant accounts are reduced by withdrawals, if any, and allocation of administrative expenses. Allocations are based on participant earnings, participant contributions, or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Notes Receivable from Participants

The Plan allows participants to borrow up to 50% of their vested account balances; however, the loan can be no more than \$50,000 minus the participant’s highest outstanding loan amount during the prior 12 months. Repayment of a loan must be made by normal payroll deduction, on an after-tax basis, in level payments of principal and interest, and must be repaid within 5 years, unless the loan is taken for the purchase of a primary residence. The loans are secured by the balance in the participant’s account. Participant loans are stated at the unpaid principal value, which are estimated to approximate fair value.

Investment Options

Each participant directs the allocation of his or her contribution and employer matching contributions to a variety of investment options offered by the Plan. As part of the investment options, participants also can allocate contributions to self-directed brokerage accounts that have a variety of investments options.

Vesting

Participants are immediately 100% vested in their own contributions plus actual earnings thereon. Vesting in the portion of their account from the Company's contributions is based on years of continuous service. A participant is 100% vested after six years of credited service. In addition, participants will become 100% vested upon attaining the age of 59 ½, death, or disability.

Payment of Benefits

Upon reaching the normal retirement age or upon termination of service, a participant may elect to receive either a lump-sum amount or partial payments equal to the value of the participant's vested interest in his or her account.

Forfeitures

As of November 29, 2022 and December 31, 2021, the Plan had no forfeited non-vested accounts. During the year ended November 29, 2022, there were no forfeitures reallocated among the remaining participants.

Administrative Expenses

Administrative expenses are paid by the Plan. Certain administrative expenses associated with in-service withdrawals, payment of benefits, and participant loan initiations are charged directly against the participant's account. In addition, certain investment related expenses have been offset with investment income and are not readily determinable.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the liquidation basis of accounting. In accordance with generally accepted accounting principles ("GAAP") in the United States of America, assets are stated at their net realizable values, liabilities are stated at their settlement amount and all expenses in liquidation have been recognized. Fair value is comparable to net realizable value. The accompanying 2021 financial statements of the Plan are prepared in compliance with the going concern method of accounting in conformity with GAAP.

Investment Valuation and Income Recognition

Investments are reported at fair value and have been certified complete and accurate by Ascensus Trust Company (Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with the liquidation basis of accounting requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein at the date of the financial statements and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates. The preparation of 2021 financial statements in conformity with the going concern method of accounting in conformity with GAAP requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein at the date of the financial statements and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for various investment options in any combination of investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investments securities, it is possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events

The Plan evaluated subsequent events through October 6, 2023, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 29, 2022 and December 31, 2021:

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets measured at Net Asset Value ("NAV") as the practical expedient to estimate fair value:

Common/Collective Trusts: Common/collective trusts ("CCT") are valued at NAV which is based on the fair value of the underlying investments of the CCT, less any liabilities. CCT are composed of a stable value fund that is composed primarily guaranteed investment contracts that are not fully-benefit responsive and is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

No auditing procedures were performed by the independent auditor as permitted by ERISA Section 103(a)(3)(C) with respect to information certified as complete and accurate by Ascensus Trust Company (the "trustee"), except for comparing such information with the information reported in the financial statements. Based on information provided and certified by the trustee, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of November 29, 2022 and December 31, 2021. Accordingly, the trustees of the Plan assets have certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets in liquidation available for benefits as of November 29, 2022 (liquidation basis) and December 31, 2021 (going concern basis).
- Net depreciation in fair value of investments, interest and dividends reflected on the accompanying statement of changes in net assets in liquidation available for benefits for the period ended November 29, 2022.

5. INCOME TAX STATUS

The Plan document is a prototype, non-standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 29, 2022 and December 31, 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were shares mutual funds managed by The Vanguard Group, Inc., who served as the custodian of the Plan assets. Therefore, these transactions qualified as party-in-interest transactions.

The Plan pays administrative expenses to parties-in-interest who provided services to the Plan and for which a statutory exemption exists. Additionally, notes receivable from participants were considered party-in-interest transactions.

All such party-in-interest transactions were exempted from the prohibited transaction rules under ERISA.
