Basis for Opinion

NOTE 1 – PLAN DESCRIPTION

The following description of the Feldco Factory Direct National 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan's provisions.

A. GENERAL

The Plan is a profit sharing and 401(k) defined contribution plan covering employees of Feldco Factory Direct National, LLC (the "Company") who meet the eligibility requirements of twelve months of service and twenty-one years of age. Employees can then enter the Plan on the first day of the first month or seventh month of the Plan Year coincident with or next following the date the requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. CONTRIBUTIONS

Under the Plan, participants are allowed to defer a portion of their compensation under a salary reduction agreement. Elective deferrals may be made in any amount between one percent and ninety percent of eligible compensation up to applicable ERISA contribution limits for the year. "Compensation" is defined as a participant's W-2 earnings. Participants may change elective deferral elections on the first day of each month of the Plan year.

The Plan allows for automatic enrollment starting at four percent of eligible compensation. The deferral election will increase by one percent each year up to ten percent.

The Company makes contributions to the Plan equal to a discretionary percentage on behalf of eligible participants that are employed at the end of the Plan year and meet the minimum hours requirement. For the years ended December 31, 2022 and 2021, the discretionary match totaled 6% of an employee's contribution during the year. The employer match is determined subsequent to year-end.

C. PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's elective deferral contribution and an allocation of (a) the Company's employer matching contribution, (b) the Company's discretionary profit-sharing contribution, and (c) plan earnings based upon the investment elections chosen. Allocations are based on participant earnings or account balances, as defined, and directed by participants.

D. NOTES RECEIVABLE FROM PARTICIPANTS

The Plan includes a provision allowing eligible participants to borrow from their accounts at a minimum of \$1,000, and up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balance. Loan terms range from one to five years. The loans are repaid, with interest, through equal payroll deductions. The interest rate charged on loans is based on a rate determined by the Plan Administrator. Participants may not have more than one loan outstanding at any time.

E. VESTING

Employees are 100% vested in their voluntary contributions or rollover contributions made to the Plan. In the case of the employer's discretionary contributions, the Plan uses a graduated scale for vesting:

2	40%
3	60%
4	80%
5 or more	100%

A participant becomes fully vested upon attainment of normal retirement age while an employee, death while an employee, or upon suffering a disability while an employee. Vesting years are subject to a minimum hours requirement.

F. PAYMENT OF BENEFITS

On termination of service due to death, disability, retirement, or other reasons, a participant can choose to have a distribution of his/her account balance equal to the value of his/her vested interest. In the case of early distribution at age 59 ½, the participant may elect to withdraw all or some of his/her vested amounts (including any earnings thereon). Upon financial hardship, as defined by the Plan agreement, distributions are permitted prior to termination of service.

G. PLAN EXPENSES

Certain expenses relating to the administration of the Plan have been paid by the Company and are not significant to the operation of the Plan.

H. PLAN TERMINATION

The Company reserves the right to alter, amend, or terminate the Plan. In the event of Plan termination, each participant will become 100 percent vested in their account balance, and participants will be entitled to a full distribution of their account balance. Presently, there is no intention on the part of the Company to terminate the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

B. BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

C. ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

D. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Investment (loss) income is recorded when earned, on the accrual basis, and allocated to each participant's account daily based on the number of shares held in each participant account. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are recorded in the accompanying financial statements at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

F. PAYMENT OF BENEFITS

Benefits are recorded when paid.

G. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

While the immediate impacts of the COVID-19 pandemic have been assessed, the long-term effects of the disruption and resulting impact on the economy and financial markets remain unpredictable and depend on future developments, such as the possible resurgence of the virus, variant strains of the virus, vaccine availability and effectiveness, and future government actions in response to the crisis. Subsequent changes in interest rates and volatility in financial markets could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits. Plan management continues to monitor the impact of these economic factors but is unable to estimate the total impact the pandemic will have.

H. SUBSEQUENT EVENTS

The Plan evaluated subsequent events through October 16, 2023, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financial statements and notes thereto.

NOTE 3 – INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan's investments are held in a trust fund administered by John Hancock Life Insurance Company ("John Hancock"). The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the custodian:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2022 and 2021.
- Investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2022.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2022.

NOTE 4 – TAX STATUS

The Plan obtained its latest determination letter, dated June 30, 2020, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, it is believed that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

As of December 31, 2022 and 2021, Plan investments consisted of mutual funds and cash funds managed by John Hancock, the trustee and record-keeper of the Plan. These transactions qualify as party-in-interest transactions. Also, the Plan has notes receivable from participants that qualify as party-in-interest transactions. The total of these investments and receivables was approximately \$406,590 and \$274,762, as of December 31, 2022 and 2021, respectively.

NOTE 6 – FORFEITED ACCOUNTS

As of December 31, 2022 and 2021, forfeited, non-vested accounts totaled \$1,306 and \$2,069, respectively. Approximately, \$2,000 of forfeitures was used to pay certain administrative expenses in the plan year ended December 31, 2022.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The accounting framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

NOTE 7 – FAIR VALUE MEASUREMENTS – (CONTINUED) –

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuations techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

- *Pooled Separate Accounts*: separate accounts are valued at their “accumulation unit value” (AUV). The separate account is valued daily as the number of accumulation units held multiplied by the AUV. The AUV is determined daily based on the net asset value of shares of the underlying fund, the fund's dividends, and the Plan's contract account charges. Since the AUV is determined based on a combination of the fund NAV and the separate account charges, Level 2 was deemed the proper classification.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
