## INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.

Their report dated October 7, 2022, indicated that: (a) the amounts and disclosures in the 2021 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2021 financial statements related to the assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c). Their report also indicated that the form and content of the 2021 supplemental schedule, other than the information in the 2021 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respect, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2021 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirement of ERISA Section 103(a)(3)(c).

## **1. DESCRIPTION OF THE PLAN**

The following description of NXTsoft, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### **General**

The Plan is a defined contribution plan, created on May 1, 2019, covering substantially all employees of NXTsoft, LLC (the Company), who have at least three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Contributions**

Participants may elect to defer up to 90% of their compensation each year, as defined by the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Participants also have the option to make Roth elective deferrals to the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Each year, the Company will contribute to the Plan the following amounts: (a) a 100% safe harbor matching contribution equal to a percentage of the amount of the salary reductions up to 4% of compensation, and (b) a discretionary profit-sharing contribution to be determined annually. The Company made safe harbor matching contributions of \$426,586 for the year ended December 31, 2022.

Profit sharing contributions are allocated to participants based on relative compensation. Profit sharing contributions are available only to employees who are employed on the last day of the Plan year and have completed at least 1,000 hours of credited service during the Plan year. The requirement to be an employee on the last day of the Plan year is waived if employment was terminated due to death, disability or retirement. There were no discretionary profit sharing contributions declared for the year ended December 31, 2022.

### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's contribution and Plan earnings. Allocations are based on participant contributions for that Plan year of compensation, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions and the Company's safe harbor contributions, plus the actual earnings thereon. Vesting in the discretionary profit sharing contribution is based on years of service. Participants are 100% vested after 6 years of credited service.

**1. DESCRIPTION OF THE PLAN – CONTINUED**

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. General purpose loans are repayable through payroll deductions over periods ranging up to 60 months. The loans are secured by the balance in the participant's account bearing interest at rates ranging from 4.25% to 7.50%, which is equal to the prime rate as established by the Wall Street Journal on the 14<sup>th</sup> day of each month, plus one percent.

**Payment of Benefits**

Upon termination of service due to death, total or permanent disability, severance from employment, or financial hardship, a participant may elect to receive an amount equal to the vested interest in his or her account either in a lump sum, a direct rollover to an eligible retirement plan as defined by the IRC, as amended, or a combination thereof. The Plan also allows employees to withdraw vested balances starting at age 59½. Distributions are subject to the applicable provisions of the Plan.

**Forfeitures**

At December 31, 2022, the Plan had no forfeited nonvested accounts and at December 31, 2021, the plan had forfeited nonvested accounts of \$217. Forfeited amounts are used to reduce employer profit-sharing contributions and then used to pay administrative expenses. In 2022, forfeited nonvested accounts of \$217 were used to reduce employer contributions and pay administrative expenses.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make a loan repayment and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments. The Plan has entered into a revenue sharing agreement with the investment advisors related to revenue generated by the Plan's investments. The revenue contributed to the Plan for the 2022 Plan year totaled \$1,542. This amount is reflected as other income on the statement of changes in net assets available for benefits for the year ended December 31, 2022. These amounts are used to pay recordkeeping fees for the Plan.

**3. CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2022 and 2021, and net depreciation in fair value of investments, and interest and dividends for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement* are described as follows:

**4. FAIR VALUE MEASUREMENTS – CONTINUED**

Level 1 – The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded; and

Level 2 – Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and

Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**5. PARTIES-IN-INTEREST TRANSACTIONS**

The Plan paid fees to parties-in-interest for recordkeeping, trustee and investment management services. These transactions qualify as parties-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

**6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Effective December 21, 2022, the Plan had three employers that were spun off under another legal entity resulting in a partial termination of the Plan. At that time all effected participants were terminated and all non-vested money became 100% vested.

**7. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
