Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Almo Corporation Non-Bargained Employees' 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 1, 2022 and March 31, 2022, and the related statement of changes in net assets available for benefits for the period April 1, 2022 to December 1, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 1, 2022 and March 31, 2022 and for the period April 1, 2022 to December 1, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following description of the Almo Corporation Non-Bargained Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Almo Corporation and its wholly-owned subsidiaries (the Company), except for employees whose employment is governed by a collective bargaining agreement, non-resident aliens, leased employees, interns, and employees of an affiliated service group that is not part of the Plan. Full-time employees who have completed 90 days of service are eligible to enroll in the Plan. Part-time employees are eligible to enroll in the Plan after completing one year of service, as defined by the Plan. Employer contributions require a minimum of six months of service for full-time employees and one year of service for part-time employees. To receive the profit sharing contribution, an employee must be employed on the last day of the plan year, subject to certain exceptions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Directors is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On December 1, 2022, the Plan was merged into the DCC LPG 401(k) Savings Plan (DCC Plan). In connection with the merger, all investment and loan balances totaling \$45,581,990 were transferred to the DCC Plan.

Contributions

Each year, participants may contribute an amount up to 100% of annual compensation, as defined by the Plan, not to exceed the deferral dollar limits imposed by the Internal Revenue Code (IRC). Participants may designate all or a portion of their salary deferrals as Roth deferrals. The Company may make a discretionary matching contribution. The Company did not make any matching contributions for the period ended December 1, 2022. The Company may also contribute additional profit sharing amounts as determined by the Board of Directors. For the period ended December 1, 2022, Company profit sharing contributions, net of forfeitures used, totaled \$880,000. Participants direct the investment of their contributions into various investment options of the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, as well as allocations of the Company's matching and profit sharing contribution and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests 20% per year over five years of credited service. Participants become fully vested upon death or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may not exceed 5 years unless the loan is used to acquire the principal residence of the participant, for which the loan term may not exceed 15 years. The loan interest rate, determined periodically by the plan administrator, is set at 2% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Payments of Benefits

Upon termination of service due to retirement, death or disability, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Withdrawals can also be made upon the attainment of age 59½. Participants can also withdraw a portion of their account balances in the event of a financial hardship, as defined by the Plan.

Forfeited Accounts

At December 1, 2022, there were no forfeited nonvested accounts. At March 31, 2022, forfeited nonvested accounts totaled \$48,550. These accounts may be used to reduce future Company contributions, pay plan expenses or may be reallocated to eligible participants. During 2022, forfeitures of \$66,063 were used to offset Company contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 1, 2022 and March 31, 2022.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Substantially all of the administrative expenses of the Plan are paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 16, 2023, the date the financial statements were available to be issued.

(3) Investment Information Certified by Qualified Institutions

Certain information related to investments disclosed in the accompanying financial statements including investments and notes receivable from participants held at December 1, 2022 and March 31, 2022, and net depreciation in fair value of investments, dividend income, and interest income on notes receivable from participants for the period ended December 1, 2022, was obtained by management and agreed to or derived from the information certified as complete and accurate by Empower Trust Company, LLC, Empower Annuity Insurance Company of America (Empower), Great-West Life & Annuity Insurance Company (Great-West) and Great-West Trust Company, LLC, qualified institutions.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 1, 2022 and March 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value. There have been no changes in the methodologies used at December 1, 2022 and March 31, 2022.

(5) Investment Contract with Insurance Company

The Plan invests in a fully benefit-responsive investment contract with Great-West and Empower. This fund contains investment contracts with insurance companies and comprises primarily benefit-responsive investment contracts. The contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West and Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(5) Investment Contract with Insurance Company, Continued

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Generally, the only event that could limit the ability of the Plan to transact at contract value is a cessation of operations, as initiated by the Plan. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreement prior to the scheduled maturity dates.

(6) Related Party Transactions and Party-In-Interest Transactions

The Plan invests in a fully benefit-responsive investment contract managed by Great-West and Empower. Great-West and Empower are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.

Certain administrative functions are performed by officers or employees of Almo Corporation and its subsidiaries. No such officer or employee receives compensation from the Plan.

(7) Tax Status

The Plan uses a prototype plan document sponsored by Ascensus LLC. The IRS has determined and informed Ascensus LLC by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Almo Corporation ("Plan Sponsor") is writing to report an issue with our 401(k)-retirement plan that occurred in 2022. Our Plan Administrator did not notify 110 plan members about a temporary blackout period that would affect access to their funds.

A timeline of the pertinent events is as follows:

10/24/2022 597 plan members are properly notified of the upcoming blackout period.

11/23/2022 – The blackout period begins.

12/01/2022 – Funds are transferred from the original plan to the new plan.

12/15/2022 – The 110 individuals that did not originally receive notice of the blackout period are now notified.

01/09/2023 – The blackout period ends.

The cause of this error was identified and is an isolated incident that will not be repeated. Plan Sponsor was acquired in 2022 and therefore was transferring funds to the acquiree's 401(k) provider. As a result, it provided proper blackout notice in advance of this transfer to 597 plan members, representing 84% of the total plan members at the time. The small subset of members that were not given notice were individuals that were no longer employed by Plan Sponsor, yet left funds in Plan Sponsor's plan.

Plan Sponsor is requesting relief from any potential penalty due to several factors. First, Plan Sponsor's issue was a one-off mistake occurring in a plan that has been in existence for 36-years. Second, the vast majority of the plan members - 84% - were properly notified prior to the blackout period. Finally, as an aggregate, the members that did not receive notice were not materially harmed.
