## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Company 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). #### 1. DESCRIPTION OF PLAN

##### **General**

The following description of The Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a 401(k) plan, established by M-Three Consulting (the "Company" or "Plan Sponsor") on August 1, 2016 in accordance with the provisions of Internal Revenue Code ("IRC") Section 401. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

As a result of the purchase of the Company by John Wiley & Sons, Inc. (the "Parent"), the Board of Directors of the Parent resolved in July 2020 to merge the Plan into the John Wiley & Sons, Inc. Employees' Savings Plan, where Vanguard Fiduciary Trust Company is the Trustee. A portion of the assets, totaling \$353,000, were transferred on February 4, 2021 and the remainder of the assets, totaling \$2,085,475, were transferred on July 1, 2022 and July 6, 2022.

##### **Administration of the Plan**

The Company is the Plan Administrator ("Plan Administrator") and is responsible for providing the participants and their beneficiaries with information about their rights and benefits under the Plan. Matrix Trust Company LLC, and CMFG Life Insurance Company (the "Trustees"), hold the Plan's investments and execute investment transactions.

##### **Eligibility**

All employees of the Company, except for non-resident aliens, are eligible to participate in the Plan. All employees are allowed to enter the Plan on the first day of the month coinciding with or next following the date the eligibility requirements have been met.

##### **Contributions**

Participants are permitted to make pre-tax and post-tax (Roth) contributions up to the limitation contained in the IRC in effect for each taxable year. Newly eligible participants are automatically enrolled in the Plan at a 2% deferral rate, unless the participant elects otherwise. In 2022, participants were permitted to contribute up to a maximum of \$20,500 with an additional \$6,500 catch-up contribution for employees over 50 years old. Participants are also permitted to contribute distributions from other qualified plans.

The Plan allows the Company to provide a discretionary matching contribution and/ or a discretionary profit-sharing contribution as determined by the Company each year. For the period from January 1, 2022 through September 30, 2022, the Company provided a matching contribution equal to 100% of the participant deferrals up to a maximum 5% of the respective participant's compensation. For the period from January 1, 2022 through September 30, 2022, the Company elected not to fund a discretionary profit-sharing contribution.

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, Company contributions, if any, the Plan's earnings (losses), participant withdrawals, and administration expenses, if applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are immediately vested in their contributions and Company contributions, plus actual earnings thereon.

**Notes Receivable from Participants**

Participants are allowed to borrow up to one loan at a time from their accounts an amount equal to no less than \$1,000 and no greater than \$50,000 or 50% of the participant's vested balance. The loans bear interest, and principal and interest are repaid ratably through payroll deductions. The loans generally bear interest at the prime rate at the time of the loan plus one percentage point. General purpose loans must be repaid within five years, and loans used to purchase a primary residence may be paid over thirty years.

**Investment Options**

Each participant directs participant and Company contributions to any of the investment options offered by the Plan. Participants may change their investment elections amongst these options at any time.

**Payment of Benefits**

In the event of retirement, disability or termination of employment, participants may elect a lump-sum or partial distribution equal to the value of the participant's vested balance, or to transfer their vested benefits to another qualified plan or to an individual retirement account. Participants may also request in-service distributions upon attaining age 59 ½ or for certain financial hardships. Vested balances under \$5,000 may be automatically distributed upon a participant's severance of employment.

**Forfeitures**

Participants are fully vested in all contributions, accordingly, there are no forfeitures in the Plan.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan have been prepared in compliance with the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Company to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein at the date of the financial statements and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

**Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income from notes receivable is recorded when earned. No allowance for losses is deemed necessary by Plan management as principal and interest are repaid through payroll deductions. A note receivable is considered to be in default after any scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the payment was due, at which point the defaulted note receivable is considered to be a distribution to the participant, and the note would be removed from the Plan's assets. The interest rate charged on notes receivable from participants was 4.00% at December 31, 2021.

**Investment Valuation and Income Recognition**

The Plan's investments are recorded at fair value except for the Guaranteed Investment Contract that is valued at contract value. See Note 4 Fair Value Measurements and Note 5 Guaranteed Investment Contract. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis and dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year. There were no significant amounts of investment income due to the Plan at September 30, 2022 and December 31, 2021.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

Plan expenses can be paid directly by the Company or by the Plan. Administrative expenses paid by the Plan were \$12,228 for the period from January 1, 2022 through September 30, 2022 and include administrative and investment advisory fees. Certain investment related expenses are netted from net depreciation in fair value of investments and are not readily determinable.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**3. INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Trustees of the Plan have certified the completeness and accuracy of all investments and related investment activity, notes receivable from participants and the related interest income in the accompanying statements of net assets available for benefits as of September 30, 2022 and December 31, 2021, the statement of changes in net assets available for benefits for the period from January 1, 2022 through September 30, 2022. No auditing procedures were performed with respect to the information certified by the Trustees, except for comparing such information with the information reported in the financial statements.

**4. FAIR VALUE MEASUREMENTS**

GAAP guidance relating to fair value measurements establishes a framework for measuring fair value and clarifies that fair value is an estimate of the exit price, representing the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants (i.e., the exit price at the measurement date). That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy are described below:

*Level 1* – Quoted prices in active markets for identical assets or liabilities.

*Level 2* – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

*Level 3* – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Registered investment companies:* Valued at the closing prices as reported on the active market on which the funds are traded.

*Common/collective trust:* Valued at the net asset values of the underlying investments as adjusted for the trust's related liabilities and administrative expenses charged. There are no redemption restrictions for unfunded commitments of the Plan related to these investments. The fair values of these investments are measured using the net asset value practical expedient.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value, on a recurring basis:

\*In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**5. GUARANTEED INVESTMENT CONTRACT**

The Plan invests in a fully benefit-responsive investment contract whereby CMFG Life Insurance Company maintains the contributions in a general account. The investment contract is included in the statements of net assets available for benefits at contract value as reported to the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum interest guaranteed to the Plan is 1.90%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract.

Certain events limit the Plan's ability to transact at contract value. Such events include the following: (a) amendments to the Plan documents (including complete or partial termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption under ERISA. The Plan administrator does not believe the merger of the Plan into the John Wiley & Sons, Inc. Employees' Savings Plan had any effect on the Plan's ability to transact at contract value with Plan participants.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments include common collective trusts and a guaranteed investment issued by one of the Trustees of the Plan, and such related transactions are considered party-in-interest transactions. Participants are parties-in-interest to the Plan, therefore notes receivable from participants qualify as party-in-interest transactions. These transactions are exempt from the prohibited transactions rules of ERISA.

Certain fees and expenses of the Plan are paid by the Company. Additionally, certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**7. TAX STATUS**

The Plan adopted a volume submitter 401(k) profit sharing plan document which obtained its latest opinion letter on March 31, 2014 in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Furthermore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. In addition, there have been no tax related interest or penalties for periods presented in these financial statements.

**8. SUBSEQUENT EVENTS**

The Plan Administrator has evaluated subsequent events occurring after September 30, 2022 through October 13, 2023, the date the financial statements were available to be issued. Based on that evaluation, the Plan has determined that no subsequent events have occurred that would require adjustment to or disclosure in the financial statements.
