Notes to Financial Statements

Note 1: Plan Description

The following description of B&M Roofing of Colorado 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualifying employees of B&M Roofing of Colorado, Inc. (the "Company"), who are 21 years or older and have completed six months of service, defined as 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The custodian of the Plan, and the Company as the plan administrator, are responsible for the oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the custodian. Ascensus Trust Company provides custodial, investment advisor, and recordkeeping services to the Plan, pursuant to the terms of the service provider agreement.

Subsequent to year end, the Plan changed to LT Trust Company as their custodian.

Contributions

Each year participants may contribute annual compensation on a pretax or after-tax basis, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the IRS. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan is a Safe-Harbor plan and requires the Company to make matching contributions equal to 100% of the first 3%, and 50% of contributions greater than 3% and up to 5%, of eligible participant's compensation. Additional profit sharing contributions can be made at the discretion of the Company's Board of Directors. The Company made Safe Harbor contributions of \$132,487 during the year ended December 31, 2022, and there were no discretionary profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Plan Description (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, including rollovers, and the Company's Safe Harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions, plus earnings thereon, is based on years of service. A participant is fully vested after six years of service.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and a guaranteed investment contract as investment options for participants. Participants may change their investment options at any time.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals are permitted and may be made from any of the participant's vested account balances at any time upon or after reaching age 59 1/2. Hardship withdrawals are available if the participant meets certain criteria.

Forfeitures

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$1,308 and \$4,457, respectively. These funds are used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2022, \$2,623 of forfeitures were used to reduce plan expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's fully benefit-responsive investment contract (FBRIC) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balance and are included in net change in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 2, 2023, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure, except as identified in Note 1.

Note 3: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified that the following unaudited information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021.
- Interest and dividend income and net change in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2022.

This information has not been audited by the Plan's independent auditors.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Investment Contract with Insurance Company

The Plan offers a fully benefit-responsive investment contract with Standard Insurance Company ("Standard"). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the guaranteed investment contract become part of Standard's general account. The contract is credited with interest in accordance with the interest crediting rate established and periodically adjusted by the issuer. The contract is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is a traditional guaranteed investment contract and is presented in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is based on a formula determined by the issuer, but it may not be less than 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

The average yield of the investment for the year ended December 31, 2022, was 2.35%.

Note 5: Investment Contract with Insurance Company (Continued)

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (3) plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is not probable.

The insurance company may terminate the contract with thirty days written notice to the contract owner for reasonable cause, which includes failure by the contract owner to meet contract requirements.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Ascensus Trust Company is the custodian and also provides third party administration and recordkeeping services. SetAway Solutions, LLC also provides third party administration services. Additionally, Achieve Retirement provides investment advisory services and administrative services to the Plan, and Wipfli LLP performs the ERISA Section 103(a)(3)(C) audit of the Plan. Transactions with these companies qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2022, the Plan made direct payments of \$28,450 to the custodian and third party administrators which were not covered by revenue sharing. The plan sponsor pays directly any other fees related to the Plan's operations.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company profit sharing contributions.

Note 8: Tax Status

The Plan utilizes a volume submitter plan which obtained a favorable determination letter from the IRS dated June 30, 2020, stating that the prototype is qualified under the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Notes to Financial Statements

Note 1: Plan Description

The following description of B&M Roofing of Colorado 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all qualifying employees of B&M Roofing of Colorado, Inc. (the "Company"), who are 21 years or older and have completed six months of service, defined as 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The custodian of the Plan, and the Company as the plan administrator, are responsible for the oversight of the Plan. The Plan's investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the custodian. Ascensus Trust Company provides custodial, investment advisor, and recordkeeping services to the Plan, pursuant to the terms of the service provider agreement.

Subsequent to year end, the Plan changed to LT Trust Company as their custodian.

Contributions

Each year participants may contribute annual compensation on a pretax or after-tax basis, as defined in the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). Deferral contributions and after-tax Roth contributions shall not exceed certain limits set forth by the IRS. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan is a Safe-Harbor plan and requires the Company to make matching contributions equal to 100% of the first 3%, and 50% of contributions greater than 3% and up to 5%, of eligible participant's compensation. Additional profit sharing contributions can be made at the discretion of the Company's Board of Directors. The Company made Safe Harbor contributions of \$132,487 during the year ended December 31, 2022, and there were no discretionary profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and allocations of plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Plan Description (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, including rollovers, and the Company's Safe Harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary profit sharing contributions, plus earnings thereon, is based on years of service. A participant is fully vested after six years of service.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds and a guaranteed investment contract as investment options for participants. Participants may change their investment options at any time.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments as required by minimum distribution rules. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals are permitted and may be made from any of the participant's vested account balances at any time upon or after reaching age 59 1/2. Hardship withdrawals are available if the participant meets certain criteria.

Forfeitures

At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$1,308 and \$4,457, respectively. These funds are used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the year ended December 31, 2022, \$2,623 of forfeitures were used to reduce plan expenses.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Note 2: Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's fully benefit-responsive investment contract (FBRIC) which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are allocated proportionately to plan participants based on their respective account balance and are included in net change in fair value of investments.

Subsequent Events

Subsequent events have been evaluated through October 2, 2023, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure, except as identified in Note 1.

Note 3: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan has certified that the following unaudited information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2022 and 2021.
- Interest and dividend income and net change in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- All investment information included in the Supplemental Schedule - Form 5500 Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2022.

This information has not been audited by the Plan's independent auditors.

Note 4: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Investment Contract with Insurance Company

The Plan offers a fully benefit-responsive investment contract with Standard Insurance Company ("Standard"). Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contributions to the guaranteed investment contract become part of Standard's general account. The contract is credited with interest in accordance with the interest crediting rate established and periodically adjusted by the issuer. The contract is charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract is a traditional guaranteed investment contract and is presented in the Statements of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate is based on a formula determined by the issuer, but it may not be less than 1.00%. Such interest rates are reviewed on a quarterly basis for resetting.

The average yield of the investment for the year ended December 31, 2022, was 2.35%.

Note 5: Investment Contract with Insurance Company (Continued)

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) termination of the contract, (2) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (3) plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is not probable.

The insurance company may terminate the contract with thirty days written notice to the contract owner for reasonable cause, which includes failure by the contract owner to meet contract requirements.

Note 6: Related-Party Transactions and Party-in-Interest Transactions

Ascensus Trust Company is the custodian and also provides third party administration and recordkeeping services. SetAway Solutions, LLC also provides third party administration services. Additionally, Achieve Retirement provides investment advisory services and administrative services to the Plan, and Wipfli LLP performs the ERISA Section 103(a)(3)(C) audit of the Plan. Transactions with these companies qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments, as they are paid through revenue sharing rather than a direct payment. For the year ended December 31, 2022, the Plan made direct payments of \$28,450 to the custodian and third party administrators which were not covered by revenue sharing. The plan sponsor pays directly any other fees related to the Plan's operations.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company profit sharing contributions.

Note 8: Tax Status

The Plan utilizes a volume submitter plan which obtained a favorable determination letter from the IRS dated June 30, 2020, stating that the prototype is qualified under the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
