Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of TeraRecon, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Merger of the Plan

As further described in Note 3 to the financial statements, the plan was merged with and into the ConcertAI 401(k) Plan and all plan assets were transferred out on January 9, 2023. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the TeraRecon, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. General

The Plan is a defined contribution plan that was established in 2000 by TeraRecon, Inc. (the “Company”) to provide benefits to eligible employees, as defined in the Plan document. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the “Code”) and provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

B. Plan Administration

An officer of the Company serves as Plan trustee. The Plan designated Transamerica Life Insurance Company (Transamerica) as custodian of Plan assets. Reliance Trust Company (“Reliance”) serves as directed trustee of the Plan. On January 1, 2023 the TeraRecon, Inc. 401(k) Plan was merged with parent company, Symphony AI Group’s 401k plan, Concerto Health AI Solutions 401(k) Plan. Plan assets were transferred on January 9, 2023 (Note 3).

C. Eligibility

The Plan covers substantially all employees of the Company age 21 or older who have completed one month of service. Plan entry is the first day of the month coinciding with or next following the date that eligibility requirements have been satisfied.

D. Contributions

Participants may elect to have the Company contribute their eligible pre-tax compensation up to the amount allowable under the Plan document and Code regulations. Participants who elect to have the Company contribute a portion of their pre-tax compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Participants age 50 or older may make up to \$7,500 of additional catch-up contributions in 2023. Contributions are invested in accordance with participant directions.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant directions and the Plan’s provisions.

The Plan provides for the Company to make discretionary profit sharing contributions, and matching contributions. No discretionary profit sharing contribution was made for the period ended January 9, 2023.

E. Vesting

Participants are immediately 100% vested in their pay deferrals, rollovers and related earnings. Participants are 25% vested in employer matching contributions following the completion of 1 year of service and vest an additional 25% for each year thereafter until becoming 100% vested

E. Vesting (Continued)

on their 4th year of service. Participants are 20% vested in employer profit sharing contributions following completion of two years of service, and vest an additional 20% for each year of service thereafter until becoming 100% vested after completing 6 years of service. Forfeitures of terminated participants' non-vested accounts will be used to reduce Company contributions. Forfeitures of \$0 and \$27,251 were used to reduce Company matching contributions, and to pay plan expenses during the period ended January 9, 2023 and year ended December 31, 2022, respectively. Forfeiture account balances of approximately \$34,000 were transferred out on January 9, 2023.

F. Payment of Benefits

Participants are eligible for benefits upon retirement, disability or termination of service. Normal retirement age under the Plan is age 65. Benefits under the Plan are payable in a lump sum or installments. Hardship distributions are permitted under limited circumstances as provided by the Plan and approved by the plan administrator. Benefits are recorded when paid.

G. Expenses

Certain investment fund management fees and operating expenses are charged directly to the investment funds and are thereby factored into each investment fund as a reduction in investment return. Transamerica contract administration fees, recordkeeping fees and brokerage commissions are paid by the Plan. Certain fees including withdrawal and participant loan administration fees are charged directly to participant accounts. The Company pays other costs incurred for administering the Plan.

H. Notes Receivable from Participants

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by a participant's vested account, bears interest at a fixed rate comparable to rates available on similar loans made by commercial lenders, and must be repaid to the Plan within five years or if the loan is for the purchase of a principal residence the term may be extended to a maximum of thirty years. Principal and interest are paid ratably through payroll deductions.

Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

B. Investment Valuation and Income Recognition

Investments are stated at fair value except the Transamerica Stable Value Fund which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made to the account, plus earnings, less participant withdrawals.

Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gains distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

C. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

D. Risks and Uncertainties

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

NOTE 3 - MERGER OF THE PLAN

The Company authorized the merger of the Plan effective January 1, 2023 into the ConcertAI 401(k) Plan. The total plan investments and participant loans transferred into ConcertAI 401(k) Plan on January 9, 2023 were \$18,774,347 and \$111,500, respectively.

NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS

Certain investment options offered are managed by Transamerica. Purchases and sales of these funds and payments of direct and indirect administrative and investment management fees to Plan service providers by the Plan are considered party-in-interest transactions under ERISA regulations. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under provisions of the Plan and are specifically exempt from prohibition of party-in-interest transactions under ERISA.

NOTE 5 - INCOME TAX STATUS

The Company adopted a volume submitter plan that has received a favorable opinion letter from the Internal Revenue Service stating that the form of the Plan meets qualification for tax-exempt status. The Company believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE DIRECTED TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements including investments held at January 9, 2023 and December 31, 2022 and net appreciation in fair value of investments, dividends and interest for the period ended January 9, 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Reliance Trust Company, the directed trustee.

NOTE 7 - FAIR VALUE MEASUREMENTS

Accounting guidance establishes a hierarchy which prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value could result in a different fair value measurement at the reporting date.

NOTE 8 - TRANSAMERICA STABLE VALUE FUND

Plan investments in the Transamerica Stable Value Fund are maintained in a general account by Transamerica Life Insurance Company (TLIC) or Transamerica Financial Life Insurance Company (TFLIC). Transamerica is contractually obligated to repay principal and a specified interest rate to the Plan. Because the fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to this fund. Participants may direct the withdrawal or transfer of all or a portion of their investment in the fund at contract value.

Certain restrictions may limit the Plan's ability to redeem its investment in the Fund at contract value, and market value adjustments and/or redemption charges may apply. The plan administrator does not believe that any events limiting the Plan's ability to transact at contract value are probable of occurring. Interest is credited to participant accounts based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six month period. The average yield of the Fund was 1.20% for the year ended December 31, 2022. The Fund balance at January 9, 2023 was zero.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through, October 12, 2023, the date on which the financial statements were available to be issued. There are no material subsequent events that require recognition or additional disclosure in the financial statements.
