Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Hycroft Mining Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 15, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to December 15, 2022 and the related notes to the financial statements.

Note 1 - Plan Description

The following description of Hycroft Mining Corporation 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan established on June 1, 2008. Each covered employee was eligible to become a participant in the Plan immediately upon hire. Employees need not be any particular age or complete any particular amount of service to participate in the Plan. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Hycroft Mining Corporation (the "Company") was the plan sponsor and administered the Plan. Participating employers in the Plan included the Company and its wholly owned subsidiary, Hycroft Resources and Development, Inc. Fidelity Management Trust Company (Fidelity) served as custodian, managed plan assets, and maintained the Plan's records. Fidelity offered plan participants a variety of investment options through various mutual funds. Individual accounts were invested in the various investment options at the direction of the participants.

Contributions

Participants could make before-tax contributions up to 90 percent of their annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage could be reduced by the plan administrator in certain circumstances. Eligible employees who had reached age 50 during the plan year could elect to make catch-up contributions. The Plan also permitted rollover contributions from other qualified retirement plans. Employee contributions to the Plan were made through regular payroll deductions. The Company made a matching contribution of 100 percent of elective deferrals up to 6 percent of eligible compensation. Matching contributions were funded each pay period. The Company had the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions were so designated, they were nonforfeitable and could not be withdrawn from the Plan prior to separation from service or attainment of age 59½.

The Company's contributions totaled \$547,769 for the period from January 1, 2022 to December 15, 2022, all of which were qualified.

Participant Notes Receivable

Participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$100,000 less their highest outstanding principal balance of the loan from the Plan in the last year or 50 percent of their vested account balances. Participants could have a maximum of one loan outstanding at any given time. The notes receivable were secured by the balance in the participant's account. Principal and interest were paid ratably through biweekly payroll deductions. Notes receivable outstanding as of December 15, 2022 were transferred to the successor plan.

Participant Accounts

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and the participant's portion of the Company's contributions and plan earnings or losses, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Participants were immediately fully invested in their salary and rollover contributions, the employer safe harbor matching contributions, and any income or loss thereon.

Note 1 - Plan Description (Continued)

Benefit Payments

On termination of service due to death, disability, or retirement, a participant (or the participant's beneficiary in the case of death) could elect to receive a lump-sum amount equal to the value of the participant's vested account balance. Benefits were recorded when paid.

The Plan allowed in-service distributions and partial distributions, subject to certain restrictions, to participants age 59½ or older who had not terminated employment with the plan sponsor. The Plan also provided for hardship withdrawals for defined hardship events. Furthermore, the Plan allowed for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan. The IRS has required minimum distributions once a participant reaches age 70½ during the previous plan year and is no longer employed by the Company.

Party-in-interest Transactions

Certain plan assets were in investment funds managed by Fidelity or its affiliates. Fidelity was the custodian of the Plan; therefore, these transactions qualified as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Additionally, some investments held by the Plan were invested in the securities of foreign companies, which may involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 2 - Summary of Significant Accounting Policies (Continued)

Subsequent Events

The plan administrator has evaluated all subsequent events through October 16, 2023, which is the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

Note 3 - Plan Merger

During 2022, the Plan merged and combined with the Aon Pooled Employer Plan. Accordingly, all assets, participants, and their related account balances were transferred to the Aon Pooled Employer Plan in 2022.

Note 4 - Certified Information

Fidelity Management Trust Company (the "Custodian") held the Plan's investments and executed all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements are based solely on information certified by the Custodian.

Note 5 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 6 - Fair Value Measurements

Generally accepted accounting principles require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.
