Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of US LBM Holdings, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Note 1 - Description of Plan

The following description of the US LBM Holdings, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full-time employees of US LBM Holdings, LLC (the "Company" or "Plan Sponsor") who have 90 days of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan was amended and restated effective January 1, 2022 for regulatory provisions. The Benefits Steering Committee is responsible for oversight of the Plan and determining the appropriateness of the Plan's investment offerings and monitoring the investments. Reliance Trust Company serves as the trustee of the Plan.

Plan mergers

Historically, the Company has grown in part by way of acquiring existing businesses. As a result, the acquired entities' existing 401(k) plans have been merged into the Plan or terminated. The following plans merged into the Plan during the year ended December 31, 2022. Total participant balances of \$98,713,788 transferred into the Plan. For further information regarding these mergers see Note 7.

Contributions

Each year, participants may contribute up to 100% of pre-tax and post-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Participants may change their investment options at any time. In 2022, the Company made a matching discretionary contribution of up to 2.49% of the participant's eligible compensation. Participants must be employed on the last day of the Plan year to receive the Company's matching contributions. Contributions are subject to the limitations of Internal Revenue Code ("IRC").

Participant accounts

Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with withdrawals and an allocation of Plan losses and administrative expenses

that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants may direct the investment of their contributions and any discretionary match contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant vests 20% per year of service and is 100% vested after five years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through monthly payroll deductions. Loan terms range from 1 month to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2022, participant loans have maturities through 2052 at interest rates ranging from 4.25 percent to 8.00 percent.

Payment of benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments.

Forfeited accounts

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. At December 31, 2022 and 2021, forfeited nonvested accounts totaled \$676,677 and \$263,495, respectively. These accounts will be used to reduce future Company contributions or to offset Plan expenses. In 2022, Company contributions were reduced by \$348,175 from forfeited nonvested accounts.

Note 2 - Summary of accounting policies

Basis of accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will

occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Benefits Steering Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and insurance companies. See Note 3 for discussion of fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are a deduction from net appreciation of fair value of investments.

Payment of Benefits

Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2022.

Subsequent events

The Plan has evaluated subsequent events through October 24, 2023, the date the financial statements were available to be issued.

During January 2023, the SouthEnd Exteriors 401(k) Plan was merged into the Plan subsequent to the Company's acquisition of Professional Builders Supply, LLC, the parent company of SEE Holdings, LLC, dba SouthEnd Exteriors in December 2021. Net assets of \$2,561,535 were transferred into the Plan.

During October 2023, the Foxworth-Galbraith Lumber Company & Associated Companies 401(k) Plan was merged into the Plan subsequent to the Company's acquisition of Foxworth-Galbraith Lumber Company in August 2022. Net assets of \$26,073,029 were transferred into the Plan.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 as compared to 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

For the year ended December 31, 2022, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

Note 4 - Fully benefit-responsive investment contract

The Plan holds an investment contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. Interest is credited, based upon the daily balance, at a rate that is the daily equivalent of the effective annual rate of interest applicable for the six-month period. There is no stated minimum or maximum interest rate. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. Amendments to the Plan document (including complete or partial Plan termination or merger with another plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan.
4. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines.

2. A breach of material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without the consent of the issuer.

Note 5 - Related party transactions and party-in-interest transactions

The Plan invests in an investment contract managed by Transamerica Life Insurance Company (“TLIC”). TLIC is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan also issues loans to participants, which are secured by the vested balances in the participants’ accounts.

Note 6 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company discretionary matching contributions.

Note 7 – Federal income tax status

The Plan uses a prototype plan document sponsored by Retirement Management Services, LLC (“RMS”). RMS received an opinion letter from the Internal Revenue Service (“IRS”), dated March 22, 2021, which states that the prototype document satisfies the applicable provisions of the IRC Section 401(a). The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that the Plan has taken no uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent to December 31, 2021, the Company determined that 15 businesses were acquired during the period August 8, 2014 to September 1, 2021 for which formal resolutions to merge the plans of the acquired companies with the Plan were not adopted. The Company has taken remedial actions under the IRS Voluntary Correction Program to correct the matter through a retroactive amendment to the Plan’s pre-approved adoption agreement. The Company submitted its request to the IRS in November 2022, and as of the date of this report, the Company has not received a response. Subsequent to December 31, 2022, the Company determined that one business acquired during 2022, for which formal resolutions to merge the plans of the acquired business with the Plan was not adopted. The Company has taken remedial actions under the IRS Voluntary Correction Program to correct the matter through a retroactive amendment to the Plan’s pre-approved adoption agreement. The Company is preparing to amend its November 2022 filing under the IRS Voluntary Correction Program.

Note 8 – Certified investment information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor (“DOL”). The following is a summary of the information regarding the Plan as of December 31, 2022 and 2021, and for the year ended December 31, 2022, included in the Plan’s financial statements and supplemental schedules that was prepared by or derived from information prepared by Reliance Trust Company, the trustee of

Note 9 – Nonexempt party-in-interest transactions

As reported on the supplemental Schedule of Delinquent Participant Contributions (Schedule H, Line 4a), during 2021 and 2022, the Plan Sponsor inadvertently failed to deposit \$91,419 and \$1,409,106, respectively, of participant deferrals to the trustee within the time frame specified by the DOL's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Company for the years ended December 31, 2022 and 2021.

The Plan Sponsor remitted the delinquent 2021 and 2022 participant contributions to the trustee during 2022. To remediate these delinquent participant contributions, the impacted participant accounts were credited by an amount representing investment income that would have been earned had the participant contributions been remitted on a timely basis. During 2022, late participant contributions of \$38,672 from 2021 were remediated, resulting in credits to participant accounts. During 2022, late participant contributions of \$52,747 and \$1,409,106, from 2021 and 2022, respectively, were remitted and credits for investment income will be remediated during 2023. The Plan Sponsor believes that these transactions should not impact the tax-qualified status of the Plan.
