### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anuvia Plan Nutrients Corporation 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### 1. Plan Description

The following description of the Anuvia Plan Nutrients Corporation 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) *General* – The Plan is a 401(k) defined contribution plan covering all full-time employees of Anuvia Plant Nutrients Corporation (the "Company") eligible upon the attainment of 21 years of age and 1 month of service, with entry the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").
- b) *Contributions* – Eligible participants are automatically enrolled in the Plan on a pre-tax basis at 4% of eligible compensation (increasing 1% per year to a maximum of 6%) should a deferral election not be made. Each year participants may contribute up to 92% of annual compensation, as defined by the Plan, subject to certain limitation under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit plans or defined contribution plans.

For the years ended December 31, 2022 and 2021, the Company made a matching contribution of 50% of employee deferrals. Matching contributions are discretionary and determined annually.

Additional nonelective amounts may be contributed at the discretion of the Company. No such contributions were made for the year ended December 31, 2022 and 2021, respectively.

Participants direct the investment of their contributions and the Company's contribution into various investment options offered by the Plan. Participants may change their investment options at any time via the telephone or website. Participants who do not select specific investments are invested in accordance with the default investment alternatives established under the Plan.

- c) *Participants Accounts* – Each participant’s account is credited with the participant’s contributions and allocation of (a) the Company’s contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses may be charged based on account balances or charged equally to each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d) *Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s matching contribution and discretionary nonelective contributions is based on years of service, with one year defined as 1,000 hours. A participant is vested 20% when they are hired, 50% after one year, and 100% after two years. Participants are automatically 100% vested if they are employed on or after attainment of normal retirement age or terminated due to death or disability.
- e) *Notes receivable from Participants* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at a reasonable rate, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions, over a term of not more than five years.
- f) *Payment of Benefits* – Upon termination of service, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. The Plan also allows for distributions in the case of hardship, death, disability, or attainment of age 59 ½.
- g) *Forfeited accounts* – Forfeitures of nonvested balances may be used as additional Company discretionary contributions. At December 31, 2022 and 2021 respectively, there were \$531 and \$73,710 of forfeited nonvested accounts of terminated participants.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 or 2021.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023.

### Payment of Benefits

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Subsequent Events**

The Plan has evaluated subsequent events through October 23, 2023, the date the financial statements were available to be issued.

The Plan sponsor ceased operations in May 2023 and the governing body of the Plan sponsor determined to terminate the Plan. As of the date of this report, substantially all assets had been distributed to participants.

## 5. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable

evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds – The Morley Stable Value Fund is a collective investment trust and valued at the net asset value ("NAV") of the units of the trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 6. Risks and Uncertainties

The Plan utilizes various investment instruments, which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### 7. Related Party Transactions

Investment assets of the Plan are held by Reliance Trust Company. JPMorgan is the recordkeeper for the Plan. In 2022, the Plan paid fees of \$4,222 for recordkeeping services.

### 8. Plan Termination

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in Company contributions.

The Plan sponsor ceased operations in May 2023 and the governing body of the Plan sponsor determined to terminate the Plan. As of the date of this report, substantially all assets had been distributed to participants. All participants became fully vested in Company contributions as a result of the plan termination.

## 9. Tax Status

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020 that the Volume Submitter Profit Sharing Plan with CODA is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.
