## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator  
Valley Cash & Carry 401(k) P/S Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Valley Cash & Carry 401(k) P/S Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of May 17, 2023 (in liquidation) and December 31, 2022 (in liquidation), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through May 17, 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from a qualified institution as of May 17, 2023 and December 31, 2022, and for the period from January 1, 2023 through May 17, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosure in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter—Basis of Accounting**

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation in September 2022, and management determined liquidation was imminent. As a result, the Plan's financial statements are presented using the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. **Note 1 - Organization and Description of Plan**

The following description of the Valley Cash & Carry 401(k) P/S Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution 401(k) plan sponsored by Valley Cash & Carry (the Company). All domestic, non-union employees who reach 18 years of age and complete one month of service are eligible to participate in the Plan. The disclosures below are applicable to the Plan prior to the Termination Date.

**Contributions** - Each year, participants may elect to defer and contribute a percentage of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may elect to categorize any portion of their contribution under the Plan's Roth deferral feature. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Each account is credited with the participant's contribution, the Company's contributions, investment income and losses, and administrative expenses, if any. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined in the plan agreement. Participants direct the investment of their account balances to any combination of the Plan's investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Fees related to the administration of certain participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as benefits paid to participants on the basis of the terms of the plan agreement.

**Subsequent Events** - The Plan has evaluated subsequent events through October 10, 2023, which is the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

*Level 1 Fair Value Measurements* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements* - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds and ETFs held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value and to transact at that price. ETFs are transacted at a market price, which fluctuates throughout the day. The funds held by the Plan are deemed to be actively traded.

The Plan's investments at fair value consist solely of mutual funds and ETFs, which are valued as of December 31, 2022 using level 1 measurement.

**Note 4 - Information Certified by Trustee**

Certain information related to investments disclosed in the accompanying financial statements, including investments at May 17, 2023 and December 31, 2022, and net appreciation in fair value of investments and dividends and interest for the period January 1, 2023 through May 17, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by PAi Trust.

**Note 5 - Related-Party and Party-In-Interest Transactions**

Notes receivable from participants held by the Plan are party-in-interest transactions under ERISA. In addition, expenses paid by the Plan are to parties-in-interest as defined by ERISA.

**Note 6 - Tax Status**

The Plan operates under provisions of a prototype plan document which received an opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the Plan, as then designed, complied with the applicable requirements of the Code. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 3 - Fair Value Measurements**

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under GAAP are described as follows:

*Level 1 Fair Value Measurements* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements* - Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**Note 3 - Fair Value Measurements (continued)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Mutual Funds & Exchange-Traded Funds (ETFs)* - Valued at the daily closing price as reported by the fund or stock exchange. Mutual funds and ETFs held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. Mutual funds are required to publish their daily net asset value and to transact at that price. ETFs are transacted at a market price, which fluctuates throughout the day. The funds held by the Plan are deemed to be actively traded.

The Plan's investments at fair value consist solely of mutual funds and ETFs, which are valued as of December 31, 2022 using level 1 measurement.

**Note 4 - Information Certified by Trustee**

Certain information related to investments disclosed in the accompanying financial statements, including investments at May 17, 2023 and December 31, 2022, and net appreciation in fair value of investments and dividends and interest for the period January 1, 2023 through May 17, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by PAi Trust.

**Note 5 - Related-Party and Party-In-Interest Transactions**

Notes receivable from participants held by the Plan are party-in-interest transactions under ERISA. In addition, expenses paid by the Plan are to parties-in-interest as defined by ERISA.

**Note 6 - Tax Status**

The Plan operates under provisions of a prototype plan document which received an opinion letter from the IRS dated June 30, 2020, in which the IRS stated that the Plan, as then designed, complied with the applicable requirements of the Code. The plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.
