INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
Black Veterans for Social Justice, Inc. Profit Sharing Plan

Opinion

We have audited the financial statements of Black Veterans for Social Justice, Inc. Profit Sharing Plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Black Veterans for Social Justice, Inc. Profit Sharing Plan as of December 31, 2022 and 2021, and the changes in its net assets available for benefits for the year ended December 31, 2022, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Black Veterans for Social Justice, Inc. Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Black Veterans for Social Justice, Inc. Profit Sharing Plan's ability to continue as a going concern for one year after the report date. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of Plan

The following description of the Black Veterans for Social Justice, Inc. Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan covering all full-time employees of Black Veterans for Social Justice, Inc. (“Plan Sponsor”) who have one year of service and are age 21 or older.

Contributions. The Plan is an employer contribution plan and employee contributions are not allowable. The contributions are discretionary.

Participant accounts. Each participant’s account is credited with an allocated portion of the employer contribution, plan earnings and losses, forfeitures of terminated participants’ non-vested accounts and reduced by distributions and administrative expenses. Allocations are based on participants’ earnings or account balances, as defined in the Plan agreement.

Vesting. Vesting is based on years of continuing service; 20% after two years, 40% after three years, 60% after four years; 80% after five years and 100% after six years.

Payment of benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum distribution equal to the value of the participant’s vested interest in their account or annual installments over a 10-year period. For termination for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Forfeited accounts. Forfeitures for non-vested contributions may be used to reduce future employer contributions.

2. Summary of Significant Accounting Policies

Basis of Presentation and Use of Estimates - The accompanying financial statements have been prepared on the accrual basis of accounting. In accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains (losses) on investments bought and sold, as well as held during the year.

Payments of benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment-related expenses are netted against the net appreciation (depreciation) of fair value of investments.

3. Investments and Fair Value Measurements

The Plan trustees determine and approve the investment option set up for the Plan. Upon enrollment in the Plan, a participant can direct contributions into various offered investment options. The Plan's assets are held in trust. Actuarial services are provided by Invesco Investments Services, Inc. ("Invesco"), and the investment custodian is Ffriend Enterprises, Ltd., the trustee of the Plan. The trustee invests funds according to participant directions. Currently, the Plan offers various mutual funds.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority,

Level 2 – inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and

Level 3 – inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. All Plan assets are Level 1 inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds – the Plan participant has ownership interest in the mutual fund but not in the individual securities held by the fund. The assets of each mutual fund consist primarily of shares of the underlying holdings. Each mutual fund net asset value ("NAV") is the value of a single share that is actively traded on national securities exchanges. The mutual funds are valued on a daily basis at the close of business day. These funds are valued primarily on the basis of market quotation or on the basis of information furnished by a nationally recognized pricing service based, on observable market data, and are classified as Level 1 within the fair value hierarchy.

For the year ended December 31, 2022, net realized and unrealized losses on investments were \$157,351.

4. Tax Status

The Internal Revenue Service (“IRS”) has determined and informed the Sponsor by letter dated March 11, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Related-Party Transactions and Party in Interest Transactions

Plan investments are managed by Ffriend Enterprises, Ltd. and the trustee of the Plan, in addition to professional fees paid by the Plan and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from prohibited transaction rules by ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Risks and Uncertainties

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

8. Subsequent Events and Legislative Matters

Subsequent events were evaluated through October 12, 2023, which is the date the financial statements were available to be issued. The following matters were determined to be subsequent events requiring disclosure:

In January 2020, Congress passed the Setting Every Community Up for Retirement Enhancement Act (“SECURE Act”) of 2019 that contained significant retirement system reform to reporting and provisions of retirement plans. Many of the provisions of the SECURE Act are effective January 1, 2020 and will require significant changes to plan administration and recordkeeping. As of March 27, 2020, Congress passed the Coronavirus Aid, Relief, and Economic Security Act (“CARES Act”) that included numerous employee benefit plan provisions to assist plan sponsors and participants.

In 2022, the Consolidated Appropriations Act, 2023, included the SECURE 2.0 Act of 2022 (“SECURE 2.0”). SECURE 2.0 expands on and, in some cases, modifies changes to the laws governing retirement plans brought about by the Setting Every Community Up for Retirement Act of 2018 (the “2019 SECURE Act”). Key provisions of SECURE 2.0 that amend the Employee Retirement Income Security Act (“ERISA”) and Internal Revenue Code (the “Code”) include mandatory automatic enrollment and escalation feature for new Section 401(k) and 403(b) plans starting in 2025, an expansion of the Internal Revenue Service (“IRS”) Employee Plans Compliance Resolution System, and other various provisions. Plan amendments under SECURE 2.0 are generally required by the last day of the first plan year beginning on or after January 1, 2025 for single-employer plans. SECURE 2.0 also directs the DOL and IRS to issue various new regulations in accordance with its provisions. The provisions are effective for plan years beginning after December 31, 2022 through 2025. Management is evaluating the impact of the SECURE 2.0 Act.

9. Form 5500 and Incomplete Filings

The Plan had incomplete filing of its Form 5500 for the year ended 2019 and has filed its Form 5500 for years ended 2020 and 2021, however, the filings have yet to be processed and approved by the DOL. The incomplete filing for 2019 relate to the Plan not including the Plan’s annual audit as an attachment to Form 5500. The Plan is subject to penalties by the U.S. Department of Labor and the Internal Revenue Service for the incomplete filings. The Plan is currently in the process of curing the incomplete filings and believe the penalties, if assessed, could be waived or abated due to reasonable cause.
