INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
St. Vincent's Home, Inc. 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Vincent's Home, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of April 4, 2023 (in liquidation), the related statement of changes in net assets available for benefits for the period ended April 4, 2023 (in liquidation) and July 31, 2022 (ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of April 4, 2023, and July 31, 2022 and for the period ended April 4, 2023, stating that the certified investment information, as described in the note titled "Information Prepared and Certified by Custodian" included in the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of St. Vincent's Home, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in the note titled "Plan Termination" included in the financial statements, the governing body of St. Vincent's Home, Inc. 401(k) Plan approved a plan of liquidation on October 10, 2022, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the July 31, 2022 financial statements to the liquidation basis used in presenting the April 4, 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN:

The following description of St. Vincent's Home, Inc. (the "Organization") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

Prior to termination, the Plan was a defined contribution plan covering all employees of the Organization who have 90 days of service and are age twenty-one or older. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Organization's Board of Directors oversees governance of the Plan.

Contributions

Participant Contributions: Prior to termination, Plan participants could elect to contribute up to 100% of their eligible compensation, not to exceed the allowable amount under Section 402(g) of the Internal Revenue Code. Participants could designate their contributions as a pre-tax deferral or on an after-tax basis ("Roth contribution"). Contributions were based upon total eligible compensation, which included all compensation that is paid for or made available during the Plan period/year, excluding any compensation received prior to the date of becoming a participant. Participant's contributions were made through automatic payroll deductions every pay period. Pre-tax deferral contributions and related earnings were not taxable to the participant until they were withdrawn from the Plan. Roth contributions and related earnings were not taxed upon distribution from the Plan.

Rollovers: Prior to termination, participants who were members of a former employer's qualified plan could elect to make a rollover contribution from that plan to the Plan.

Employer Contributions: Prior to termination, the Organization could make annual discretionary matching and/or profit-sharing contributions in an amount determined by the Organization's Board of Directors. These discretionary contributions were allocated following the end of the Plan period/year to all participants eligible to share therein. The Organization did not make a matching and/or profit-sharing contribution to the Plan for the period ended April 4, 2023.

Participant Accounts

Prior to termination, each participant's account was credited with the participant's contribution and allocations of the Organization's contribution, Plan earnings (losses), and charged administrative expenses for certain transactions. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Prior to termination, participants were immediately vested in their contributions, rollovers, plus actual earnings thereon. Vesting in the Organization's matching and/or profit-sharing contributions plus actual earnings thereon was based on years of continuous service. A participant was 100% vested after five years of credited service. Regardless of the vesting schedule, a Participant became fully vested upon death or permanent disability occurring prior to termination of employment.

1. DESCRIPTION OF PLAN - (Continued):

Investment Options

Prior to termination, a participant could direct contributions to a variety of investment funds.

Payment of Benefits

Prior to termination, the Plan was designed to provide participants with benefits at the time of retirement. However, if employment with the Organization was terminated, the balance of a participant's vested Plan accounts became distributable to them. Upon proper notification of the Plan Administrator, the account balance was distributed to the participant in the form of a lump-sum cash payment. The participant could also request a rollover distribution as soon as practicable after separation from service.

Prior to termination, the normal retirement age for the Plan was 65. Participants could continue employment and participation in the Plan past the normal retirement age. In-service distributions were allowed for participants who had reached age 59 ½.

Prior to termination, a participant, under certain hardship conditions, could elect to receive a distribution before the participant was terminated or attained age 59 ½ up to the total of their participant contributions and the earnings generated on those contributions.

Forfeited Accounts

Prior to termination, nonvested benefits of participants who were terminated were forfeited and used to reduce employer contributions. During the period ended April 4, 2023, no balances were forfeited. There were no forfeited nonvested accounts as of April 4, 2023 and July 31, 2022.

Participants' Notes Receivable

Prior to termination, the Plan did not allow participant notes receivable.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

The following accounting policies, which conform to accounting principles generally accepted in the United States of America ("U.S. GAAP"), have been applied consistently in the preparation of the Plan's financial statements:

Basis of Accounting

The April 4, 2023 financial statements of the Plan are prepared using the liquidation basis of accounting. The comparative July 31, 2022 statement of net assets available for benefits is presented using the ongoing basis of accounting.

Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates used in preparing these financial statements include the fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (Continued):

Investment Valuation and Income Recognition

Prior to termination, investments held by the Plan were stated at fair value except for the group annuity contract which was treated as a fully benefit-responsive investment contract and stated at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Contract value reflects the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts. See the note titled "Fair Value Measurements" for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Prior to termination, benefits were recorded when paid.

Operating Expenses

Prior to termination, benefit distribution fees were paid by the participant receiving the distribution. Any remaining expenses were paid by the Organization and are therefore excluded from these financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN:

Prior to termination, all assets were held and invested by the Principal Trust Company (the "Custodian"). The Custodian also received and held all income from the investments. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Custodian as of April 4, 2023 and July 31, 2022 and for the period ended April 4, 2023:

4. FAIR VALUE MEASUREMENTS:

The Plan's investments in registered investment companies, common collective trusts, and pooled separate accounts are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The following is a description of the valuation methodologies used for assets measured at fair value:

Registered Investment Companies – Shares of registered investment companies (mutual funds) are valued at quoted market prices on the last business day of the period, which represents the fair market value of shares held by the Plan.

Common Collective Trusts – Investments in common collective trusts are valued at the net asset value ("NAV") as determined by using estimated fair value of the underlying assets held in the fund as reported by the investment manager of the trust.

Pooled Separate Accounts – Investments in pooled separate accounts are valued at the NAV of shares held by the Plan at period end as reported by the fund managers.

5. INVESTMENTS IN GROUP ANNUITY CONTRACT:

Prior to termination, the group annuity contract (the “Contract”) was a fully benefit-responsive investment with the Custodian, and is reported at contract value in the statements of net assets available for benefits. Benefit responsiveness is defined as the extent to which a contract’s terms and the Plan permit or require participant-initiated withdrawals at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

The Custodian maintained contributions in a general account. The contractual guarantees were backed up by the full faith and credit of the Custodian, the contract issuer. The Custodian was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. Crediting interest rates were reset semiannually. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

The Contract did not specify any events that would limit the ability of the Plan to transact at contract value with the issuer or any events that would allow the issuer to terminate the contract and settle for an amount different from contract value. The Contract provided various payment options for surrendering the Contract at contract value.

6. INCOME TAX STATUS:

Prior to termination, the Plan adopted a prototype plan sponsored by Brown Edwards & Company LLP. The IRS determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust were designed in accordance with applicable sections of the Internal Revenue Code ("IRC").

U.S. GAAP requires the Plan Administrator to evaluate income tax positions taken by the Plan and recognize an income tax liability for any uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by income tax authorities; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2019.

7. PLAN TERMINATION:

On October 10, 2022, the Organization announced its intention to merge with the Virginia Institute of Autism ("VIA") effective January 1, 2023. As part of the merger, the Organization will terminate the Plan. Plan participants affected by the merger were allowed to (a) rollover their balance to a plan sponsored by VIA, (b) rollover their balance to an Individual Retirement Account, or (c) receive a lump-sum cash distribution. In accordance with Plan provisions, all participants were 100% vested in the assets of the Plan as of January 1, 2023. All Plan assets were distributed to participants by April 4, 2023. The comparative July 31, 2022 information is presented and prepared using the ongoing basis of U.S. GAAP.

8. RELATED PARTY TRANSACTIONS:

Prior to termination, certain administrative functions were performed by officers or employees of the Organization. These employees were also Plan participants. No such officer or employee received compensation from the Plan.

Plan investments were managed by the Custodian and the Plan used the Custodian to administer the Plan. These transactions qualified as party-in-interest. Administrative fees paid by the Plan to the Custodian amounted to \$4,364 for the period ended April 4, 2023.

10. SUBSEQUENT EVENTS:

The Plan has evaluated all subsequent events through September 7, 2023, the date the financial statements were available to be issued.


