NOTE 1 - DESCRIPTION OF PLAN

The following description of the Diamond Rental, LLC. (the Sponsor) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- A. General - Prior to termination, the Plan was a defined contribution plan covering eligible employees of the Sponsor who had completed six months of service and had attained age eighteen or older. It was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- B. Contributions - Each year, participants could contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Service (IRS) maximum deferral limitations. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various mutual funds and an insurance investment contract as investment options for participants. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan, unless they affirmatively elected not to participate, with a default deferral rate set at 5% of eligible compensation. Contributions were automatically invested in a designated balance fund until changed by the participant. The Sponsor made matching contributions of 33% of the first 7% of base compensation that a participant contributed to the Plan. The Sponsor could make discretionary profit sharing contributions at the option of the Sponsor's Board of Directors.
- C. Participant Accounts - Each participant's account was credited with the participant's contributions and allocations of (a) the Sponsor's contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.
- D. Vesting - Participants were immediately vested in their contributions plus actual earnings thereon. A participant was 100% vested in the Sponsor's matching contributions after three years of credited services. Vesting in the portion of their accounts attributable to profit sharing contributions was as follows:

- E. Payment of Benefits - On termination of service due to death, disability, or retirement, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments over a period not to exceed the assumed life expectancy of the participant. For termination of service due to other reasons, a participant could receive the value of the vested interest in his or her account as a lump-sum distribution.
- F. Notes Receivable from Participants - Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing rates as determined by the plan administrator.
- G. Forfeited Accounts - At August 15, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$8,215 respectively. These accounts could be used to reduce future employer contributions.
- H. Administrative Expenses - Certain administrative expenses incidental to the administration of the Plan, including fees paid to the recordkeeper and financial advisors, were paid by the Sponsor. Expenses not paid by the Sponsor were paid by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's 2022 financial statements are presented on the liquidation basis of accounting, and the Plan's 2021 financial statements are presented on the accrual basis of accounting, both of which are in accordance with generally accepted accounting principles.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Subsequent Events

Management of the Plan has evaluated subsequent events through October 16, 2023, which is also the date the financial statements were available to be issued. No subsequent events were noted during this evaluation that require recognition or disclosure in these financial statements.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is defined as the amount that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The following hierarchy prioritizes the inputs to valuation methodologies used to measure fair value:

- Level 1 inputs, which have the highest priority, are quoted prices for identical assets in active markets.
- Level 2 inputs are observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets in active markets or quoted prices for identical or similar assets in markets that are not active.
- Level 3 inputs, which have the lowest priority, are unobservable inputs that reflect the Plan's own assumptions, consistent with reasonably available assumptions made by other market participants.

Investment Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefits are recorded when paid.

NOTE 5 - INCOME TAX STATUS

The IRS has determined and informed the Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan was designed and operated in accordance with the requirements to qualify for tax-exempt status.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invested in various securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 - PLAN TERMINATION

Management terminated and liquidated the Plan as of August 15, 2022. Remaining participants became 100% vested in their employer contributions as of that date in accordance with the provisions of the Plan agreement and remaining assets and accounts were transferred out of the Plan.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Great-West was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$11,756 for the period from January 1, 2022 to August 15, 2022 (liquidation).

The above party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.
