INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
Therapeutics MD 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2022 Financial Statements

We have performed an audit of the accompanying financial statements of Therapeutics MD 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2022, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements ("2022 Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2022 Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022, stating that the certified investment information, as described in Note C to the 2022 Financial Statements, is complete and accurate.

Opinion on the 2022 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2022 Financial Statements section—

- the amounts and disclosures in the accompanying 2022 Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying 2022 Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2022 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

December 31, 2022 and 2021

NOTE A--DESCRIPTION OF PLAN

The following description of the Therapeutics MD 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, effective February 1, 2019, covering substantially all employees of vitaMedMD, LLC (the "Company", "Employer" or "Plan Sponsor"). Employees who are eligible to participate must be of age 21, have completed 3 months of service and not be excluded under the terms of the Plan Document. Effective July 1, 2022, the Plan Document was restated to bring the Plan into compliance with legislative and regulatory changes. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

On April 14, 2022, a divestiture of a non-core asset which included employees of the Company was sold to an unrelated third-party. Employees working for the divestiture, became employees of the unrelated third-party and were no longer eligible to contribute to the Plan as of the date of sale. Account balances of those effected participants were transferred to the unrelated third-party's 401(k) Plan. Total balances, including loans, transferred out amounted to approximately \$595,000 for the year ended December 31, 2022.

Partial Plan Termination: On December 4, 2022, the Company entered into an agreement which changed its business to become a pharmaceutical royalty company. As a result of the Company's transformation into a pharmaceutical royalty company, the Company terminated substantially all of its employees with the exception of certain executives. As a result of the workforce reduction, the Plan experienced a partial plan termination. Under the terms of the Plan Document, as required by IRS ("Internal Revenue Service") regulations, affected employees whose employment terminated in December 2022 became fully vested in their discretionary employer matching contributions and discretionary profit-sharing contributions.

Plan Termination: On March 30, 2023, the Board of Directors of the Plan Sponsor voted to terminate the Plan effective April 28, 2023, and to distribute Plan assets as soon as administratively practicable after receipt of an IRS determination letter on the Plan's termination. All Plan assets were distributed by August 22, 2023.

Plan Administration: Reliance Trust Company ("Reliance") is the Plan Trustee and ADP Retirement Services ("ADP") is the record-keeper and third-party administrator.

NOTE A--DESCRIPTION OF PLAN--Continued

Elective Deferrals and Contributions: Each year, participants may elect to have the Company contribute up to 65% of annual compensation as pre-tax or Roth contributions (and up to 90% of eligible bonus compensation), subject to certain limitations as defined in the Plan Document. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan Document. Under provisions of the Plan Document, the Company may make discretionary matching contributions. During 2022 and 2021, the Company contributed 100% of the first 4% of base compensation that a participant contributed to the Plan, up to a maximum of \$2,000.

Participant Accounts: Each participant's account is credited with the participant's elective deferrals and allocations of (a) the Company's matching contribution and (b) investment earnings and losses and charged with an allocation of administrative expenses if the expenses are not paid by the Company. Allocations are based on participant earnings or account balances, as defined by the Plan Documents. Certain minimum service hour requirements must be met for employees to be entitled to allocations of Company matching contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All Plan investments are participant directed.

Vesting: Participants' contributions and rollover contributions plus actual earnings are 100% vested immediately. Employer contributions are subject to the following vesting schedule:

Investment Options: Upon enrollment in the Plan, a participant may direct elective deferrals in any of the investment options offered by the Plan. Participants may change their investment options at their discretion. As of December 31, 2022 and 2021, the Plan offers investments in mutual funds.

NOTE A--DESCRIPTION OF PLAN--Continued

Notes Receivable from Participants: Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 0-5 years. If the purpose of the loan is to acquire or construct the primary residence of the Participant, the period of repayment may exceed five years, but may not be greater than 30 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved. Interest rates on participant loans outstanding at December 31, 2022 and 2021 range from 4.25% to 7.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits: On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial payment. The normal retirement age is 65 years. A participant may also receive a distribution if they experience undue financial hardship as further defined in the Plan Document and in accordance with the Internal Revenue Code ("IRC"). For events qualifying under certain "hardship" rules as prescribed by the IRS, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeited Accounts: Forfeitures are created when participants terminate employment prior to becoming entitled to full benefits. Forfeitures of non-vested employer matching contributions can be used by the Company to reduce future employer matching contributions and pay Plan expenses.

Approximately \$158,000 of forfeited non-vested accounts were generated during the year ended December 31, 2022. Approximately \$110,000 of forfeitures were used by the Company during 2022 to offset employer contributions and Plan expenses (See Note H). At December 31, 2022, and 2021, there were approximately \$51,000 and \$4,000, respectively, of unused forfeitures remaining in the Plan.

Expenses Paid by the Company: Administrative Plan related expenses, such as professional fees, amounting to approximately \$18,000 were paid by the Company in 2022 on behalf of the Plan.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions and deductions. Significant estimates include the determination of fair value of certain investments of the Plan. Actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment earnings or losses and interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation in fair value of investments includes the Plan's net gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees for the administration of loans are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor as noted in Note A and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other administrative transaction fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--Continued

Risks and Uncertainties: The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

Subsequent Events: The Plan's management has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2023, the date the financial statements were available to be issued.

NOTE C--INFORMATION CERTIFIED BY THE TRUSTEE

Information disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2022 and 2021, and net depreciation in fair value of investments, dividends and interest income for the year ended December 31, 2022, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the Trustee.

NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy in accordance with GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

NOTE D--FAIR VALUE MEASUREMENTS--Continued

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2022 and 2021. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission (the "SEC"). These funds are required to publish their daily Net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE E--PARTY-IN-INTEREST TRANSACTIONS

ADP is the Plan's third-party administrator and provides certain recordkeeping and other services to the Plan. Transactions with ADP qualify as party-in-interest transactions. Certain Plan investments are shares of mutual funds managed by Reliance. Reliance is the trustee, as defined by the Plan, and therefore, transactions with Reliance qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net depreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan pays certain expenses related to the Plan's operations and investment activity to other various service providers. The Company pays directly any other fees related to the Plan's operations.

NOTE F--TAX STATUS

The Plan is a prototype 401(k) profit sharing plan that received an IRS determination letter dated October 6, 2020, for such prototype plan and related trust, as then designed, was in compliance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan and its amendments is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore, the Plan is qualified and is tax-exempt.

GAAP requires Plan Management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's tax returns for the years ended December 31, 2019, 2020 and 2021 remain subject to examination.

NOTE G--CONCENTRATIONS

At December 31, 2022, approximately 49% of the Plan's investments were invested in four funds. At December 31, 2021, approximately 38% of the Plan's investments were invested in three funds.

NOTE H--SUBSEQUENT EVENTS

On March 30, 2023, the Board of Directors of the Plan Sponsor voted to terminate the Plan effective on April 28, 2023, and to distribute Plan assets as soon as administratively practicable after receipt of an IRS determination letter on the Plan's termination. All Plan assets were distributed by August 22, 2023.

During 2023, the Company determined that the Plan improperly received forfeitures from participants who became fully vested in their discretionary employer matching and discretionary profit-sharing contributions, as a result of the partial plan termination that occurred on December 30, 2022. These improper forfeiture amounts totaled approximately \$54,000 and were subsequently corrected and returned to the participants before the Plan termination date on April 28, 2023.
