Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Siege Media 401(k), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to June 30, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of June 30, 2022 and December 31, 2021, and for period from January 1, 2022 to June 30, 2022, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter - Plan Merger

As described in Note 1 to the financial statements, Plan management made the decision to merge the Siege Media 401(k) Plan into the Insuperity 401(k) Plan effective June 30, 2022. As a result, all investments were transferred from the Plan into Insuperity 401(k) Plan on that date. Our opinion is not modified with respect to this matter.

Report on the Compilation of the 2021 Financial Statements

Plan management is responsible for the accompanying financial statement of Siege Media 401(k), which comprises the statement of net assets available for benefits as of December 31, 2021, and the related notes to the financial statement in accordance with accounting principles generally accepted in the United States of America. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by plan management. Accordingly, we do not express an opinion, a conclusion, or provide any form of assurance on the financial statement.

NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2022 AND DECEMBER 31, 2021

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Siege Media 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering substantially all employees of Siege Media, LLC (the "Company" or "Employer"). The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Merger: The Company, as permitted by the Plan document, made the decision to merge the Siege Media 401(k) Plan into the Insuperity 401(k) Plan effective June 30, 2022. As a result, the Company transferred the Plan assets to the Insuperity 401(k) Plan on June 30, 2022, as reflected in the transfer of Plan assets due to merger on the accompanying statement of changes in net assets available for benefits.

Administration: The Plan is administered by the Company.

Eligibility: An employee must have been at least 21 years of age to become a participant in the Plan. Residents of Puerto Rico and nonresident aliens with no income from a U.S. source were not eligible to participate in the Plan. Employees could enter the Plan on the first day of the month following completion of the service requirement.

Contributions: Prior to the termination of the Plan, eligible participants could make voluntary pre-tax or after-tax (Roth) contributions, by means of a salary deferral agreement of up to 90% of their compensation, subject to IRS limitations for the Plan year. Plan participants over the age of 50 were also permitted to make additional pre-tax and Roth catch-up contributions to a maximum of \$6,500 in 2022. The Plan also permitted rollover contributions from other qualified pre-tax retirement plans. Participants directed the investment of contributions into various investment options offered by the Plan. The Company matched 50% of the first 6% of employee deferrals. Additionally, the Company could make discretionary profit sharing contributions.

Participant accounts: Each participant's account was credited with the participant's contributions and an allocation of (a) the employer contributions, if any, and (b) plan earnings, and was charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants were immediately vested in their voluntary contributions, employer matching contributions, and discretionary profit-sharing contributions, plus actual earnings thereon.

Participant notes receivable: The Plan allowed participants to obtain loans from the Plan. Loans were subject to the following general provisions: the maximum amount of loans outstanding was equal to the lesser of \$50,000 or 50% of the participant's account balance with a minimum of \$1,000, the term of any loan could not exceed five years unless the purpose of the loan was to purchase the participant's primary residence, in which case the loan was limited to a term of 10 years. The loans were secured by the participant's entire account balance. The interest rate for each loan was based on the bank's prime lending rate on the loan issuance date, plus 2%. Principal and interest was paid ratably through biweekly payroll deductions.

If a participant did not make loan repayments and the plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of benefits: Upon termination of service due to death, disability, retirement, or other reasons, a participant could elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, payment in substantially equal installments, or partial withdrawals, provided the minimum withdrawal was \$500. For termination of service due to other reasons, if a participant's account was less than \$5,000, the balance will automatically be rolled into an individual retirement account. Actively employed participants could have begun receiving distributions of pre-tax contributions at age 59½. In the case of hardship, a participant could have applied for a distribution as described in the Plan agreement.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates: The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Participant notes receivable: Participant notes receivable are recorded at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes receivable are written off when deemed uncollectible.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See Note 3, *Fair Value Measurements*, for discussion of fair value measurements.

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded when earned, and dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit payments: Benefit payments to participants are recorded when paid.

Administrative expenses: Substantially all administrative expenses of the Plan are paid by Company, unless otherwise paid for by the Plan, and are included in the statement of changes in net assets available for benefits.

Subsequent events: In preparing the financial statements, management has evaluated events and transactions for potential recognition or disclosure through October 5, 2023, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- a) Quoted prices for similar assets or liabilities in active markets;
- b) Quoted prices for identical or similar assets or liabilities in inactive markets;
- c) Inputs other than quoted prices that are observable for the asset or liability;
- d) Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2021.

1. **Mutual funds (Registered Investment Companies):** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively-traded.

2. *Investments measured at net asset value*: A common/collective trust stable value fund which is composed primarily of fully benefit-responsive investment contracts. This fund is valued at the net asset value of units of the common/collective trust. The net asset value as provided by the trustee is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments relating to this type of investment.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

NOTE 4 – INCOME TAX STATUS

The Plan, as adopted, is a non-standardized pre-approve profit sharing plan, which does not require an application for a determination letter from the Internal Revenue Service ("IRS"). The non-standardized pre-approve profit sharing plan has received a favorable notification letter from the IRS dated October 6, 2020. The Plan has not individually sought its own determination letter.

NOTE 5 – INFORMATION CERTIFIED BY TRUSTEE

In accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected to restrict the scope of the auditors’ examination with regards to statements or information prepared and certified by Reliance Trust Company. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by Reliance Trust Company, the trustee:

NOTE 7 – RISKS AND UNCERTAINTIES

The participants directed the Plan to invest in various investment securities. Investment securities were exposed to various risks such as interest rate, market value fluctuation, and credit risk. Changes in the values of investment securities occurred on a daily basis and such changes could have materially affected the amounts reported in the statements of net assets available for benefits.
