I am writing to you on behalf of Beacon Container Corporation (the “Debtor”).

I am attaching this letter to the 2023 Form 5500 for the Beacon Container Corporation 401(k) Savings Plan (the “Plan”). This letter is in lieu of an Independent Qualified Public Accountant’s (“IQPA Report”) and its purpose is to explain why there is no IQPA Report attached to the Form 5500.

On June 12, 2023, the Beacon Container Corporation (the “Plan Sponsor”) filed a voluntary petition for protection under Chapter 7 of the United States Bankruptcy Code and a Chapter 7 Trustee was appointed. (“Chapter 7 Trustee”).

Prior to the bankruptcy, all of the Debtor’s assets were encumbered by its bank as security for the bank’s loans to the Debtor and the bank had control over the Debtor’s cash under the covenants in the bank’s loan documents. On February 6, 2023, the Debtor’s bank shut down the Debtor’s operations and most of its workforce was laid off. The bank refused to release funds to pay for, among other things, the annual IQPA Report for 2022. The Debtor filed for bankruptcy to manage the foreclosure by the bank. Since the Debtor’s workforce was terminated, all of the benefits from the 401(k) Plan were distributed to participants in May of 2023, prior to the bankruptcy filing.

On August 22, 2023, the Chapter 7 Trustee reported to the Court that the bankruptcy was a no asset case due to the encumbrance by the bank and he sought discharge as trustee and the closing of the bankruptcy case. On August 25, 2023, the Court discharged the Chapter 7 Trustee and closed the bankruptcy case. Accordingly, the Debtor is no longer under the control of the Bankruptcy Court and the Chapter 7 Trustee. A copy of the Docket Sheet from the Court is

attached for your information. However, all of the Debtor's assets were foreclosed upon by the bank.

Notwithstanding the dismissal of the Bankruptcy case, all of the assets of the Debtor are now under the control of its secured creditor, the bank. The bank refuses to release any of its collateral to pay for any other obligations of the Debtor.

An audit is required for 2023 because on January 1, 2023, there were 110 participants in the Plan with account balances.

This audits would be required as part of the Plan's wrap up. Plan audits cost from \$20,000 to \$30,000 per year. As previously mentioned, all of the benefits in the Plan were distributed to the participants (or rolled over to cash out IRAs) prior to the bankruptcy. There was only \$2,873,151 in the Plan as of December 31, 2022. Thus, there are no funds in the Plan to pay for an audit. All of the Debtor's assets have been foreclosed on by the bank and it has no assets to pay for the IQPA Report.

This Plan has been appropriately administered by a regional professional recordkeeper that has been in the business for 47 years. The Plan covered union employees and was the subject of collective bargaining. All employee deferrals have been timely contributed to the Plan.

Accordingly, we request that the attached 2023 Form 5500 for the Beacon Container Corporation 401(k) Savings Plan be accepted as filed without the Opinion of an Independent Qualified Public Accountant.
