To the Plan Administrator and Participants of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the financial statements of Global Linguist Solutions 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of October 3, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 through October 3, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Global Linguist Solutions 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of October 3, 2022 and December 31, 2021, and for the period from January 1, 2022 through October 3, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

#### 1. DESCRIPTION OF PLAN

##### **General**

Global Linguist Solutions 401(k) Plan (the "Plan") was established as of January 1, 2015. It was a defined contribution plan, established in accordance with the provisions of the Internal Revenue Code ("IRC"). The Plan, sponsored by Global Linguist Solutions (the Plan "Sponsor" or "Company") was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The purpose of the Plan was to enable eligible employees to save for retirement. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Company was acquired by Amentum Services, Inc. effective July 30, 2021, and as a result the Company elected to freeze participation in the Plan, and Amentum Services, Inc. became the new plan sponsor. All active participants who became employees of Amentum Services, Inc. became eligible to participate in the Amentum 401(k) Retirement Plan ("Amentum Plan").

##### **Plan Merger**

The Plan was merged into an affiliated plan, the Amentum 401(k) Retirement Plan ("Amentum Plan") effective on October 3, 2022. As of October 3, 2022, \$6,979,744 of Plan assets were transferred to the Amentum Plan.

##### **Administration of the Plan**

The Plan Administrator was responsible for oversight of the Plan and providing the participants and their beneficiaries with information about their rights and benefits under the Plan. Plan management determined the appropriateness of the Plan's investment offerings and monitored investment performance.

##### **Eligibility**

The Plan covered all eligible employees of the Company except union employees and interns. Prior to July 30, 2021, employees who were twenty-one years of age or older could enter the Plan after completion of two month of service.

##### **Contributions**

Prior to July 30, 2021, participants could contribute to the Plan a percentage of their annual pre-tax compensation, up to the maximum allowed by the Internal Revenue Service ("IRS") of \$19,500 in 2021. Certain eligible participants (age 50 and older) could contribute additional catch-up contributions. Participants could also contribute after-tax Roth contributions and amounts representing distributions from other qualified defined benefit or contribution plans.

Prior to July 30, 2021, the Company could provide a matching contribution of a discretionary percentage of the employee deferrals as determined by the Company each year and could make a discretionary profit-sharing contribution.

##### **Investment Options**

Participants directed the investment of their contributions and employer contributions into the investment options offered by the Plan. Participants could change their investment options at any time.

**Notes Receivable from Participants**

Prior to July 30, 2021, participants were allowed to borrow a minimum of \$1,000 and up to a maximum of the lesser of 50% of their vested balance or \$50,000. Participants were allowed to have one loan outstanding at a time. The loans bore interest at rates which were commensurate with similar types of loans by other lenders. Principal and interest were paid ratably through after-tax payroll deductions. The maximum repayment period was five years with the exception of loans to purchase a primary residence which can have a longer repayment period. The interest rates on outstanding loans ranged from 4.25% to 6.50% as of December 31, 2021, with maturities ranging from 2022 to 2026.

**Vesting**

Participants were vested immediately in their salary deferrals, including Roth deferrals, rollover contributions, and catch-up contributions. Prior to July 30, 2021, the Company contributions vested according to the following:

Upon death, disability or normal retirement, participants become 100% vested in all employer contributions.

**Forfeited Accounts**

Forfeitures of nonvested employer contributions of terminated participants could be used to reduce employer contributions or to pay administrative expenses of the Plan. During the period from January 1, 2022, through October 3, 2022, \$156 of forfeitures were used to pay Plan expenses, and the forfeiture balances at October 3, 2022 and December 31, 2021 were \$0 and \$7,172, respectively.

**Payment of Benefits**

Upon termination of employment, death, retirement, or disability, a participant or his or her beneficiary was entitled to receive the vested amount allocated to the participant's account as a lump sum. If the value of a participant's vested benefit was \$1,000 or less, the balance would be distributed automatically to the participant. In-service withdrawals were permitted for participants who had attained the age of 59½ years or for financial hardship.

**Administrative Expenses**

Certain investment related expenses have been offset with net depreciation in fair value of investments and were not readily determinable. Administrative expenses of the Plan were generally paid by the Company or by the Plan. The Plan paid expenses of approximately \$80,252 for the period from January 1, 2022, through October 3, 2022.

**Participant Accounts**

Each participant's account was credited with the participant's contributions, their respective share of the Company's contributions and Plan earnings and was charged with an allocation of administrative expenses and Plan losses, and the participant's distributions, if any. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosures of contingent assets and liabilities, and additions and deductions to net assets available for benefits as of the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded when earned. Net depreciation in fair value of investments represents both realized and unrealized gains and losses on assets bought and sold during the year, as well as held at the end of the year.

**Notes Receivable from Participants**

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses was recorded as of December 31, 2021.

**Payment of Benefits**

Benefits paid to Plan participants are recorded when paid.

**Subsequent Events**

Plan management has evaluated subsequent events through October 10, 2023, the date which the financial statements were available to be issued. Based upon this evaluation, the Plan has determined that no subsequent events have occurred which require adjustment to or disclosure in the financial statements.

**3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS**

No auditing procedures were performed by the independent public accountants as permitted by 29 CFR 2520.103-8 with respect to information certified as complete and accurate by Empower Annuity Insurance Company and Empower Trust Company, LLC, the Plan custodians, except for comparing such information with the related information included in the financial statements. Based on the information provided and certified by the custodians, there are no fixed income obligations, leases, or debt instruments in default or deemed uncollectible, as defined by ERISA, as of October 3, 2022, and December 31, 2021.

- Net depreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the period from January 1, 2022 through October 3, 2022.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology:

*Mutual Funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange-Traded Funds:* Valued at the daily closing price on a national stock exchange, which may or may not be the same as the NAV of the shares. The funds held by the Plan are registered with the Securities and Exchange Commission and are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investment assets measured at fair value as of December 31, 2021, and up until the date of the merger, as noted in Note 1, were comprised of mutual funds and exchange-traded funds and were valued using Level 1 inputs.

#### **5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

At December 31, 2021, and until the date of merger, as noted in Note 1, the Plan had a fully benefit-responsive investment contract in the form of a group annuity contract with Great-West Life & Annuity Insurance Company that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund was a general account product. The group annuity contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Contract value was the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The insurance company was contractually obligated to pay the principal and specified interest rate that was guaranteed to the Plan. The crediting interest rate was based on a formula agreed upon with the insurance company but may not be less than zero percent. Such interest rates were reviewed on a quarterly basis for resetting. The crediting rate of the product was established based on the earnings of the underlying assets in the entire medium-long term portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions.

The Plan's ability to receive amounts due in accordance with the group annuity contract was dependent on the insurance company's ability to meet its financial obligations. The insurance company's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limited the Plan's ability to transact at contract value. Such events included the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The insurance company may not terminate the contract at any amount less than contract value. When the Plan merged into the Amentum Plan, participant balances that were invested in the Key Guaranteed Portfolio Fund were transferred at contract value.

#### **6. PARTY-IN-INTEREST TRANSACTIONS**

At December 31, 2021, and during the period from January 1, 2022 through October 3, 2022, certain Plan investments were issued and/or managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, who also acts as the custodians of the Plan. Certain investment transactions and balances are considered to be transactions with a party-in-interest. Fees paid by the Plan to the custodians are also considered to be party-in-interest transactions. Notes receivable from participants also represent party-in-interest transactions.

**7. TAX STATUS**

The Plan adopted the non-standardized prototype profit sharing plan of Great-West Trust Company, LLC for which the IRS determined and informed the sponsoring organization by a letter dated June 30, 2020, that the Plan and related trust are designed in compliance with applicable sections of the IRC, and that employers adopting the non-standardized prototype profit sharing plan could rely on such determination. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes the Plan was designed and was operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Plan management has evaluated tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of October 3, 2022, and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Furthermore, there are no tax related interest or penalties for the periods presented in these financial statements.

**8. RISKS AND UNCERTAINTIES**

The Plan invests in investments securities, which are exposed to various risks such as interest rate, overall market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that the changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.
