Dear Mr. Albert or other representative for your Office,

On behalf of Orion Development Group, I hereby request the Department of Labor waive any penalties or fees arising from our late filing of 5500 forms for the years 2021 and 2022.

For many years, Orion paid a third-party to manage our pension paperwork. In 2021, one of our two remaining active participants wanted to pull her money out. At that time, I contacted our vendor to let them know that if we sunk to one participant then Orion would just close out the program. The vendor resisted assisting us in closing our program. After months of back-and-forth, they refused to help us unless we paid a large fee for an unnecessary service. This was unacceptable at any time – especially during the financial hardships of the pandemic.

Left without a vendor and having several other challenges post-pandemic, the paperwork fell to the wayside until now. (Thank you for your email from February 3.)

As you will see on the forms we are submitting for 2021 and 2022, Orion has not had any transactions of note in recent years. All money has been distributed and our pension program is closed. Given the above, please waive any fees that arose out of this difficult time.
