Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Duncan Enterprises 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation available for benefits as of May 31, 2023 and 2022, and the related statement of changes in net assets in liquidation available for benefits for the year ended May 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Duncan Enterprises 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2023 and 2022, and for the year ended May 31, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Duncan Enterprises 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter – Plan Termination

As described in Note 1 to the financial statements, on May 1, 2022, the sponsor of Duncan Enterprises 401(k) Plan adopted a resolution to terminate Duncan Enterprises 401(k) Plan. The Plan completed its benefit distribution during the year ended May 31, 2023, and had no assets as of May 31, 2023. As a result, Duncan Enterprises 401(k) Plan has presented the financial statements on the liquidation basis of accounting. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Duncan Enterprises 401(k) Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of Duncan Enterprises 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was a 401(k) salary deferral plan covering substantially all employees of Duncan Enterprises, Inc., and Duncan Financial Corporation (collectively, the Company) and was subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Duncan Enterprises, Inc., was the Plan's sponsor and serves as Plan administrator.

Plan termination – The Company had the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA.

Effective December 30, 2021, the Company closed an asset purchase agreement between the Company and Paisley Crafts, LLC (Paisley). Per the terms of the asset purchase agreement between the Company and Paisley, existing employees of the Company were offered employment at Paisley upon closing, and those employees were also eligible to participate in the Paisley Crafts, LLC 401k Plan. Consequently, after closing, employee and employer contributions into the Plan ceased and new participant notes receivable from the Plan also ceased.

On May 1, 2022, the Plan sponsor adopted a resolution to terminate the Plan. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of years of vested service. The Plan completed its benefit distribution during the year ended May 31, 2023, and had no assets as of May 31, 2023.

Eligibility – Prior to December 30, 2021, employees of the Company were eligible to participate in the Plan upon reaching age 18 and after completing three months of employment with the Company. Eligible employees could elect to participate in the Plan on the first day of the month following their first date of eligibility.

Contributions

Participant contributions – Prior to December 30, 2021, participants could contribute between 1% and 100% of eligible pretax annual compensation, as defined in the Plan. Participants could elect to make Roth contributions utilizing after-tax contributions. Participants who attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant.

Employer contributions – Prior to December 30, 2021, the Company was under no obligation to contribute to the Plan in any given year. The Company could make discretionary matching contributions and profit sharing contributions to the Plan.

Contributions were subject to regulatory limitations.

Duncan Enterprises 401(k) Plan Notes to Financial Statements

Participant accounts – Prior to Plan termination, each participant’s account was credited with the participant’s contribution, any applicable Company contributions, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account. Participants directed the investment of their contributions into various investment options offered by the Plan.

Vesting – Prior to December 30, 2021, participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts was based on years of continuous service. Participants vested in the Company’s contributions based on the following schedule:

Notes receivable from participants – Prior to December 30, 2021, participants could borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were issued by the Plan and secured by the balance in the participant’s account. All loans were required to be repaid within a period of five years, unless the loan was used to purchase a principal residence, in which case, the loan could be repaid within a reasonable period of time not to exceed thirty years. Under the terms of the Plan Agreement, plan loans were required to bear a reasonable rate of interest determined by the Plan administrator. Principal and interest was paid ratably through payroll deductions. Upon Plan termination, any unpaid loans were distributed during the year ended May 31, 2023.

Payment of benefits – Prior to Plan termination, a participant, on termination of employment, could elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or installments over a period of years. The Plan allowed for the automatic distribution of participant vested account balances that did not exceed \$1,000.

Forfeitures – Prior to Plan termination, forfeitures were the nonvested portion of a participant’s account that was lost upon termination of employment. Upon Plan termination, participants became fully vested in their accounts. As of May 31, 2023 and 2022, the balance of forfeited nonvested accounts was \$0 and \$9,768, respectively. During the year ended May 31, 2023, \$9,083 of forfeited nonvested accounts originated prior to Plan termination were used to pay administrative expense.

Duncan Enterprises 401(k) Plan Notes to Financial Statements

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – In accordance with Plan termination (Note 1), the financial statements are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted (GAAP) in the United States of America.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments were reported at fair value. The Plan's trustee, Fidelity Management Trust Company (Fidelity), certified the fair market value of the investments. If available, quoted prices were used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Interest income was recorded on the accrual basis. The net depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants were measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants were reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan Agreement. No allowance for credit losses was recorded as of May 31, 2023 or 2022.

Payment of benefits – Benefits were recorded when paid.

Expenses – Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Several of the investment fund options were subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees were charged directly against the fund's investment performance; accordingly, they were not separately disclosed in the accompanying financial statements.

Subsequent events – The Plan has evaluated subsequent events through November 2, 2023, which is the date the financial statements were available to be issued.

Duncan Enterprises 401(k) Plan Notes to Financial Statements

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan were deemed to be actively traded. Mutual funds held by the Plan were open-end mutual funds that were registered with the U.S. Securities and Exchange Commission.

Collective/common trust: Units held in collective/common trusts (CCT) were valued using the NAV practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient was based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The Plan invested in a CCT that was valued daily and aimed to maintain a stable NAV. It permitted withdrawals to accommodate benefit payments on any business day, however, it required a 12-month advance written notice prior to redemption directed by the Company.

The Plan believed its valuation methods were appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan document was a volume submitter defined contribution plan that received its latest favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator believed that the Plan was designed and operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Information Certified by the Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets in liquidation available for benefits as of May 31, 2023 and 2022.
- Interest and dividends and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets in liquidation available for benefits for the year ended May 31, 2023.

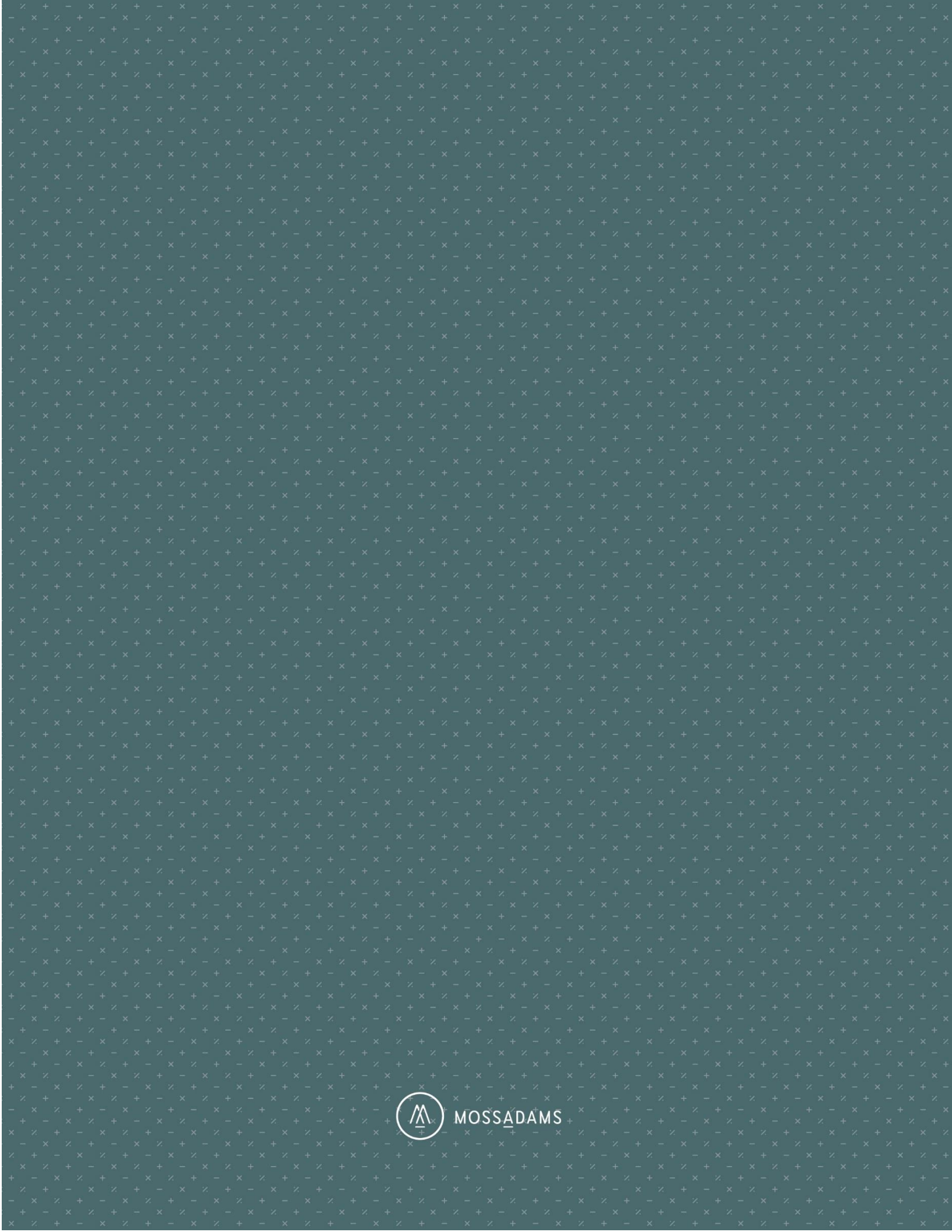
Note 6 – Party-In-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Certain Plan investments were managed by an affiliate of Fidelity. All purchases and sales of these funds were performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, were permitted under the provisions of the Plan and were specifically exempt from the prohibition on party-in-interest transactions under ERISA.
