**Note 1 – Description of Plan**

The following description of APL 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General* - The Plan is a defined contribution plan covering substantially all eligible employees of Academy for Precision Learning (the Organization) (the Sponsor). The Organization is the Plan's sponsor and serves as Plan Administrator. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

*Eligibility* - Employees of the Organization are eligible to participate in the Plan at their date of hire. Employees enter the Plan on scheduled enrollment dates which are the first day of the month after eligibility conditions are met. There is no minimum age or service requirement. The Plan excludes nonresident aliens, residents of Puerto Rico, part-time employees, temporary employees, and seasonal employees.

Participants must be employed on the last day of the Plan year and have completed 1,000 service hours during the Plan year to share in Organization allocations (see contributions note). Exceptions to employment on the last day of the Plan year are death, total and permanent disability, or termination of employment on or after normal retirement age.

*Contributions* – Participants may contribute up to the maximum annual federal dollar limit to pre-tax or Roth salary deferrals, as provided by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Organization, at its discretion, may contribute a match (flexible discretionary match) equal to 100 percent of the first 4 percent of eligible compensation that a participant contributes to the Plan and applied to all participants on a uniform basis. The Organization did not make matching contributions for the year ended December 31, 2022.

The Organization, at its discretion, may make nonelective profit sharing contributions to the Plan. There were no discretionary employer profit sharing contributions for the year ended December 31, 2022.

Contributions are subject to certain statutory limitations.

*Participant Accounts* - Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's discretionary contributions, if any, and, (b) Plan earnings or losses, and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

*Vesting* – Participants are immediately vested in their contributions, allocation of employer discretionary matching contributions, and qualified non-elective contributions, plus actual earnings thereon.

**Note 1 – Description of Plan (continued)**

*Loans* – Loans are not allowed.

*Benefit Payments* – Participants are eligible to receive 100 percent of their vested account balance upon attaining normal retirement age of 65 years, death, disability, or termination. The Plan requires that distributions to terminating and withdrawn participants must be made on a timely basis. If the vested amount of the participant's account balance does not exceed \$5,000, the account will automatically be distributed in the form of a lump-sum payment. Additionally, the Plan permits hardship distributions, as well as in-service distributions for participants who have reached age 59 ½. Benefits are paid under various options, as defined in the Plan.

*Investment Options* – Participants may elect to direct their account balance and any related earnings into investment options provided by the Plan. Investment options include various mutual funds and common collective trust funds.

*Forfeited Accounts* – Forfeitures may be used to pay Plan expenses and reduce Organization contributions. There were no forfeiture amounts at December 31, 2022 and 2021.

*Administrative Expenses* – Certain expenses of maintaining the Plan may be paid directly by the Organization and are excluded from these financial statements. Fees related to the administration of distributions from participants are charged directly to the participant's account and are included in administrative expenses. Certain expenses, including fees, were paid by Plan assets as disclosed in Note 8.

**Note 2 – Summary of Significant Accounting Policies**

*Basis of Accounting* - The financial statements of the Plan are prepared on the accrual basis of accounting.

*Investment Valuation and Income Recognition* - The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 4 for discussion of fair value measurements.

*Benefit Payments* - Benefits are recorded when paid.

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

*Subsequent Events* - In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 30, 2023, the date the financial statements were available to be issued.

***Note 3 – Information Prepared and Certified by Custodian***

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including the fair value of investments held at December 31, 2022 and 2021 and net depreciation in fair value of investments and interest and dividends for the year ended December 31, 2022 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan). The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

***Note 4 – Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2022 and 2021.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered Level 1 investments.

*Common Collective Trust funds:* The values of the Common Collective Trust funds are based on the NAV as a practical expedient calculated based on the fair value of the underlying assets owned by the funds, less their liabilities, and then divided by the number of units outstanding.

Purchases and sales of securities are recorded on a trade date basis, and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2021:

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100 percent vested in their employer contributions.

**Note 6 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7 – Plan Tax Status**

Originally effective December 1, 2013 and most recently restated as of October 30, 2023, the Plan adopted a Non-standardized Profit Sharing Plan with CODA. ADP, LLC, the sponsor of this prototype plan, obtained its latest IRS opinion letter on October 6, 2020, in which the IRS stated that the form of the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC).

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
