I apologize that our report was filed late. We closed the 401k account in 2022 and were told in March of this year that all things to do with this account were complete. We were notified mid August that this report was past due. I tried logging in to the old site which I no longer use anymore and there were no tasks available. Our website had been shut off due to the account being closed so there was no access to file the report. After some back and forth they determined they would send me the report to sign and submit via E-fast. I got the report signed (dated 8-29-23, I have the file and email date stamped) and tried filing on E-fast and the file type wasn't accepted and it wouldn't upload and I couldn't get it to be saved as the correct type to submit. I then reached back out to Principal and a few weeks later it was determined I would need to call and have them turn my website back on and try to file it through them. I later had the website turned back on but was unsure on the answers to some of the questions it was asking (different from what EFAST website had) so I had to get clarification on that to make sure the answers were right. I then went to file it and needed a DOL number and pin and had no idea where to find that. I called Principal and they gave me the number to DOL. I called them and they said they couldn't help and I would have to call a different number but that department has a high call volume so may take some time to get through and call back repeatedly. When I spoke to them they were able to help me get the PIN I needed and could finally file the report.
