Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Admiral Metals 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 22, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for period from January 1, 2022 through September 22, 2022 and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 22, 2022 and December 31, 2021, and for the period from January 1, 2022 through September 22, 2022 and for the year ended December 31, 2021, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

Emphasis of Matter

As discussed in Note 3 to the financial statements, the Reliance Steel & Aluminum Co. Benefits Committee elected to merge the Plan into the Reliance Steel & Aluminum Co. Master 401(k) Plan effective September 22, 2022. The transfer of assets was completed on September 22, 2022 at which time all participant balances in the Plan were transferred into the Reliance Steel & Aluminum Co. Master 401(k) Plan. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Admiral Metals 401(k) Plan (the Plan) of Admiral Metals Servicenter Co., Inc. and its affiliated companies (the Company) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

At the close of business on December 10, 2021, the Company was acquired by Reliance Steel & Aluminum Co. (Reliance). In connection with the acquisition, the Company became a participating employer in the Reliance Steel & Aluminum Co. Master 401(k) Plan (the Reliance Plan) effective February 1, 2022, freezing new contributions into the Plan after January 31, 2022. See Note 3 for further details surrounding the Plan's merger into the Reliance Plan.

The Company's Controller is the Plan's administrator (Plan Administrator).

The Plan is administered by a committee designated by the Plan Administrator. Empower Retirement, LLC (Empower) is the custodian and trustee and provides plan administration and record keeping services.

Eligibility requirements: The Plan allows for initial participation by any employee, excluding specific groups of employees, as defined in the Plan document, who has attained the age of 18 years and completed one month of service, as defined in the Plan document. Effective February 1, 2021, the Plan was amended to automatically enroll all eligible employees, excluding union employees, on their first eligible entrant date into the Plan at 3%.

To be eligible for the discretionary matching contribution, an employee must be eligible for contributing to the Plan and must have completed the service requirement of 1,000 hours of service during the plan year as described in the Plan document. To be eligible for the discretionary profit sharing or retirement contribution, an eligible employee (including non-actively participating eligible employees employed on the last day of the year) must have at least one year of active service and have completed at least 1,000 hours of service in the plan year for which the contribution is made and be employed on the last day of the plan year. Employees covered by a collective bargaining agreement are not eligible to receive the discretionary matching, profit sharing or retirement contributions.

Contributions: Each year, participating employees may contribute to the Plan up to 100% of their annual compensation, subject to Internal Revenue Code (IRC) limitations. Additionally, the Company may make a discretionary matching contribution. There was no discretionary matching contribution for the period from January 1, 2022 through September 22, 2022. For the year ended December 31, 2021, the discretionary matching contribution was \$0.50 for each \$1.00 contribution by the participant up to 4% of the participant's compensation.

For the period from January 1, 2022 through September 22, 2022 and for the year ended December 31, 2021, discretionary matching contributions totaled \$0 and \$227,647, respectively. The discretionary matching contribution for the fourth quarter of 2021 was remitted to the Plan during 2022, and as such the contribution, totaling \$58,650, was included in employer contributions receivable as of December 31, 2021, on the statements of net assets available for benefits.

Notes to Financial Statements

Note 1. Description of the Plan (Continued)

The Company may also contribute, at its discretion, a profit sharing contribution and a retirement contribution, both to be allocated among eligible participants at year-end in the same ratio as each participant's eligible compensation bears to the total compensation of all eligible participants. The Company did not make a profit sharing contribution to the Plan related to the period from January 1, 2022 through September 22, 2022. The Company made a profit sharing contribution to the Plan related to the 2021 plan year in 2022. At December 31, 2021, \$356,875 was included in profit sharing contributions receivable on the statements of net assets available for benefits. The Company did not make a retirement contribution to the Plan related to the period from January 1, 2022 through September 22, 2022 or the year ended December 31, 2021.

Participant accounts: Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer contributions, as well as the participant's share of the Plan's earnings and any related investment expenses. The allocations are based upon each participant's account balance in relation to all participant account balances within each investment fund.

Rollovers: With the approval of the Company, the Plan may receive any amounts received by an employee as a distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified status of the Plan. Participants are fully vested in these amounts.

Vesting and forfeitures: Participants are immediately vested in their voluntary contributions, rollover contributions and employer discretionary matching contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 25% vested after two years, 50% vested after three years, 75% vested after four years and 100% vested after five years of credited service.

Unallocated forfeitures are used to reduce future employer contributions or to pay administrative expenses. Forfeitures generated during the period from January 1, 2022 through September 22, 2022 and for the year ended December 31, 2021, were approximately \$609 and \$5,400, respectively. Forfeitures used to reduce employer contributions or pay administrative expenses during the period from January 1, 2022 through September 22, 2022 and for the year ended December 31, 2021, were approximately \$609 and \$19,300, respectively. Unallocated forfeitures as of September 22, 2022 and December 31, 2021, were \$0.

Investment elections: Each participant shall direct the investment of their account. Each participant shall elect among various mutual funds and a money market fund.

Notes receivable from participants: Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 (less the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balance. Loan repayment terms are a maximum of five years, unless used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate that is fixed at the origination of the loan at the then Prime Rate. Principal and interest are paid through payroll deductions.

Payment of benefits: A participant, or beneficiary in the case of death, may withdraw all or a portion of their account balance upon termination of employment, attaining normal retirement age of 55, death, qualifying hardship or permanent disability. Generally, a participant's vested account balance will be distributed in the form of a lump-sum payment. A participant may also elect to receive their vested account balance in the form of installment payments.

In accordance with Plan provisions, a participant may withdraw a portion of their vested balance to meet immediate and heavy financial needs, subject to certain limitations outlined in the Plan.

Administrative expenses: The Company pays all general administrative expenses of the Plan, except for the administrative costs associated with participant activity such as loan and distribution requests which are included in administrative expenses and investment-related expenses which are included in net (depreciation) appreciation in fair value of investments on the statements of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates: The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. The Plan presents in the statements of changes in net assets available for benefits the net (depreciation) appreciation in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Fair value measurements: The Plan follows the guidance in Financial Accounting Standards Board Accounting Standards Codification Topic 820—Fair Value Measurements and Disclosures (ASC 820), which defines fair value, and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2: Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Plan in determining fair value is greatest for instruments categorized in Level 3. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Note 2. Summary of Significant Accounting Policies (Continued)

Fair value is a market-based measure considered from the perspective of a market participant rather than an entity-specific measure. Therefore, even when market assumptions are not readily available, the Plan's own assumptions are set to reflect those that market participants would use in pricing the asset or liability at the measurement date. The Plan uses prices and inputs that are current as of the measurement date, including during periods of market dislocation. In periods of market dislocation, the observability of prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2, or Level 2 to Level 3.

ASC 820 also requires nonfinancial assets or nonfinancial liabilities to be recorded or disclosed at fair value on a nonrecurring basis. As of September 22, 2022 and December 31, 2021, the Plan did not have any nonfinancial assets or liabilities which are required to be recorded or disclosed at fair value.

Valuation techniques: The valuation techniques used by the Plan for their investment classes at both September 22, 2022 and December 31, 2021, are described below.

Mutual funds: Mutual funds are valued at quoted prices in active markets. These securities are categorized as Level 1 as they are actively traded and no valuation adjustments have been applied.

Money market fund: The fair value of the money market fund is determined by valuing its securities at amortized cost. Under the amortized cost method, a security is valued by applying a constant yield to maturity of the difference between the principal amount due at maturity and the cost of the security. These securities are categorized in Level 2.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. As of September 22, 2022 and December 31, 2021, there was no allowance for notes receivable from participants.

Payment of benefits: Benefits are recorded when paid.

Income taxes: GAAP requires plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements.

Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state or local tax authorities for years before 2019.

Note 3. Plan Merger

In connection with the acquisition of the Company by Reliance, the Reliance Benefits Committee voted to merge the Plan into the Reliance Plan effective September 22, 2022. The transfer of assets was completed on September 22, 2022 at which time the participant balance of \$16,587,100 in the Plan were transferred to the Reliance Plan. Vesting schedules related to transferred balances were retained by the Reliance Plan.
