Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of PAS Global, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 25, 2022 (Date of Merger) and December 31, 2021, and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to January 25, 2022 (Date of Merger) and for the year ended December 31, 2021, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of PAS Global, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of January 25, 2022 and December 31, 2021 and for the period from January 1 to January 25, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note H to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of PAS Global, LLC 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

As discussed in Note A, effective January 25, 2022, the Plan was merged into the Hexagon Employee Retirement Savings Plan. Participants ceased participation in the Plan and their balances were transferred.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about PAS Global, LLC 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A - DESCRIPTION OF PLAN

The following description of PAS Global, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, formed January 1, 2005, covering all employees of PAS Global, LLC (the Company) meeting participation requirements described below. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Section 401(a) of the Internal Revenue Code. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator, with the assistance from professional advisors, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Frozen Plan

The Plan was amended, effective May 3, 2021, to freeze the PAS Global, LLC 401(k) Plan. This means no additional contributions can be made to the Plan and that participants are fully vested in all of their accounts in the Plan. The Plan was also amended to modify the vesting provisions for both the employer nonelective profit sharing contributions and employer matching contributions to indicate participants are one-hundred percent vested. All investments and residual earnings were transferred from the PAS Global, LLC 401(k) Plan into the Hexagon Employee Retirement Savings Plan at Vanguard on January 25, 2022.

Plan Merger

On December 14, 2021, the Plan Trustee of PAS Global, LLC 401(k) Plan approved the merger of this Plan into the Hexagon Employee Retirement Savings Plan (the HERSP Plan), effective January 25, 2022. As a result, all investments were transferred from the Plan into the HERSP Plan on that date.

Participation

An employee must have attained age twenty-one (21) in order to become eligible to make elective deferrals into the Plan. An employee must have completed a minimum of six (6) months of service to be eligible for employer matching and other employer contributions.

Contributions

For the plan year ended December 31, 2021, the Company elected not to make any profit sharing contributions.

Participant Accounts

Accounting records for individual participants are maintained by a third-party administrator. Each participant's account is credited with the participant's salary deferrals and rollover contributions and allocations of Company contributions and plan earnings and losses. Allocations are based on participant earnings or account balances, as defined. Effective November 1, 2018, the Plan was amended to accept rollovers of Roth elective deferrals from qualified plans as described in Code Sections 401(a) and 403(b).

Vesting

Participants are immediately and fully vested in their salary deferral contributions plus actual earnings thereon. All employer contributions are vested over a 5 year service. A year of service as determined for vesting purposes is 1,000 hours during a Plan year.

Notes Receivable from Participants

A participant with an account balance of \$1,000 or greater may borrow from his or her account an amount not to exceed the lesser of fifty percent (50%) of his or her account balance, or \$50,000. Loans must be repaid within five (5) years. The interest rate for all loans is equal to 1% above the prime rate. The loans are secured by the balance in the participant's account. Loan repayments are to be made ratably through payroll deductions.

Payment of Benefits

The Plan does not allow withdrawals of salary deferrals, Company contributions or earnings thereon by active employees of the Company, unless the employee has attained age 59 ½ or the employee requests and is approved a hardship withdrawal. On termination of service due to attaining normal retirement age, disability or death, a participant or his or her beneficiary may elect to receive an amount equal to the value of his or her account balance as a single lump-sum. An employee who terminates employment before reaching normal retirement age may elect to receive a distribution of his or her vested account balance in a single lump sum.

Forfeitures

If a participant terminates employment before being fully vested, the non-vested portion of the terminated participant's account balance remains in the Plan as a forfeiture. Forfeitures attributable to amounts other than employer matching contributions will be allocated to participants in the same proportion that each participant's compensation for the plan year bears to the compensation of all participants. Forfeitures of employer matching contributions are allocated to all participants eligible to share in the matching allocations in proportion to each participant's compensation for the year. At January 25, 2022 and December 31, 2021, forfeited non-vested accounts totaled \$21,693. These accounts will be used to reduce future employer contributions. Also, in 2021, employer contributions were reduced by \$31,124 from forfeited non-vested accounts.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Date of Management's Review of Subsequent Events

The Plan has evaluated subsequent events through November 8, 2023, the date the financial statements were available to be issued.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Administrative expenses including custodian fees are paid directly by the Plan. Expenses incurred to audit the Plan are paid by the Plan Sponsor.

Notes Receivable from Participants

Loans to Plan participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. All Plan assets were transferred to the Savings Plan before close of business on January 25, 2022. As of December 31, 2021, no allowance for credit losses was recorded. If a participant does not make a loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Up to January 25, 2022 and December 31, 2021, the Plan's investments were held and maintained by Voya Retirement Insurance and Annuity Company, which is regulated, supervised and subject to periodic examination by Federal agencies. The Plan's Investments are valued at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the custodian of the Plan. See NOTE C for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed are recorded as a liability with a corresponding reduction of contributions. The Plan distributed the 2021 excess contributions to the applicable participant prior to January 25, 2022.

NOTE C - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits, except for fully benefit-responsive investment contract, which is reported at contract value. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The Plan's investments are stated at fair value. All Plan assets were transferred to the Savings Plan before close of business on January 25, 2022.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There are no plan assets requiring the use of Level 2 and 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies at December 31, 2021.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

NOTE D - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

In 2014, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issue or otherwise. The contract value of the investment contract at January 25, 2022 immediately before transfer and December 31, 2021, was \$2,137,136 and \$2,241,737, respectively. The crediting interest is based on a formula agreed upon with the issuer, but may not be less than minimum guaranteed interest rate of 1%. The crediting rate is reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Voya. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to plan's prohibition on competing investments options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (e) premature termination of the contract. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at a contract value with Plan participants or the issuer, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE E - TAX STATUS

The Internal Revenue Service has determined and informed the prototype plan by letter dated September 1, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G – UNAUDITED INFORMATION CERTIFIED BY CUSTODIAN
