# OpEx Solutions, Inc.

To Whom it May Concern:

OpEx Solutions, Inc. (OSI) was not able to submit Form 5500 in a timely manner because of a series of unplanned events as shown below. OSI is a small business and the officers and the officer's family members themselves work on the submission.

- Initially, the submission was delayed due to unplanned issues with a contract at the Army National Guard.
- When OSI was ready to submit in July, unfortunately the OSI President's brother suddenly died in his sleep at a young age leaving behind a non-working wife and two young sons, one of them with special-needs condition. The President was the only family member in the same town and had to support with coordination of funeral, other associated activities, and assisting the family with immediate needs.
- Even before completing the President's brother's funeral and important-urgent support items, the President's 95-year-old father-in-law was declared to be in his last days and had to go to India for three weeks in September. Upon return, with jetlag/illness and other issues with my brother's death, we were not able to submit the Form 5500 on time.

I would appreciate it if you could consider and accept the above situation as a reasonable cause and waive any penalties.
