Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Vitac Corporation Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statements of changes in net assets available for benefits for the year ended December 31, 2022 and the period ended December 31, 2021, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information and to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that were identified during the audit.

1. PLAN DESCRIPTION

The following description of the Vitac Corporation Retirement Savings Plan (the “Plan”) provides only general information. Participants and other interested parties should refer to the Plan document for a more complete description of the Plan’s provisions.

General - The Plan was established on September 3, 2021, and is a defined contribution plan covering eligible employees who have been employed by Vitac Corporation (the “Company” and the “Plan Sponsor”) and have attained 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective May 11, 2021, Vitac Corporation was sold to Verbit, Inc. and removed as a participating employer of The Gores Group, LLC – 401(k) Plan (the “Gores Plan”). As a result of the sale, assets of \$21,449,027 were transferred to the Plan from the Gores Plan during September and October 2021.

Contributions - Each year, participants may contribute pre-tax and Roth deferrals up to 100 percent of annual compensation, as defined in the Plan and subject to certain limitations under the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans, as defined. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides for safe harbor matching contributions equal to 100 percent of the first three percent deferred by a participant and 50 percent of any additional deferral up to five percent of compensation. The Company made safe harbor matching contributions of \$968,922 and \$336,887 for the year ended December 31, 2022 and the period ended December 31, 2021, respectively. The Plan also provides for discretionary Company matching and nonelective contributions of which none were made for the year ended December 31, 2022 or the period ended December 31, 2021.

Participant Accounts - Each participant’s account is credited with the participant’s contributions, Company safe harbor matching contributions and discretionary Company matching contributions, if any, as well as allocations of the discretionary Company nonelective contributions, if any, and Plan earnings, and charged with any withdrawals or distributions requested by the participant, investment losses, and allocation of administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are vested immediately in all contributions, plus actual earnings thereon.

Payment of Benefits - On termination of service for any reason, a participant or their beneficiaries, as applicable, may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or partial payments, in accordance with the Plan. Installment payments are allowed for required minimum distributions. The Plan provides for a mandatory cash-out following severance of employment for account balances less than \$5,000.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments are valued daily. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021.

Administrative Expenses - Certain administrative expenses incidental to the administration of the Plan may be paid by the Plan, unless otherwise paid by the Company. Administrative expenses paid by the Company are excluded from these financial statements.

Most investment options have fees which reduce the overall return on assets. The net depreciation of investments is inclusive of these fees.

According to the Plan Expense Account Agreement between the Company and Empower Trust Company, Empower Trust Company is required to make a monthly contribution to the Plan Expense Account ("PEA") in an amount equal to 0.000125 percent of the Plan's assets (0.0015 percent annually). The funds in the PEA may be used to pay Plan administrative expenses during the year and any remaining balance at the end of the year may be allocated to participants as earnings or contributions. The net depreciation of investments is reflected net of these contributions. During the year ended December 31, 2022, Empower Trust Company contributed \$29,981 to the PEA and \$29,732 was used to pay Plan administrative expenses. During the period ended December 31, 2021, Empower Trust Company contributed \$7,229 to the PEA, of which no funds were utilized to pay Plan administrative expenses. As of December 31, 2022 and 2021, there was \$7,821 and \$7,251, respectively, available for use in the PEA.

Benefits Payable to Participants - Benefits are recorded when paid.

Subsequent Events - The Company has evaluated subsequent events through November 1, 2023, which is the date that the financial statements were available to be issued, and determined that there were no subsequent events or transactions that required recognition or disclosure in the financial statements, except as disclosed below.

Effective January 1, 2023, the Plan was amended to change the Plan Sponsor from Vitac Corporation to Verbit, Inc. and as a result the Plan name was changed to Verbit Group Retirement Savings Plan.

Effective April 13, 2023, the Plan was amended to allow the merger of the assets related to Verbit, Inc. from the TriNet 401(k) Plan.

3. FAIR VALUE

The Plan accounts for its financial instruments using a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value measurement hierarchy is based on three levels of inputs, of which the first two are considered observable and the last unobservable.

The three levels of the fair value hierarchy are the following:

- Level 1 – Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3 – Inputs to the valuation that are unobservable and significant to the fair value measurement.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds – This category consists of publicly traded funds of registered investment companies. The net asset value (“NAV”) of the mutual fund's shares is quoted on the exchange where the fund is actively traded and therefore classified as Level 1 within the valuation hierarchy.

Self-directed brokerage accounts – Accounts in the TD Ameritrade SDB Account primarily consist of common stocks that are valued at the closing price reported on the active market on which the individual securities are traded, mutual funds that are valued on the basis of readily determinable net asset value, and interest-bearing cash that is valued at par and therefore classified as Level 1 within the valuation hierarchy.

Collective investment trust – The Putnam Stable Value Fund is valued at the NAV of units of a collective investment trust (“CIT”). The NAV, as provided by the fund’s trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CIT does not have any unfunded commitments relating to its investments, or any significant restrictions on redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

4. FINANCIAL DATA CERTIFIED BY THE TRUSTEE

5. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 less the highest outstanding loan balance during the prior 12 months or 50 percent of their vested account balance. Loans are generally issued with a maturity of up to five years. The loan interest rate is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. PLAN TERMINATION

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participant accounts would be distributed in accordance with the Plan document.

8. TAX STATUS

Effective September 3, 2021, the Company adopted a non-standardized pre-approved profit sharing plan which is the subject of a favorable tax opinion letter from the IRS dated June 30, 2020. The Company routinely self-reviews the administration of the Plan and self-corrects any compliance issues in accordance with the Employee Plans Compliance Resolution System. The plan administrator believes the Plan is currently being operated in accordance with the applicable provisions of the IRC and, accordingly, the plan administrator believes that the Plan is exempt from income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee. Transactions with the Trustee, and its affiliates, qualify as party in interest transactions for which exemptions exist. For the year ended December 31, 2022, the Trustee and its affiliates received \$11,625 for loan administration and transaction fees, all of which was paid by participants through the Plan and the Trustee also received indirect compensation from investments based on a formula. In addition, the Plan's investment advisors were paid direct compensation of \$29,732, all of which was paid from the PEA. For the period ended December 31, 2021, the Trustee and its affiliates received \$2,653 for loan administration and transaction fees, all of which was paid by participants through the Plan and the Trustee also received indirect compensation from investments based on a formula.

10. BONDING

Department of Labor ("DOL") rules and regulations require the Plan Sponsor to have bonding in the amount of 10 percent of the Plan's beginning net assets with a minimum of \$1,000. As of December 31, 2022 and 2021, there was no bond in place and, therefore, the Plan was not in compliance with DOL rules and regulations.
