Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Avascent Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statement of Net Assets Available for Benefits as of September 13, 2023 (in Liquidation), and the related Statement of Changes in Net Assets Available for Benefits for the period January 1, 2023 to September 13, 2023 (in Liquidation), and the Statement of Net Assets Available for Benefits as of December 31, 2022 (Ongoing), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Avascent Group 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

We are required to be independent of The Avascent Group 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, on March 27, 2023 the Board of Directors of the Plan sponsor approved the termination of the Plan effective June 30, 2023, and management determined liquidation was imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements to the liquidation basis used in presenting the 2023 financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements



Notes to Financial Statements

- 1. Description of the Plan** The following description of The Avascent Group 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan covering substantially all employees of The Avascent Group, Ltd. (the "Company") who were at least 21 years old and had completed three months of service, except for leased employees, nonresident aliens, and interns working under 1,000 hours per year. Employees could enter the Plan on the first day of the month subsequent to satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

In November 2022, the Company was acquired by Oliver Wyman. In March 2023, the Board of Directors of the Plan sponsor elected to terminate the Plan effective June 30, 2023. All participants became fully vested in their accounts on that date. All Plan assets were fully distributed as of September 13, 2023.

Contributions: Each year, participants could contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions were also permitted. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified plans (rollovers). The Plan provided for automatic enrollment. Any newly eligible employee who had not affirmatively elected to contribute to the Plan or had not affirmatively declined to participate in the Plan would be automatically enrolled in the Plan with a three percent withholding of pretax annual compensation. The Plan allowed for discretionary matching contributions. During 2023, the Company contributed 100 percent of the first six percent of compensation that a participant contributed to the Plan. Profit sharing amounts could be contributed at the discretion of the Company. Participants had to be employed on the last day of the Plan year to receive an allocation of any discretionary profit sharing contribution. For the period January 1, 2023 to September 13, 2023, there were no such contributions. Contributions were subject to certain limitations.

Participant accounts: Each participant's account was credited with the participant's contributions, the Company's discretionary matching contributions, if any, as well as allocations of the Company's discretionary profit sharing contribution, if any, and Plan earnings. Participant accounts could also be charged with an allocation of certain administrative expenses. Investment earnings and losses were allocated based upon the investment performance of each investment in the participant's account. Allocation of the Company's discretionary profit sharing contributions, if any, were based on a grouping allocation method whereby each participant in the same employee group would receive the same allocation rate. Group 1 consisted of shareholders. Group 2 consisted of senior staff. Group 3 consisted of senior associates. Group 4 consisted of junior staff. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Notes receivable from participants: Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years or up to ten years for the purchase of a primary residence. The loans were secured by the balance in the participant's account and bore interest at prevailing interest rates at the time of issuance. Principal and interest were paid through payroll deductions.

Vesting: Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and profit sharing contributions was based on years of continuous service. For participants hired prior to March 1, 2020, a participant was 25 percent vested after one year of service was completed, and vests an additional 25 percent per year until full vesting after four years, in the Company matching contributions. For participants hired subsequent to March 1, 2020, a participant was 50 percent vested after two years of service was completed, and vests an additional 25 percent per year until full vesting after four years, in the Company matching contributions. For participants who terminated from the Plan on or before October 2, 2019, a participant was 20 percent vested after two years of service was completed, and vests an additional 20 percent per year until full vesting after six years of service, in the Company matching contributions. Vesting in the Company profit sharing contributions was 20 percent vested after two years of service was completed, and vests an additional 20 percent per year until full vesting after six years.

Effective June 30, 2023, upon Plan termination, all participants became fully vested.

Payment of benefits: Benefits were payable upon retirement at age 65, early retirement at age 55 with six years of service, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 were also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions were permitted at any time. Benefits were payable in lump sum payments.

Forfeited accounts: At September 13, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$14,545, respectively. These accounts were used to reduce Company contributions or to pay Plan expenses. During 2023, \$20,739 of forfeited nonvested accounts were used to reduce Company contributions and \$2,671 were used to pay Plan expenses.

Administrative expenses: Certain expenses of maintaining the Plan were paid by the Company. Transaction expenses, such as loan and distribution administration fees, were charged directly to the participant's account and were included in administrative expenses. Recordkeeping and investment management fees were also charged to participants based on account balances.

2. Significant accounting policies

Basis of accounting: The financial statements of the Plan were prepared under the accrual method of accounting.

As a result of the Plan's termination (see Note 1) the Plan's financial statements as of September 13, 2023 and for the period January 1, 2023 to September 13, 2023 have been prepared on the liquidation basis of accounting. The financial statement as of December 31, 2022 was prepared on the going concern basis of accounting.

Investment valuation and income recognition: Investments were reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Delinquent loans were reclassified as distributions based upon the terms of the Plan document.

Payment of benefits: Benefits were recorded when paid.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events: The Plan has evaluated subsequent events for disclosure in these financial statements through November 10, 2023, which is the date the financial statements were available to be issued.

3. Certified information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at September 13, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the period January 1, 2023 to September 13, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair value measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 13, 2023 and December 31, 2022.

The fair value of the shares of mutual funds owned by the Plan is based on quoted net asset values on the last business day of the Plan year.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

Investments in the collective trust fund can be redeemed immediately at the current net asset value. There are no withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for this investment as of December 31, 2022.

5. Plan termination As described in Note 1, the Board of Directors of the Plan sponsor elected to terminate the Plan effective June 30, 2023. All assets were fully distributed as of September 13, 2023.

6. Tax status The Plan was a pre-approved plan of FMR, LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan was designed, and had been operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. **Party-in-interest transactions** Certain Plan investments were managed by affiliates of Fidelity Management Trust Company ("Fidelity"). Fidelity was the trustee and recordkeeper as defined by the Plan. During 2023, the Plan paid Fidelity and other service providers for recordkeeping and other services. These transactions qualify as exempt party-in-interest transactions.
