1. DESCRIPTION OF PLAN

The following description of the Marvin F. Poer and Company ("Company") Cash or Deferred Profit Sharing Plan and Trust ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan was liquidated on January 31, 2023 and the plan assets were transferred to Empower Retirement on February 1, 2023. Ryan, LLC merged the Plan into the Ryan, LLC retirement plan.

General

The Plan was a defined contribution plan covering all employees of the Company who were age nineteen or older, and were either full-time employees or had 1,000 hours of service or more in a year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants could contribute up to 50% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered twenty-two mutual funds and one common/collective trust as investment options for participants. The Company could, at the option of the Company's Board of Directors, make matching contributions. Additional profit sharing amounts may also be contributed at the option of the Company's Board of Directors. Contributions were subject to certain limitations.

Participant accounts

Each participant's account was credited with the participant's contributions, Company matching contributions and plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on account balances. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. Participants became 20% vested after two years of service and vested an additional 20% for each additional year of service. A participant was 100% vested after six years of credited service.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined by the plan administrator, is commensurate with local prevailing rates. Note terms ranged over a period not exceeding five years, except for notes to purchase a principal residence, which shall not exceed fifteen years. Principal and interest is paid ratably through monthly payroll deductions.

Payment of benefits

On termination of service, death, disability, or retirement, the participant may request distribution of the value of the vested interest in his or her account in the form of a lump sum distribution. In-service distributions and hardship distributions may be made subject to limitations as defined in the Plan. If a participant terminates employment and the participant's account balance did not exceed \$1,000 the Plan administrator could authorize the benefit payment without the participant's consent. If the participant's balance exceeded \$1,000 but did not exceed \$5,000 the Plan would establish an IRA on the participant's behalf with The Vanguard Group and transfer the participant's vested balance to the IRA.

Forfeited accounts

Participants separating from the Plan and receiving a distribution forfeited their non-vested portion of employer contributions at the plan year-end immediately following the date of payment of the vested portion of the account. Forfeitures were used to reduce administrative fees and matching contributions. Forfeitures available to reduce plan expenses at February 1, 2023 and December 31, 2022 were insignificant to the Plan, and amounts applied to reduce plan expenses during the periods then ended were also insignificant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of management's review

Subsequent events were evaluated through November 2, 2023, which is the date the financial statements were available to be issued.

Basis of presentation

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - continued

Investment valuation and income recognition

Investments are reported at fair value or contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, insurance company and valuation experts. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 1, 2023 and December 31, 2022.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including the carrying values for investments in registered investment companies and a common/collective trust and notes receivable from participants totaling \$-0- and \$31,424,424 as of February 1, 2023 and December 31, 2022, respectively, and net investment income of \$1,621,654 for 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan).

4. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS – continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at February 1, 2023 and December 31, 2022.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INVESTMENT IN MASTER TRUST

The Vanguard Retirement Savings Trust, carried at the contract value of \$-0- and \$3,820,260 at February 1, 2023 and December 31, 2022, respectively, was a common/collective trust which invests exclusively in the Vanguard Retirement Savings Master Trust (the “VRMST”.) The VRMST invests primarily in synthetic contracts backed by high-credit-quality fixed income investments and traditional investments issued by insurance companies and banks. Participant transactions (purchases and sales) may occur daily, with certain limitations on shifts into short-term bond funds or money market funds. Certain events or conditions outside the normal operation of the Plan, such as layoffs, plan amendments, sale of a division or participant withdrawals due the sponsor's insolvency could result in sale and payment of benefits at an amount less than carrying value.

Interest income from the Plan’s investment in the master trust was \$5,521 for 2023.

6. INVESTMENT IN LIFE INSURANCE

Certain participant's accounts include investments in life insurance products. The investments are carried at the net cash value of the policies. In 2023, the carrying value changed as follows:

7. INCOME TAX STATUS

The Plan has obtained a determination letter from the Internal Revenue Service dated June 30, 2020 stating that the Plan is a qualified plan under Section 401(a) of the Internal Revenue code. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions exempt from the prohibited transaction rules.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PLAN TERMINATION

The Plan was terminated and liquidated on January 31, 2023. Participants were 100% vested in their accounts. The plan assets were transferred to Empower Retirement on February 1, 2023. Ryan, LLC merged the Plan into the Ryan, LLC retirement plan.
