INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Springfield Electric Supply Company 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2023 and December 31, 2022 and the related statement of changes in net assets available for benefits for the period January 1, 2023 to June 30, 2023, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of June 30, 2023 and December 31, 2022 and the period January 1, 2023 to June 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. DESCRIPTION OF PLAN

The following description of the Springfield Electric Supply Company 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) profit sharing plan covering substantially all employees, except for residents of Puerto Rico, employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan, leased employees, nonresident aliens with no income from a U.S. source or co-ops and interns of Springfield Electric Supply Company (the Company) and its subsidiary, Ronk Electrical Industries, Inc., who have one month of service and are of age 21 or older. Employees are eligible for Company discretionary matching and profit-sharing contributions after one year of service, as defined by the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is administered by the Trustee Committee consisting of persons appointed by the Board of Directors of the Company. Charles Schwab Trust Bank, as Custodian for the Plan, accumulates and invests contributions as directed by the participants.

In 2023, the Plan was merged into the Sonepar USA 401(k) Plan (Sonepar Plan). The merger is reflected within the statement of changes in net asset available for benefits. Participants in the Plan became eligible for Sonepar Plan effective January 1, 2023. A majority of the Plan assets were transferred on January 3, 2023 with residual transfer through June 30, 2023.

The following provisions and footnotes were prepared prior to the Plan merger. All participant contributions, loans, benefit payments and income allocation were made under the Sonepar Plan in 2023.

Contributions

Contributions to participants' accounts are affected through voluntary withholdings from their compensation (elective deferrals). Eligible participants are automatically enrolled in the Plan at the first of the quarter following 30 days of employment, following delivery of the enrollment notice describing the default contribution rate and the default investment, unless they affirmatively elect to enroll at a self-selected rate and investment or affirmatively decline to participate. If automatically enrolled, a participant's deferral is set at 6% of eligible compensation and automatically increased by 1% annually up to 10% of eligible compensation or until changed by the participant. Annual contributions for each participant are subject to participation and discrimination standards of Internal Revenue Code (IRC). Participants who have reached an age of at least 50 years old by the end of the Plan year may elect to increase their elective deferrals as permitted under the IRC.

Rollover contributions from other qualified retirement plans or from conduit individual retirement accounts (IRAs) are accepted as permitted by the Plan.

1. DESCRIPTION OF PLAN – CONTINUED

Participant Accounts

Each participant's account is credited with the participant's contributions and charged with withdrawals, as applicable, and allocations of the Company's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments

Participants direct the investment of their account into various investment options offered by the Plan. The Plan currently offers numerous mutual funds and common collective trust funds. The Company's Trustee Committee is responsible for oversight of the Plan and determines the appropriateness of the investment offerings and monitors investment performance.

Vesting

Participants are immediately vested in their contributions plus or minus any earnings or losses thereon. The Company's matching and discretionary contribution portion of participants' accounts, plus or minus any actual earnings or losses thereon, vests at 100% after three years of employment.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company reserves the right to elect to pay, or have the Plan pay administrative costs in the future. Fees related to participant-initiated recordkeeping services are charged directly to the participant's accounts and are included in administrative expenses.

Forfeitures

Forfeited accounts are to be used to reduce future employer contributions. As of June 30, 2023, and December 31, 2022, there were no forfeited balances.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installment or partial payments of at least \$1,000 per payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions which affect the reported amounts in the financial statements and the accompanying notes. Actual results could differ from those estimates.

Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Investments in common collective trusts are valued based on the NAV provided by the fund. The NAV is based on the fair value of the underlying investments held by the fund. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Payment of Benefits

Benefits are recorded as paid.

Plan Expenses

Expenses for maintaining the Plan are paid for by Plan participants and the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in the net depreciation of fair value of investments.

Management fees and other operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this standard are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2023 or December 31, 2022:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds (CCTs) – This investment is a public investment vehicle valued using the daily NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. There are no significant restrictions such as redemption terms, or holding periods, which would limit the ability of the Plan or the participants to transact at the NAV. Participant transactions may occur daily.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements, including investments held as of June 30, 2023 and December 31, 2022, and net depreciation in fair value of investments, and interest and dividends for the period January 1, 2023 to June 30, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian of the Plan.

5. INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Epic Advisors, Inc. The prototype received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Custodian of the Plan's assets and, therefore, these transactions qualify as party-in-interest transactions. The Plan also pays fees to the Plan's investment advisor as well as third party administrator. These transactions qualify as exempt party-in-interest transactions and are included within administrative expense for the period January 1, 2023 to June 30, 2023.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to participant accounts become 100% vested.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 30, 2023, which is the date the financial statements were available to be issued and have determined that there are no additional subsequent events that require disclosure under FASB ASC 855, *Subsequent Events*.
