## Independent Auditor's Report

To the 401(k) Committee  
Salient CRGT, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Salient CRGT, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of March 4, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits for the period of January 1, 2022 through March 4, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Notes to Financial Statements March 4, 2022

#### Note 1 - Description of the Plan

The following description of the Salient CRGT, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan generally covering all employees of Salient CRGT, Inc. (the "Company") who completed three months of service and are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The GovCIO 401(k) Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

On July 8, 2021, the Company was acquired by GovernmentCIO. By way of an amendment to the GovernmentCIO LLC 401(k) Profit Sharing Plan and Trust (the "GovernmentCIO 401(k) Plan") dated February 23, 2022, the Plan was merged with the GovernmentCIO 401(k) Plan, effective as of March 1, 2022. On March 4, 2022, the accounts of all Plan participants, totaling \$178,674,386, were transferred out of the Plan to the GovernmentCIO 401(k) Plan. The period of January 1, 2022 through March 4, 2022 is known as the "short period".

##### Contributions

Participants contribute up to 100% of pre-tax compensation as defined by the Plan. Participants also make Roth elective deferrals. Participants who attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes discretionary contributions to match the participants' pre-tax and Roth elective deferrals. During the short period, the Company made discretionary contributions of \$249,866. The Company can choose to make a nonelective contribution to those employees employed on the last day of the Plan year and who have completed a year of service during the Plan year. Due to the Plan merger, no participants were eligible to receive a nonelective contribution. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

##### Participant accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's nonelective discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants hired prior to January 1, 2011 are 100% vested after three years of credited service. Participants hired on or following January 1, 2011 are 100% vested over three years on a graded basis. Participants with less than three years of credited service are fully vested in discretionary employer contributions upon death, permanent disability or retirement.

### **Notes to Financial Statements March 4, 2022**

#### **Notes receivable from participants**

Participants can borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at a fixed rate determined by the Plan, as defined. Principal and interest is paid ratably through bi-weekly payroll deductions.

#### **Payment of benefits**

On termination of service due to death, disability or retirement, a participant can elect to receive either a lump-sum amount, annual or more frequent installments, an annuity, or partial distributions equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant can receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Forfeited accounts**

As of March 4, 2022 and December 31, 2021, forfeited nonvested accounts totaled \$0 and \$29,530, respectively. These accounts were used to reduce employer contributions or offset administrative expenses. During the short period, employer contributions were reduced by \$65,803 and plan expenses were offset by \$202 from forfeited nonvested accounts.

### **Note 2 - Summary of significant accounting policies**

#### **Basis of accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The GovCIO 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by investment advisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the short period.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of March 4, 2022 or December 31, 2021.

#### **Payments of benefits**

Benefits are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### Subsequent events

The Plan has evaluated subsequent events through November 9, 2023, the date the financial statements were available to be issued.

#### Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at March 4, 2022 and December 31, 2021:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

As of March 4, 2022, there were no investments measured at fair value that were held by the Plan. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2021. Classification within the fair value hierarchy table is based on the lowest level of input that is significant to the fair value measurement:

**Note 4 - Related party transactions and party-in-interest transactions**

Certain Plan investments are invested in funds managed by an affiliate of Transamerica and by State Street Bank & Trust. Transamerica is the third-party administrator and record-keeper of the Plan and State Street Bank & Trust is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Transamerica provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and Transamerica. Transamerica receives revenue from mutual fund and collective trust fund service providers for services Transamerica provided to the funds. This revenue is used to offset certain amounts owed to Transamerica for its administrative services to the Plan.

If the revenue received by Transamerica from such mutual fund or collective trust fund service providers exceeds the amount owed under the MSA, Transamerica remits the excess to the Plan's trust on a quarterly basis. Such amounts can be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During the short period and the year ended December 31, 2021, the Plan's Excess Budget Account ("EBA") was credited for \$15,625 and \$62,500, respectively. The balance in the Plan's EBA was \$0 at both March 4, 2022 and December 31, 2021.

#### **Note 5 - Plan merger**

As discussed in Note 1, the Plan was merged into the GovernmentCIO 401(k) Plan effective March 1, 2022.

#### **Note 6 - Tax status**

On March 31, 2014, the IRS stated that the prototype plan adopted by the Plan, as designed, qualifies under Internal Revenue Code ("IRC") Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is being operated, in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, including interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at March 4, 2022 and December 31, 2021, and investment loss and interest income on notes receivable from participants for the period ended March 4, 2022, that is disclosed in the accompanying financial statements was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by State Street Bank and the Trust Company, the trustee of the Plan.
