### 1. Description of Plan

The following description of the Legrand AV 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan was a defined contribution plan established effective January 1, 1998, as restated January 1, 2021. The Plan covered all employees of Legrand AV, Inc. (the Company) who had completed one month of service, excluding collectively bargained employees, non-resident aliens, as defined in the Plan, leased employees, temporary employees and former Middle Atlantic Products Employees and Former C2G employees. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan's named fiduciaries were the Company, as Plan Sponsor and Plan Administrator, and Vanguard Fiduciary Trust Company, as Trustee. The Investment Committee was responsible for oversight of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance and reported to the Plan Administrator.

The Plan merged into the Legrand North America 401(k) Plan, effective January 1, 2023, and all assets were transferred as of January 31, 2023.

#### *Contributions*

Each year, participants could have contributed up to 80% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also could have designated all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who had attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants also could have contributed amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributed a safe harbor contribution where employee deferrals of 1% resulted in an employer match of 2%, employee deferrals of 2% resulted in an employer match of 4%, employee deferrals of 3% resulted in an employer match of 5.5%, employee deferrals of 4% resulted in an employer match of 6%, employee deferrals of 5% resulted in an employer match of 6.5% and employee deferrals of 6% resulted in an employer match of 7%. Additional profit sharing amounts were contributed at the option of the Investment Committee. There were no profit sharing contributions for the period from January 1, 2023 to January 31, 2023, or for the year ended December 31, 2022. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### *Participant Accounts*

Each participant's account was credited with the participant's contributions, Company matching contributions, allocations of the Company's discretionary contributions and an allocation of the Plan's earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could have been provided from the participant's vested account.

### *Vesting*

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 20% vested after 2 years of credited service and continued to vest in increments of 20% until 100% vested after 6 years of credited service. A year of service was a consecutive twelve-month period in which the participant was credited with 1,000 hours of service.

### *Notes Receivable From Participants*

Participants could have borrowed from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at 1% above the prime rate, as defined. There were no loans outstanding as of January 31, 2023. Interest rates ranged from 4.25% to 7.25% and 4.25% to 6.50% as of December 31, 2022 and 2021, respectively. Principal and interest were paid ratably through bi-weekly payroll deductions. Terms ranged from one to five years or greater for the purchase of a primary residence.

### *Payment of Benefits*

Upon termination of service, for any reason, a participant with an account balance less than \$1,000 would have received a lump-sum amount equal to the value of his or her vested account. Participants with account balances that exceed \$1,000 could have elected to receive their vested amount in a lump-sum amount or as a series of installment payments. The Plan also allowed for hardship distributions and in-service distributions subject to certain restrictions.

### *Forfeited Accounts*

At January 31, 2023 and December 31, 2022 and 2021, forfeited nonvested accounts totaled \$0, \$103 and \$66,809, respectively. These accounts were used to reduce Company contributions or to pay plan administrative expenses. During the period from January 1, 2023 to January 31, 2023, no forfeitures were used to reduce Company contributions or plan administrative expenses. During 2022, Company contributions were reduced by \$128,754 and plan administrative expenses were reduced by \$3,250, from forfeited nonvested accounts, in accordance with plan provisions.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and Trustee, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments, and the Plan Administrator deems the participant's loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of both December 31, 2022 and 2021.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### *Subsequent Events*

Subsequent events were evaluated through November 2, 2023, the date the financial statements were available to be issued.

The Secure 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management is evaluating the impact of the adoption and implementation of this legislation on the Plan.

## **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 31, 2023, December 31, 2022 and 2021.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022 and 2021, noting the Plan held no investments as of January 31, 2023:

### 4. Concentrations

As of both January 31, 2023 and December 31, 2022, the Plan had no investment concentrations greater than 10% of the net assets available for benefits. As of December 31, 2021, the Plan had an investment of \$8,772,787 concentrated in one fund.

### 5. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by the Trustees, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

### 6. Tax Status

The Plan adopted a pre-approved plan offered by The Vanguard Group. The pre-approved plan received an IRS Opinion Letter dated May 28, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## 8. Administration of Plan Assets

The Plan's assets are administered under a contract with the Trustee of the Plan. The Trustee invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

## 9. Information Certified by Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2023, 2022, and 2021. Accordingly, the Trustee of the Plan has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of January 31, 2023, December 31, 2022 and 2021 and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2022, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the period from January 1, 2023 through January 31, 2023 and for the year ended December 31, 2022.

## 10. Delinquent Participant Contributions

For the year ended December 31, 2022, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$11,906, were corrected outside of the Department of Labor Voluntary Fiduciary Correction Program in January 2023. Additionally, the Company has compensated participants for lost earnings resulting from the delay in contributions.
