INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Sheet Metal Workers' Local No. 40
Supplemental Retirement Fund

Opinion

We have audited the financial statements of the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of January 31, 2023 and December 31, 2022 and the related statements of changes in net assets available for benefits for the one month period ended January 31, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund as of January 31, 2023 and December 31, 2022, and changes in its net assets available for benefits for the one month period ended January 31, 2023 and the year ended December 31, 2022, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Plan management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the fund, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2022 AND JANUARY 31, 2023

NOTE 1. PLAN MERGER

Effective January 31, 2023, the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund (the Plan) was merged into the Sheet Metal Workers' Local 17 Annuity Income Fund. Prior to the merger, the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund covered eligible participants as described under Note 2 – Description of Plan. The transferred net assets have been recognized in the accounts of the Sheet Metal Workers Local 17 Annuity Income Fund. The following assets were transferred as a result of the merger:

All rights and duties of the Trustees of the Plan were assumed by the Sheet Metal Workers Local 17 Annuity Income Fund, except any rights and duties necessary to affect the transfer of all assets and liabilities to the Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund.

As of January 31, 2023, Plan participants were subjected to the rules of the Sheet metal Workers Local 17 Annuity Income Fund.

NOTE 2. DESCRIPTION OF FUND

The Sheet Metal Workers' Local No. 40 Annuity Fund (Plan) was formed on July 1, 1982 under an agreement and declaration of trust between The Associated Sheet Metal and Roofing Contractors of Connecticut, Incorporated and the Sheet Metal Workers' Local Union No. 40. Effective October 1, 1996, the Trustees amended the agreement and declaration of Trust and the Plan to change the Plan's name to "Sheet Metal Workers' Local No. 40 Supplemental Retirement Fund." The purpose of the Plan is to supplement the benefits of the Sheet Metal Workers' Local No. 40 Pension Plan for sheet metal workers engaged in the jurisdiction of Local No. 40. The Plan is administered by a Board of Trustees, consisting of representatives of the employers and the Union. It is a "defined contribution plan", converted from the money purchase pension type to the profit-sharing type as of January 1, 1994. It allows for voluntary, non-deductible, contributions of up to ten percent of a participant's annual sheet metal worker compensation and accepts rollover contributions from other qualified plans.

NOTE 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Contributions - The Plan is funded by contributions made by employers at a fixed rate for each hour worked in covered employment and as determined in accordance with the collective bargaining agreement in effect. The contribution rates were as follows:

July 1, 2021 through June 30, 2022	\$	7.00
July 1, 2022 through January 31, 2023	\$	7.75

Employer contributions are accounted for as exchange transactions.

Participant Accounts - Each participant's account is credited with employer contributions and adjusted by net earnings or losses and administration fees, as defined by the Plan. The net earnings, or losses, and administration fees are allocated to participants using a non-discriminatory procedure, as outlined in the Plan. Participants can change their contribution allocation and investment options daily.

Plan Benefits - Participants and their eligible beneficiaries are entitled to their vested benefits upon retirement, termination, disability, or death. The method of payment may be a lump sum distribution, installments, a life annuity, a joint and survivor annuity, or a combination of a lump sum and one of the other options, subject to certain restrictions outlined in the Plan. A participant may receive a hardship withdrawal from amounts added to his account after 1993, subject to certain restrictions outlined in the Plan. A participant may receive an in-service withdrawal from his account, subject to certain restrictions outlined in the Plan.

Vesting - Each participant is 100% vested in the value of the amounts allocated to their account, subject to adjustments for net earnings or losses and administration fees.

Investment Valuation and Income Recognition - The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies utilizing information provided by investment advisers and the custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

See Note 7 for discussion of fair value measurements.

Employer Contributions Receivable - The Plan considers employer contributions receivable to be fully collectible; accordingly, no allowance for doubtful accounts is required.

Estimates - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires that management make estimates and assumptions that could affect certain reported amounts, and disclosures in the financial statements. Actual results could differ from those estimates.

NOTE 4. TAX STATUS

The Plan received its latest determination letter on November 6, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was exempt from federal income tax under Section 401(a) of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Fund management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. PLAN TERMINATION

The Trustees reserve the right to amend or terminate the Plan. Upon termination of the Plan or complete discontinuance of contributions, each participant or beneficiary will have non-forfeitable rights to his account after providing for all the expenses of the Plan at termination.

See Note 1 regarding Plan merger.

NOTE 6. PLAN ADMINISTRATION

The Plan has an administrator's service agreement with Zenith American Solutions, Inc. Zenith American Solutions, Inc. is responsible for the daily administration of the Plan, as well as the processing of all participant data and benefit payments. Fees paid to the administrator totaled \$5,807 and \$69,682 for the one month period ended January 31, 2023 and for the year ended December 31, 2022, respectively.

NOTE 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7. FAIR VALUE MEASUREMENTS (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the fair valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at January 31, 2023 and December 31, 2022. All investments were transferred to Sheet Metal Workers Local 17 Annuity Income Fund as of January 31, 2023.

Mutual funds - Mutual funds are valued at quoted market prices in an active market and are classified as Level 1 investments.

Common collective trust: The Vanguard Retirement Savings Trust, a stable value fund, held in a common collective trust fund, invests primarily in conventional and synthetic guaranteed investment contracts (GICs) issued by life insurance companies, banks and similar types of fixed-principal investments. The stable value fund allows for earnings stability regardless of the volatility of the financial markets and is recorded in the accompanying financial statements at fair value. The net asset value is used as a practical expedient to estimated fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

There were no investments held at January 31, 2023.

NOTE 8. EMPLOYER CONTRIBUTIONS

Employer Receivables - Employer receivables represent uncollected contributions for covered employment prior to the Plan's year-end.

These receivables are unsecured, except for any employer bonds (surety or cash) held in accordance with the Trust agreement and bonding policy.

The bonding policy provides that each employer must either: (1) Provide a surety bond naming the Plan, as well as other benefit funds and interested parties, in an amount based on the number of sheet metal workers employed; or (2) Place a cash deposit equal to one month's contributions based on a 40-hour work week for each sheet metal worker; or (3) Make contributions every two weeks, provided the employer has not been delinquent in remittances; or (4) Make contributions weekly. The bond account for employers providing a cash deposit is maintained by the Sheet Metal Workers' Local No. 40 Health Fund on behalf of the Plan and the other benefit funds and interested parties.

Significant Contributing Employers - Contributions from 7 employers represents 74% of employer contributions for the one month period ended January 2023.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through November 13, 2023, which is the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.


