Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the BDEP, Inc. 401 (k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 13, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through January 13, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. (1) Description of plan

The following description of the BDEP, Inc. 401 (k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2023, the Plan was closed to new participants and no additional contributions were allowed. The Plan's participants became eligible to participate in the SaveWise Pooled Employer Plan ("SaveWise Plan") as of January 1, 2023. The Plan was merged into the SaveWise Plan and all participant account balances and Plan assets were transferred effective January 13, 2023.

(a) General

The Plan was a defined contribution plan which was adopted to provide retirement benefits for employees of Business Development Equity Partners, Inc. ("BDEP"), (the "Plan Sponsor"). The Plan covered substantially all full-time employees who were age twenty-one or older and who had completed six months of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

(b) Contributions

Prior to January 1, 2023, participants were able to voluntarily make qualified pre-tax retirement contributions to the Plan which were deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations.

Through December 31, 2022, the Plan automatically enrolled all newly eligible employees at a deferral rate of 1%, unless the employee elected to not participate in the Plan or elected otherwise.

The Plan Sponsor provided a safe harbor matching contribution of 100% of the first 4% of compensation contributed by the employee. Plan Sponsor and participant contributions could not exceed the maximum deductible for federal income tax purposes.

(c) Participant accounts

Each participant's account was credited (charged) with the participant's and Plan Sponsor contributions and allocations of investment earnings (losses) and administrative expenses. Allocations were based on participant's compensation or account balances, or specific participant transactions, as defined in the plan agreement. Participants could change their investment options on a daily basis. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants were immediately vested in their contributions and safe harbor matching contributions plus actual earnings (losses) thereon.

(e) Participant notes receivable

Participant notes receivable were not permitted by the Plan document.

(f) Payment of benefits

On termination of service due to death, permanent disability, retirement, or other reasons a participant could elect to receive a lump-sum payment equal to his or her entire account.

(g) Hardship withdrawals

The Plan did not permit hardship withdrawals.

(h) Administrative expenses

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions are included in administrative expenses and are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

(2) Summary of significant accounting policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investments were stated at fair value, with the exception of the insurance contract, which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Payment of benefits

Benefits were recorded when paid.

(d) Use of estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between January 13, 2023 and November 13, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments disclosed in the accompanying financial statements, including the fair (or contract) value of investments held at January 13, 2023 and December 31, 2022, and net appreciation in fair value of investments for the period ended January 13, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Nationwide Trust Company, FSB ("Nationwide").

(4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan does not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2022.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022 or during 2023.

- (i) *Mutual funds*: Valued at the net asset value ("NAV") of units held by the Plan at year end based on quoted prices in an active market. The mutual funds are classified as Level 1 assets within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan held mutual funds totaling \$1,414,409 classified as level 1 investments as of December 31, 2022.

(5) Investment contract with insurance company

The Plan had entered into a traditional benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company. This contract met the fully benefit-responsive investment contract criteria and therefore was reported at contract value. Nationwide maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit Nationwide to terminate the agreement prior to the scheduled maturity date. The contract value of the investment contract was \$80,887 as of December 31, 2022.

(6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. Although the Plan has been amended since the opinion letter date, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 13, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

Certain Plan investments were shares of mutual funds and an insurance contract managed by Nationwide and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. As described in Note (1), the Plan paid expenses to various service providers which also qualify as party-in-interest transactions.
