Wenzel Associates Inc sponsored a 401k plan. As part of an acquisition, the Wenzel 401(K) plan was moved and combined with our parent company effective 1/1/2023. Wenzel employees are now part of the Quantic 401(K) Retirement Savings Plan (“Quantic 401(K) plan”)

In the course of the conversion, our Wenzel 401(K) plan rolled 10 days into 2023 and shows a final date of 1/10/2023. As a result of this short period, we have a duty to file a short period 5500.

We discovered that during this 10-day period, we had employees become eligible that changed the Wenzel 401(K) plan from “Small” to “Large”. While we had 9 new eligible employees effective 1/1/2023, none were allowed to contribute funds during the blackout period of the plan move (1/1/2023 to 1/10/2023).

Our plan was considered small in 2022 and all prior years. Effective 1/1/2023, Wenzel is part of the Quantic 401(K) plan that will be audited for the full year of 2023.

It is not our intention to have the Wenzel 401(K) plan audited on a stand-alone basis for the 10-day short period of 2023. Please accept the 5500 short period filing as submitted.
