1. Description of Plan

The following description of the Raging Bull LLC 401(k) Plan ("the plan") provides only general information. The plan sponsor is Raging Bull LLC. Participants should refer to the Summary Plan Description (SPD) for additional information.

General - The plan was established on and effective as of January 1, 2020. The plan is a qualified defined contribution plan covering all employees of the Company who have three consecutive months of service and are age eighteen years or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Ascensus Trust Company acts as record keeper and custodian of the plan.

Allocations - Assets of the plan are allocated to participant accounts based on specific contributions made by each participant and respective match made by the Company. Investment income (loss) is credited to each account based on appreciation (depreciation) of specific assets held in each participant's account and any earnings thereon.

Contribution - Each year, participants may contribute up to annual federally defined limits. Participants may make elective contributions of pretax compensation and Roth 401 (k) deferrals subject to the provisions of Internal Revenue Code Section 401 (k) and the provisions of the Plan. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Each year the Company will make an ADP safe harbour matching contribution of 100% of your deferral up to 4% of your compensation. The Plan allows the Company to make matching and profit-sharing contributions in the amount determined by the Company at its discretion.

Vesting - Participants are immediately vested in their contributions, safe harbour contributions plus actual earnings thereon. Vesting in any Employer's portion of the matching or profit-sharing contributions of the participant's accounts plus actual earnings thereon is 20% after two years of service increasing 20% each year until fully vested after six years. A participant is 100 percent vested in employer matching or profit-sharing contributions upon attainment of normal retirement age, death, total disability or after six years of service.

Disposition of Forfeitures - Forfeitures, if any, are used to pay plan expenses in the year they occur.

Benefit payments - If a participant's account is greater than \$5,000, even if they terminate service, they are not required to take a payment from the Plan until the required distribution rules apply. If their balance is \$5,000 or less, upon retirement, disability or death, a participant or beneficiary receives the entire amount credited to the participant's

account in either a lump sum distribution or at the participation's election, it will be rolled over into an IRA.

In service distributions and hardship distributions may also be available if the participant meets the requirements for such distributions as set out by the plan.

Participant accounts - The plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and plan gains and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account.

Investment options - Upon enrolment in the plan, participants direct the investment of their contributions and the Company contributions into various investment options offered by the plan. Participants may direct their contributions into one or more mutual funds or money market funds. If a participant does not select investments for their plan account, the plan administrator will determine how their account will be invested.

Notes receivable from participants - Loans to participants are not allowed under the plan.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Notes to the Financial Statements (cont'd)

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events – Subsequent events have been evaluated through March 31, 2023, which is the date the financial statements were available to be issued.

4. Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time. The termination of the Plan is subject to the provisions of ERISA.

5. Tax Status

The Plan as amended and restated as of April 01, 2022, is an individually designed plan. While the restated Plan document does not have a determination letter from the IRS, the Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has concluded that as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Transfer of Plan

During the year the Raging Bull LLC 401(K) Plan is transferred to TriNet Select 401(k) Plan Raging Bull LLC. As on date 8/29/2022 the transferred amount was \$ 764,576.
