### (1) Description of plan

The following description of the Titan Implement, LLC 401 (k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective January 1, 2023, the Plan was closed to new participants and no additional contributions were allowed. The Plan's participants became eligible to participate in the SaveWise Pooled Employer Plan ("SaveWise Plan") as of January 1, 2023. The Plan was merged into the SaveWise Plan and all participant account balances and Plan assets were transferred effective January 17, 2023.

#### (a) General

The Plan was a defined contribution plan which was adopted on January 1, 2020 to provide retirement benefits for employees of Titan Implement, LLC (the "Plan Sponsor"). The Plan covered substantially all full-time employees who were age eighteen or older and had completed six months of service ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan was amended in July 2021, to allow the participation of employees of Trailblazer Attachments, LLC, which was under common ownership.

#### (b) Contributions

Prior to January 1, 2023, participants were able to voluntarily make qualified retirement contributions to the Plan which could have been after-tax Roth deferrals or pre-tax deferrals deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC"). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. Participant contributions were permitted up to 100% of compensation subject to certain IRC limitations.

The Plan Sponsor provided a safe harbor matching contribution of 100% for the first 3% of compensation contributed by an employee and 50% of the next 2% of compensation contributed by the employee. Plan Sponsor and participant contributions could not exceed the maximum amount deductible for federal income tax purposes.

The Plan also provided that the Plan Sponsor could make a discretionary profit sharing contribution each year; however, the Plan Sponsor made no profit sharing contribution in 2023.

**(c) Participant accounts**

Each participant's account was credited (charged) with the participant's and Plan Sponsor safe harbor matching contributions, and allocations of Plan Sponsor profit sharing contributions, investment earnings (losses), administrative expenses. Allocations were based on participant's compensation or account balances as defined in the plan agreement. Participants could change their investment options on a daily basis. The benefit to which a participant was entitled is the benefit that can be provided from the participant's vested account.

**(d) Vesting**

Participants were immediately vested in their safe harbor matching contributions and their elective salary deferral plus actual earnings (losses) thereon. A participant was also 100% vested in discretionary profit sharing contributions after six years of credited service according to the following schedule:

Participants became fully vested due to death or disability.

**(e) Payment of benefits**

On termination of service due to death, permanent disability, or retirement, a participant could elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant was entitled to receive only the vested interest in his or her account as a lump-sum distribution.

**(f) Forfeited accounts**

Forfeitures were created when participants terminated employment prior to becoming fully vested in the Plan Sponsor discretionary profit sharing contribution portion of their accounts and actual earnings (losses) thereon. Such forfeitures reduced the Plan Sponsor's contributions to the Plan. There were no unutilized forfeitures as of December 31, 2022 or January 17, 2023.

**(g) Hardship withdrawals**

The Plan permitted distributions in the event of a hardship, as defined in the Plan agreement. These distributions were taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant was younger than age 59½. Hardship withdrawals were limited to the participant's elective and rollover account balances.

**(h) Administrative expenses**

Certain expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

**(2) Summary of significant accounting policies**

**(a) Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**(b) Investment valuation and income recognition**

Investments were stated at fair value, with the exception of the insurance contract, which was reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note (4) for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Payment of benefits**

Benefits were recorded when paid.

**(d) Use of estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(e) Events occurring after reporting date

The Plan Sponsor has evaluated events and transactions that occurred between January 17, 2023 and November 13, 2023, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

(3) Certified information

Certain information related to investments disclosed in the accompanying financial statements, including the fair (or contract) value of investments held at January 17, 2023 and December 31, 2022, and net appreciation in fair value of investments for the period ended January 17, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by American United Life Insurance Company.

(4) Fair value measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on the assumptions that market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, fair value accounting standards establish a fair value hierarchy that distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity including quoted market prices in active markets for identical assets (Level 1), or significant other observable inputs (Level 2) and the reporting entity's own assumptions about market participant assumptions (Level 3). The Plan did not have any fair value measurements using significant unobservable inputs (Level 3) as of December 31, 2022 or during 2023.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2022.

- (i) *Pooled separate accounts*: Valued at net asset value ("NAV"), which is based on the market value of the underlying investments held by the pooled separate account at year end. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the pooled separate accounts, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's pooled separate accounts were measured at NAV as a practical expedient as of December 31, 2022 to estimate fair value and therefore, were not classified in the fair value hierarchy.

The following table summarizes investments for which the fair value is measured using NAV as a practical expedient as of December 31, 2022. There were no participant redemption restrictions for these investments.

The Plan held various pooled separate accounts that were not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts were target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. Others were lifestyle funds which seek returns consistent with the stated investment style.

### (5) Investment contract with insurance company

The Plan had entered into a traditional benefit-responsive investment contract with American United Life Insurance Company. The guaranteed investment contract was considered fully benefit responsive. American United Life Insurance Company maintained the Plan's contributions in a general account which was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract was \$125,965 as of December 31, 2022.

(6) Income tax status

The Plan Sponsor adopted a non-standardized pre-approved profit sharing plan, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on June 1, 2021, which stated that the pre-approved profit sharing plan was designed in accordance with the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the plan administrator believes that the adopted plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of January 17, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) Related party and party-in-interest transactions

The Plan had an investment in an insurance contract managed by American United Life Insurance Company and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note (1), the Plan also paid expenses to various service providers which also qualify as party-in-interest transactions.
