We have performed audits of the accompanying financial statements of Banker Steel Co. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of January 10, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through January 10, 2023, and the related notes to the financial statements.

JANUARY 10, 2023 and December 31, 2022

Note 1—Description of the Plan

The following description of the Banker Steel Co. 401(k) Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution safe harbor plan covering substantially all employees of Banker Steel Co. L.L.C. and subsidiaries including Banker Steel South, LLC; Banker Steel NJ, LLC; NYC Constructors, LLC; Memco LLC; Innovative Engineering Solutions, LLC; and Lynchburg Freight & Specialty LLC (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 1, 2016, the Plan document was amended and restated to allow former non-union employees of NYC Constructors, Inc. and all employees of MRP, LLC to use the time employed by those organizations to meet the three month service requirement of the Plan. In addition, the safe harbor vesting schedule for all eligible employees was amended and restated to permit 100% immediate vesting of all Company contributions.

Plan Merger – The Company was acquired by DBM Global, Inc. on May 27, 2021. During 2022, the Company decided to merge the Plan into the DBM Global, Inc. 401(k) plan. As a result, all Plan assets were transferred from the Plan into the DBM Global, Inc. 401(k) Plan by January 10, 2023.

Administration – The Company is the Plan sponsor and Plan administrator. All assets of the Plan were held by Empower Trust Company, LLC (the “Trustee”). Certain administrative functions were performed by employees of the Company, who received no compensation from the Plan. The Company could reimburse the Plan for any administrative expenses incurred.

Eligibility – Employees are eligible to participate in the Plan on the first day of the Plan year quarter after the completion of three consecutive months of service.

Participant Contributions – Each year, prior to 2023, participants could contribute up to 100% of pretax annual compensation, as defined by the Plan, subject to maximum contribution limits established under the Internal Revenue Code (“IRC”). Participants who had attained age 50 before the end of the Plan year were eligible to make additional catch-up contributions within IRC limits. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Eligible compensation is defined as wages subject to federal income tax. For the employee’s first year of participation, compensation is recognized as of the first date the participant entered the Plan. Compensation was subject to limitation as prescribed by the Internal Revenue Service (“IRS”) regulations.

Employer Contributions – Prior to 2023, the Plan provided for a qualified safe harbor matching provision. The Company could also make a discretionary contribution in an amount determined annually by the Company. There were no contributions during 2023.

Participant Accounts – Each participant’s account was credited with the participant’s contributions and Company matching contributions, as well as allocations of the Company’s discretionary contribution, if any. Participant accounts were charged with withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant’s vested account. Participant accounts were segregated for purposes of determining the earnings or losses on each participant’s choice of investments.

Note 1—Description of the Plan (continued)

Vesting – A participant normally became eligible for benefits after reaching age 65 or meeting the vesting requirements. Each participant was immediately 100% vested in his or her salary reductions, rollover contributions, and Company matching and discretionary contributions.

Investment Options – Participants directed the investment of their contributions into various investment options offered by the Plan. Participants could change their investment elections at any time.

Notes Receivable from Participants – Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest were paid ratably through monthly payroll deductions. At January 10, 2023, there were no outstanding loans.

Payment of Benefits – Distribution of the vested portion of a participant's account could occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant was entitled to receive a lump-sum payment or installment payments in an amount equal to the vested value of his or her account, or ad-hoc distributions. At January 10, 2023 and December 31, 2022, there were no benefit payments that had been requested but not yet paid.

Forfeitures – As of January 10, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0- and \$18,763, respectively. Per the Plan Document, these amounts could be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During 2023, \$18,763 of forfeited nonvested accounts were transferred upon merger.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could vary from the estimates that were used.

Investment Valuation and Income Recognition – Investments in the Plan were reported at fair value. U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities were recorded on a trade-date basis. Dividends were recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants – Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees were charged directly to the borrowing participant's account and were included in administrative expenses when incurred. As of January 10, 2023 and December 31, 2022, no allowance for credit losses has been recorded. If a participant did not make loan repayments and the Plan administrator considered the participant loan to be in default, the loan balance was reduced, and the delinquent participant note receivable was recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits – Benefit paid to participants were recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan were paid by the Company and were, therefore, excluded from these financial statements. Investment related expenses were included in net appreciation in fair value of investments. Fees for the administration of notes receivable from participants were included in administrative expenses and charged directly to the participant's account.

Risks and Uncertainties – The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3—Information certified by the Trustee (unaudited)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC (the "qualified institution") has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of January 10, 2023 and December 31, 2022.
- Net appreciation in fair value of investments and interest and dividends as shown in the statement of changes in net assets available for benefits for the period from January 1, 2023 through January 10, 2023.

The Plan's independent auditor did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements.

Note 4—Fair value measurements

U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability in the principal or most advantageous market for the asset and liability, in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP defines three levels of inputs that may be used to measure fair value as follows:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodology used at January 10, 2023 or December 31, 2022. There were no transfers between levels during the period from January 1, 2023 through January 10, 2023. A description of the valuation methodologies used for assets measured at fair value is as follows:

Mutual Funds – These public investment vehicles are valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is classified within Level 1 of the valuation hierarchy based on the underlying assets of the account, which are traded on an active market.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan did not carry assets at January 10, 2023. The Plan’s financial instruments carried at fair value are classified by the following fair value hierarchy levels as of December 31, 2022:

Note 5—Party-in-interest transactions

Certain administrative expenses are paid to the investment advisor and record-keeper of the Plan. These transactions qualify as party-in-interest transactions. These administrative expenses amounted to \$2,846 for the period from January 1, 2023 through January 10, 2023, and are included in the statement of changes in net assets available for benefits. Notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants.

Note 6—Tax status

The Company adopted a prototype non-standardized profit sharing plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the IRC”. The Plan has not received a determination letter specific to the Plan itself, and the prototype plan has been amended since receiving the opinion letter. However, the Company believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan qualifies under IRC Section 401(a) and the related trust is tax-exempt as of January 10, 2023. The Company believes the Plan has no income subject to unrelated business income tax.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of January 10, 2023, and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a tax liability (or an asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7—Subsequent events

In accordance with U.S. GAAP related to subsequent events, the Plan has evaluated all events subsequent through November 15, 2023, the date these financial statements were available to be issued.
